For existing PMLA Property Owners you must make your individual Annual Golf Membership selection and return this signed and completed form, **with payment, to the PMLA Golf Shop** no later than **December 31, 2008**. If you sign up during 2009 you are still required to pay for all 12 months. Only new Property Owners will have their Annual Golf Membership prorated. *To Play 18 Holes in one day the Nine Hole member must pay the Property Owner Green Fee for the Back nine.

- To be eligible to purchase the annual golf membership you must be a member in good standing and named on the deed of trust pursuant to the Second Restated By-Laws, Article 3, Section 3.04. Limit two annual golf memberships per lot.
- Memberships are non-transferable. Requests for refunds for medical reasons will be determined on a case-by-case basis. All requests must be accompanied by a physician's statement containing the reason for the inability to play golf and the estimated length of time the individual will be unable to play. The refund will be determined based on the number of rounds played. Maximum refund will be 80% of annual membership fee.
- If you have a change of address or name, please notify the Administration office at once.
- On the monthly payment option, the remaining balance is due on the First of each month. Payments not received by the Thirtieth of the month will be subject to late charges and interest. If the payment is not made by the Thirtieth of the month the membership will be cancelled and the property owner will not be eligible for an annual membership for the remainder of 2009 or for the 2010 year.
- Collection of delinquent accounts will be in accordance with Resolution 07.03 – Collection Policy.

PINE MOUNTAIN LAKE GOLF ANNUAL CART RENTAL AGREEMENT

- Rental and use of a PML Golf Cart is at the Renter's risk. The Renter will hold Pine Mountain Lake Association and its employees harmless for any and all injuries or damage to any person(s) or property arising from the use of the Golf Cart.
- The Renter will use care and precaution necessary to prevent injury to the renter, to others, or damage to the Golf Cart.
- The Renter is responsible for all costs associated with damage to the Golf Cart or other PML property.
- The Renter and Driver of the Golf Cart must have a valid Drivers License. License # _____
- No one under age 18 may rent a cart. No one under 16 may drive a PML Golf Cart. Age 16 or older may drive a cart only with a valid drivers license.
- Only 2 persons and 2 bags per cart.

THE RENTER AGREES TO ABIDE BY ALL ESTABLISHED GOLF CART RULES.
Violations of this agreement will subject the renter to loss of privileges and/or fines.

By signing below, I represent that I am familiar with the operation of a PMLA golf cart and agree to return said cart at the end of play in as good condition as received. I agree to hold *Pine Mountain Lake Association* free and harmless from any damages or claims whatsoever arising from my use of said cart, and further agree to pay for all damages sustained while said cart is in my possession. I further represent that I am over 18 years of age. **This agreement shall be valid for all golf cart rentals in 2009 and shall expire December 31, 2009.**
