PML Election Record Dates for 2017

Deadline for returning nominating papers.

May 19, 2017 (Friday) (92 days before election)

(No less than 90 or more than 120 days before election)

Actual Election Record Date.

June 23, 2017 (Friday) (This date is 17 days prior to ballot mailing to allow for receipt of June assessment payment per Controller)

(No more than 60 days before the day on which the first written ballot is mailed or solicited)

Date for mailing ballots for Director Election.

July 10, 2017 (40 days before election) (Monday)

(No more than 45 or less than 20 days before election)

Date for Return of Ballots.

August 18, 2017 (Friday)

(By 4:30 pm the day before election)

Date of the Annual Meeting/Director Election.

August 19, 2017 (Saturday)

PG&E has cut your dead trees and you want them to remove the logs

Downed tree removal process

Call PG&E at 800-743-5000, press 4 for other, press 4 for other, say "tree trimming" as the reason for your call. Wait times can be long so be patient. They need to create a help ticket and they will give you a case # so you need to talk to a live person. PG&E will send ACRT to inspect your Lot to see if it qualifies for the downed tree removal program. Needs to be within 100' of a structure (the neighbor's house qualifies) or within 20' of the street.

If you qualify you will receive an authorization form from ACRT for your signature and return to ACRT.

P & J is the subcontractor who will evaluate your Lot and remove the logs. There could be circumstances where P & J cannot remove your logs due to location, ground condition or other extenuating circumstances but this should be the exception.
