Reminder: Golf Course Closed for Aeration

As a reminder the course will be closed for greens aeration on September 26th and 27th we look forward to seeing everyone back out on the course on the 28th.

Aeration involves perforating the soil with small holes to allow air, water and nutrients to penetrate the grass roots. This helps the roots grow deeply and produce a stronger, more vigorous lawn.

The main reason for aerating is to alleviate soil compaction. Compacted soils have too many solid particles in a certain volume or space, which prevents proper circulation of air, water and nutrients within the soil.

PML Special User Cards and Permanent Guests

Are Mom, Dad and the kids frequent visitors to your PML property? Do you have friends or extended family members that love to spend time with you here in PML? Are you tired of calling in passes for these frequent guests?

Two (2) Special User Access Cards may be purchased by the property owner. These gate cards can be issued to property owner's relatives, one generation up (parents), and one generation down (children) without the General Manager's signature. All other requests for a Special User Access Card must be applied for in writing and receive General Manager's approval.

If your guest does not meet the criteria for a Special User Access card, you have the option, as a property owner, to enter your party as a "permanent guest" in the GateAccess.net on-line program. A permanent guest must check in at the Main Gate each time they visit, but will be allowed entry to the Property Owner's address. This will save you from having to call your frequent guest in each time they visit.
