The speed limit is 25 mph because of safety. The roads are narrow, and there are no sidewalks within PML, so folks like to take walks along the side of the road.

Some visitors end up in the middle of the road and this presents a safety hazard. A speeding vehicle only exacerbates the problem. Deer versus vehicle accidents are a common occurrence and these can be reduced by simply slowing down. So please observe the speed limit and help keep PML safe.

Electric Golf Cart Building Project Makes Progress

The Electric Golf Cart building project remains on schedule. The siding and roof were completed in January. The concrete pad near the upper Restaurant parking lot was constructed and will allow for placement of the panel needed to bring additional electrical service to the building. Our contractor, Pluim Construction, and their crew worked around the inclement weather and continue to make good progress.

Our Golf Pro, David Rau is handling the new electric golf cart order. Part of the deal includes the trade-in of our used EZ-GO carts. If the trade-in value offered by EZ-GO is not acceptable, we

will offer the carts for sale to our members and then the general public. If we decide to offer carts for sale to our members, we will post notices so that everyone will get a chance. Either way, we will get the best price possible to help off-set the cost of the new carts.

Lake Dredging Project Started

The lake dredging project continues and, while some adjustments have been made to the work schedule, the project is proceeding at a timely pace. Our contractor, Cooper Crane and Rigging, completed the Fisherman's Cove area in mid-January and moved to the two areas in Unit 4.

Compliance Chatter by dennis pipal, compliance officer

In this month's article I want to bring to your attention a few sections from our CC&R's which you may or may not be familiar with. They all have one thing in common...they relate to the condition of your property and how others react to its condition.

Article VII, Section 2 – Owner Maintenance Responsibility – Each Owner shall be responsible for maintaining and keeping his Residence and Lot in good repair, including landscaping.

This sounds like a "duh" section of our governing documents. Most people would agree an Owner needs to keep the condition of his property acceptable and it kind of goes without saying. But this section usually comes into play when the condition of a property deteriorates to a point where it is obvious it needs attention. Many times absentee Owners don't see their property for long periods of time and we have to bring this condition to their attention.

Article VIII, Section 1 (c) – Use of Lots - ...All Lots and the Residences and other improvements erected or placed thereon (including, without limitation, landscaping) shall at all times be maintained in such a manner as to prevent their becoming unsightly.

This section almost sounds the same as the section we just finished but it relates to conditions that are not necessarily maintenance issues. An example would be Christmas tree lights in July which are falling off the eaves of a house. Another example would be house windows which are boarded up which makes the property look like it's in a slum area.

Article VIII, Section 10 – Storage

- Storage of personal property on any Lot shall be entirely within enclosed storage areas.

This seems to be everyone's pet peeve, that's of course unless you are the one who likes to store odds 'n ends up against the side of your house. For those of you who like to keep a lot of stuff which won't fit inside your house, this section requires you to keep this stuff in some kind of enclosed container, such as a storage building. But in lieu of that expense, a trip to the dump might solve your storage problem.

ECC Guidelines Section 3, F – Temporary Structures - No structure of a temporary character, i.e., trailer, mobile home, camper, tent, shack, garage or other out building shall be used on any Lot at any time as a residence, either temporarily or permanently. Softsided structures (carports, storage units, etc.) are not permitted.

The soft-sided structures which are used as garages for cars, boats etc. are not allowed. However, our ECC department can help you design a permanent structure for this purpose which will comply as an improvement on your property.

The complaints I receive from Owners, more often than not, fall into one of the above areas of our CC&R's. Choosing to be a nonconformist won't work when we live in a glass bowl such as a homeowner's association. Again, it's a matter of common courtesy towards our neighbors to maintain our properties in a manner consistent with the rules we agreed to follow when we chose to live in this wonderful glass bowl called Pine Mountain Lake.

Shades of Green

The rain, snow and cold temperatures of December have made the playing conditions extremely wet to say the least. As you can imagine, it was difficult to complete fall cleanup due to all the weather in and around the holidays. When carts are restricted, so is most of our equipment. As the course begins to dry we then can begin cleanup in some areas and other areas it could be months before it is dry enough to support equipment.

As of early January we have had around 80% of our normal average rain fall for the year ending June 1st 2011. Only Mother Nature knows what is in store for the rest of winter and spring but, if the wet weather continues, there will be many days of cart restrictions. There are many areas around the course that you can't leave the path to just turn around, let alone cross a fairway to get to a tee during Shot Gun season. Please be aware of your surroundings and stay on the paths. Find a wider area of a path to turn around or in some areas under trees where the turf can handle the load. Many areas, like to the left of the path at 10 green, are springs. #16 fairway, in the middle just across the cart crossing in the fairway, is a spring and will stay wet long after other areas have dried out. Both of these areas have French drains and are designed to drain to creeks leaving the course.

The Cart Barn project is proceeding nicely. We will be doing some improvements to the hillsides with an assortment of drought and deer resistant plants.

Frank Jablonski completed the divot mix "Birdhouse" container that we located at the restroom on #13, so now there is an additional place to grab a fresh container. Thank you, Frank, and to the Men's Club for supporting this project.

Let's hope we get a chance to dry out so you can all have a great February of golf.

Proposed PML Shooting Range & Policy BY JOE POWELL, GENERAL MANAGER

Years ago, PMLA operated a shooting range in Unit 16, up behind the Campgrounds. Over time, the range fell out of use. In the last few years members have expressed an interest in re-opening the range. Last year a PML Shooting Club was formed and a proposal was made to the PML Board to re-open the range. Prior to consideration, several key issues had to be resolved. Management was assigned the task of researching and providing information to address noise,

safety, cost, insurance and planning. This information was gathered and a noise test was conducted to determine the nuisance effect on members.

The next step in the process is to provide multiple opportunities for PML members to voice their opinion on the matter. At the January 15th Board meeting, the subject was placed on the agenda for discussion and a draft shooting range policies and procedures resolution was presented for review.

The following, draft Board resolution is being published for member review and comment. The subject of re-opening the PML Shooting Range will be discussed at the February 19, 2011 Board meeting. The meeting will be held at the PML Lake Lodge starting at 9 a.m. The draft resolution will also be discussed and considered at that time. The Board of Directors encourages interested members to attend the Board meeting and voice their opinion. Members that

WHEREAS, Article III, Section 6 of the CC&R's gives the Board of Directors the powers and duties necessary to conduct the affairs of the Association and to make such rules and policies as the Directors deem in the best interest of the Association; and WHEREAS, for the safety, welfare and consideration of all residents, the Board wishes to establish Shooting Range policies and procedures so that the PMLA Shooting Range is used and managed in a legal, safe, and effective manner; THEREFORE BE IT RESOLVED that the attached policies and procedures referred to as "Exhibit A" are adopted by the Board of Directors effective and that notice of their adoption shall be given to the membership within 15 days of today's date. EXHIBIT "A" PMLA Shooting Range Policies and Procedures DRAFT 1.15.11

PMLA Shooting Range

The PMLA Shooting Range is a pistol and smallbore rifle, practice range located in Unit 16 above the PMLA Campgrounds. The use of the Shooting Range is governed by the PMLA CC&R's and all subsequent rules and policies as adopted by the PMLA Board of Directors. The use of the PMLA Shooting Range is limited to PMLA members and guests in accordance with Association Policies and Procedures.

Operational Authority

The Association General Manager is authorized to manage, operate and delegate the daily operational tasks of the PMLA Shooting Range in accordance with Association policy and all applicable State and Federal laws

Certified Range Masters, made up of PMLA members in good standing and/or PMLA personnel, may be designated by the General Manager as authorized to operate the Shooting Range in a responsible, safe manner.

Range Masters

The Association may solicit volunteer assistance from the PMLA Shooting Club to provide members that have

Range Master certification as defined by the NRA or other sanctioned training agencies. A certified Range Master will be present at all times that the Shooting Range is in operation.

The Range Master will be responsible for the safe and compatible operation of the range as well as complying with all PMLA Shooting Range rules, policies and procedures. The onsite Range Master will have the right to expel any user that, in his/her opinion, is not acting responsibly or safely. The minimum age requirement to serve as a PMLA Shooting Range Master is 21 years of age.

Range Masters will have the final say on the weapons that can be used on the range. Their concern will be based on insuring all weapons are in a safe operating condition and that the report of the weapon is not inconsistent with the compatible use of the range.

Rule Violations

Should the General Manager or designated PMLA management be made aware of any violation of the established Shooting Range rules, policies and procedures, they may close the range and convene a meeting with the Shooting Club officers and/or onsite Range Master as applicable to review the rules violations. The Shooting Range will remain closed until the General Manager or designated PMLA management is satisfied that the approved rules are being applied properly. Multiple rules violations could result in the Shooting Range being

Range Schedule

The Shooting Range is scheduled to be open on Tuesday, Thursday, and Saturday, weather permitting, from 9:00 am to 5:00 pm as long as a PMLA approved Range Master is present. The range may be opened on other days for special events as authorized by the General Manager. The range schedule may be changed without notice.

Range Access

The gate to the Shooting Range can only be accessed by authorized PMLA staff upon the presence of an approved Range Master consistent with the range operating schedule. All users of the range shall register with PMLA before their first time use to insure they are PMLA property owners in good standing. Registration forms are available at the PMLA Administration Office or Main Gate, Department of Safety.

The range will be available to any PMLA resident in good standing in accordance with the current fee schedule. Those members using the range will be responsible for providing their own ammunition, paper targets and cleaning up after themselves when they are done. PMLA members that wish to use the range should call the Administration Office or Main Gate Department of Safety to determine if the range is open prior to driving to the range. Access to the range will be controlled by a locked gate. The road to the range may be closed due to weather and road conditions.

Range Use Fee

A fee to use the PMLA Shooting Range will be charged in accordance with the current fee schedule, as authorized by the PMLA Board of Directors.

Age Minimum

The minimum age to use the Shooting Range is 16 years, with a parent or legal guardian present at all times. Shooting Range user's ages 16 years to 20 years old must be accompanied by a parent or legal guardian at all times. The parent or guardian is responsible for the actions of the child or young adult while at the Shooting Range.

Authorized Weapons

PMLA strictly controls the types and calibers of weapons that may be fired at the Shooting Range. The following types and calibers of weapons are authorized to be used at the range:

Handguns; .22, 38, 357, 9mm, 40, 45acp. No magnum loads.

Rifle: .17, .22 only.

No other types or calibers of weapons will be allowed without the express approval of the General Manager or PMLA Board of Directors.

Alcohol Consumption

Alcohol is not allowed at the PMLA Shooting Range.

range? PML conducted a noise test that included multiple areas that could be impacted by the range. It was determined that the noise would be negligible and in most cases would have little or no impact on the overall membership.

What about safety issues?

The location of the range is designed for safety and all precautions would be followed in accordance with PML policies and procedures.

How much will the range cost? The initial cost estimate to build a small bore range to NRA standards is around \$24K. Other costs like road upgrades for access, grading and restroom facilities are being researched and considered. Costs to the Association may be reduced through the use of volunteer labor or a reduction in the scope of the construction.

Will there be a fee to use the range? This is still under discussion, but there will most likely be a nominal use fee if the range is approved.

Who will operate and run the range?

PMLA Money Matters

Several months ago, in September of 2010, we were just beginning the process of developing the Association's budget for 2011. Along with all of the many operational issues and costs that had to be addressed during this annual financial marathon, another concern raised its head and demanded attention.

As you are no doubt aware, we have two large and fairly expensive Reserve projects currently underway. The Lake Dredging project, as well as the Golf Cart Storage Facility (and associated electric carts) replacement, are both in full swing and are expected to be completed by the end of the first quarter of 2011. With the total cost of both projects combined totaling over \$2.5M the funding for these important undertakings was critical to their success.

After analyzing the status of our Reserve fund we concluded that the 2011 Assessment included sufficient funds to pay for these and all other scheduled Reserve based mainte-

Changes are being implemented at the PMLA Compost Piles and Slash Piles site operation. In preparation for the 2011 Fire Safety season, the site will be staffed, and the hours of operation will be regulated. A PMLA employee will be in attendance at the site during the hours of operation, and will be controlling the receiving of materials. The site will be open for use Wednesday through Sunday, conditions permitting. The hours of operation will be from 8AM to 4PM during the winter season of November through March, and 9AM to 5PM in the April through October season.

The Compost and Slash Piles site is for specific use; slash and compost materials dropped at the site are to be from Pine Mountain Lake properties only. PMLA property owners and/or their agents will be permitted to drop approved materials at the sites during operating hours only. Persons entering the site will be granted entrance, the drop loads checked, information recorded, and you will be directed to the drop area.

There are green signs at the en-

nance activities during the year. Our Reserve analysis was included in the budget package each of you received in December of last year. This analysis shows a minimal, but workable, funding level in our Reserves to handle unexpected costs to maintain the many assets of the Association.

However, budgeting for an expense over a 12 month period is somewhat different than paying for that same expense in a relatively short time frame such as a quarter. The real issue became one of cash flow and not necessarily the total cost of the jobs. Our challenge became one of increasing the volume of cash the Association received in the latter part of 2010 and the early stages of 2011.

As you know, the vast majority of our funding comes from assessment payments. Traditionally about 40% of you pay your assessment in full prior to the end of January. While this is a good number, it still leaves 60% of the assessment to be paid monthly. This makes for a more uniform cash flow throughout the year, but impacts our ability to address early year cash demands like the two projects mentioned above.

After discussing various methods to increase the early availability of cash in 2011 we came up with a somewhat unique solution. Included with each assessment package was an offer to all property owners. Pay your assessment in full for 2011 by December 31, 2010 and be entered into a drawing for a full refund of the assessment. Considering the current state of the economy we hoped to see a modest increase in payments received.

To say that I was surprised by the reaction to this program would be a huge understatement. In 2009 we had received 459 full year assessment payments by 12/31. While a 50% increase in this number would have marked a fairly successful effort, the response we received was far in excess of that figure. After all the counting was done we realized an increase of 165%! That means that instead of just 459 prepaid assessments, we have received an amazing 1,214 full year payments. This

remarkable return now allows us the flexibility to fund the Reserve in about half the time that it normally takes us. My thanks to all of you that took advantage of this opportunity and made my job a lot easier when it comes to paying for these two large jobs ,as well as all the other important projects we have scheduled for 2011.

By the time you read this the lucky winner will have been selected, so my congratulations to that individual. Again, thank you to all property owners who made the decision to pay their assessment in full prior to December 31. I look forward to another great and successful year here at PML.

PML Compost & Slash Piles

trances to the site that will display COMPOST OPEN or COMPOST CLOSED. The site is closed during bad weather conditions and when safety is an utmost concern. The Slash Pile site receives woody slash debris, brush, small trees, and tree limbs less than six inches in diameter. The Compost Pile is for leaves, pine needles, and composting materials.

The instructions as to which materials are not allowed to be dropped at this site, are displayed on large white signs. Strict adherence to these requirements will be enforced.

The Slash Pile and Compost Pile site is a PMLA operation which works in conjunction with our Fire Safety program. This site operation provides an area for property owners to bring their brush, tree trimmings, woody debris, leaves, and pine needles. These are materials that are cleared from PML properties for fire safety and improvement. There is no charge for PML members and the site is one of our many valuable services offered by your Association.

The principal form of fuel reduc-

tion of slash at this site is by burning. During the fire season the slash is reduced by grinding. Leaves and pine needles are composted. The site is not a community garbage dump, does not receive building materials, stumps, trees, or any other materials which cannot be properly reduced by burning, grinding, or composting.

Many future improvements are planned for this area and the placement of onsite staff is the first step in controlling and improving the operation.

COMMUNITY CORNER 22 **ARABIAN DAYS** of the Country Mountain Riders

Christmas often is marked by a child's anticipation of the day, but this Christmas five of our Country Mountain Riders were just as eager for the arrival of their "gifts". Horse trailers loaded with their new young equines were on the road to their new owners. One came earlier than the others by way of Texas, while all the others came direct from their former home, the Asgard Arabian farms in West Virginia. Five of the six babies were out of the stud, Bandjo De Falgas, a proven producer of race and endurance horses. Holly Foiles was the first lucky one to receive her new family member, Tres Amour (barn name Ami). Hers is the oldest (five years) of the four mares, two geldings in the group, with the others ranging from three to four years of age. Debra and Kevin Kalkowski had chosen two quiet youngsters, a mare, Mimyque (Mimy) and a gelding, Epatant (Rio), half owned by their friend Rick Mayer. Alexandra North bought two mares, Fyriga and Monnamie (Mona) and a gelding, Pantin, for her new mounts.

Armed with the DVDs of the Down Under clinician, Clinton Anderson, the riders are systematically introducing their new babies to all things on the ground that sets the foundation for a great horse. If any of you have followed the new teachings in horse training you are aware of the term "Natural Horsemanship". Studying horses in their herds led to a method of working with horses in the same way they relate to one another, a method without pain or fear, therefore growing the relationship/bond between the rider and his mount. You start on the ground and build this relationship prior to climbing in the saddle, with all ground work directly related to what happens later in the saddle. Tom Dorrance, his brother Bill, and Ray Hunt were all valley leaders in this foundation training and have had a following throughout the world for decades.

On a recent bright sunny day, the owners led all six of the babies into a round pen. Having just seen them for the first time, I was not able to tell who was who because they are all chestnut in color, but very soon, by observing them, it was easy to discern the pecking order prevalent in horse herds, whether that herd be just two horses or more; each new horse added can change the order. It was equally easy to know which ones were now barn mates as they circled the pen in their new "herds". And very soon, their individual

personalities began to show. At the Asgard Arabian Farms they were in their larger herd groups on 250 acres, having had few hours working with humans. They are essentially "clean slates", so the concern of their owners is that they introduce new things in a manner that leaves no holes and no scars from their teachings. Luckily for all, horses are incredibly forgiving of our mistakes.

Departing the round pen one could not help but smile at the eagerness of both horse and owner as the equine was being led over a stream complete with blackberry vines or varied stacks of tires, or a tarp, or standing next to a mailbox while it was being opened. These babies were quickly absorbing their new environment, eager to please and showing their new trust and confidence. They are all, to a one, fluid movers. All horses are wonderful to watch, but an Arabian has that special way of moving that appears to hardly touch the ground, as if they weigh nothing. Like Pit Bulls, they have, in some circles, received a bad reputation for being "knocker heads", "scaredecats", etc., but like all horses/ dogs it is not the breed but the breeding and handling that determines who they become. These six will be trained for endurance riding, which is bred into them with their strong legs, good feet, beefy hindquarters, quiet minds, and strong hearts. Through their training they will be able to attend parades, do trail trials, trail rides, etc., whatever their owner would like to do with them on any particular day. Alexandra is a wellknown endurance rider with great success on the trails. Hollie has been doing endurance and trail trials for a long time and Debra is the newest to the sports. Now Holly and Debra have horses that can take them a whole new level up in their sport. Rick had a fear of horses and through working with his new baby has developed a love and appreciation for



As part of the year-long celebration to commemorate Yosemite National Park's 120th birthday, the Yosemite Chamber of Commerce (Groveland, Calif.) today finished the installation of 14 street pole banners along Highway 120 through Groveland. With the help of Groveland Community Services District (GCSD), fourteen banners were mounted and hung along the Northern corridor toward Yosemite – the most accessible and scenic route to the park from the Bay Area.

The vertical banner, which measures 24" wide by 60" long, was designed by Silicon Valley graphic artist Patty Cimlov-Zahares. The design, which incorporates the headline "Celebrate Yosemite" with an illustration of Yosemite's Half Dome and Highway 120, does not include any dates so the banners can be perpetually hung along Highway 120 without fear of obsolescence. There also are several additional banners available for purchase by local merchants.

This project was spearheaded by the Highway 120 Celebrates Yosemite committee, a special committee of the Yosemite Chamber of Commerce. The committee, headed by Jeannie Tasker and assisted by Lynn Upthagrove and Dori Jones, was instrumental in planning a multitude of events to commemorate Yosemite's 120th birthday. According to Yosemite Chamber of Commerce President, James Nagle, "The banner project has been a yearlong endeavor – all aimed at highlighting Yosemite's milestone birthday and enhancing Groveland as a prominent entrance into Yosemite."

The year-long celebration was kicked off with an opening ceremony event in Groveland at the Hotel Charlotte and Dori's Tea Cottage on Oct. 3, 2010. There were nearly 70 people in attendance, including several park dignitaries and Tuolumne County supervisors. Other events scheduled during the year include "A Toast to Yosemite" signature wine dinner on March 6, 2011 at the Hotel Charlotte, which will feature wines from the Yosemite gateway regions. Closing ceremonies are scheduled for Oct. 2, 2011.

Foundation Giving Tops \$1.1 million


More than \$1.1 million in grants and scholarships were awarded to local students and nonprofits in 2010 through the Sonora Area Foundation and its supporting organization, the Irving J. Symons Foundation.

Foundation trustees awarded \$500,000 to more than 40 nonprofit groups through its competitive grants. Another \$507,000 was awarded through donoradvised funds, and \$109,000 was awarded in scholarships to 102 local students.

Competitive grants, awarded by Foundation trustees, went to support a wide variety of local projects and programs benefiting all areas of the community, with a special focus on "safety net" services to help local residents in need during the current economic downturn.

"Even in this beleaguered economy, the Sonora Area Foundation and its donors continue to step up to assist with the basic needs of the community," said Executive Director Greg Applegate. "It's amazing the way people continue to donate and serve the citizens of Tuolumne County."

Given the state of the local economy, Applegate said, the foundation's



"Food, clothing and shelter are still the top priorities," he said. "The breadth and depth of the economic downturn is still impacting so many people, the board will continue that philosophy and approach.

"I'm optimistic," he added. "I believe that in 2011, we have some really great opportunities to generate family wage jobs, which will have a positive impact on our local economy. But for now, meeting basis needs will be a high priority of the Sonora Area Foundation.

The Foundation ended the year awarding more than \$40,000 in grants and two special awards. Competitive grants went to the following groups:

• ATCAA Friday Night Live received \$11,973 award from the Irving J. Symons Foundation to support its work in youth leadership and suicide prevention at local high school and junior high campuses.

• Habitat for Humanity of Tuolumne County received a \$14,982 grant to help with its efforts to complete site improvements and begin construction of the first two homes at its Parrotts



Ferry Village property on Parrotts Ferry Road.

• Gold Rush Charter School received \$5,000 from the Irving J. Symons Foundation to help complete animal shelters, a chicken coop and hay barn to continue popular animal care and gardening projects at its new Country School campus, formerly Sullivan Creek School. • Sierra Nonprofit Services re-

ceived \$1,600 to support the Lifetime Achievement Award presentation and publicity for the county's annual volunteer awards luncheon.

• Dawn's Light, Center for Children and Adults in Grief, received a \$22,532 grant to help it with development plans, including contracting with a part-time development director to build community connections and financial support. The center provides counseling and other services for adults, teens and younger children, and also has a Yellow Ribbon Suicide Prevention Chapter with student-led clubs at two high school campuses.

Two other "community impact" awards were also presented in the fourth quarter:

• ATCAA Mentoring Works received \$10,000 as this year's recipient of the annual Elaine Symons Baker Community Impact Award from the Sonora Area Foundation. The youth mentoring program matches a trained volunteer with a vulnerable youth for one-to-one friendship and support.

• **Sonora High School** received \$9,256 for portable bleachers, as recipient of the 2010 Irving J. Symons Award. The bleachers will be used primarily to seat the school's Golden Regiment Band at the football stadium.

The project began with our "food barrel elf", Richard Abdelnour distributing the barrels on November 1st. It's a big job to collect and empty them weekly, but Richard does it graciously and with a smile each year.

More Than Just A Pretty Engine

I've been in the Cadet program for about half a year now. Throughout the course of the year I've heard the remark: "Oh, what do they teach you in Fire Science, how to wash the engine?" I found this very insulting and that is the reason for writing this paper. My hopes is that it will prove to people that Fire Science is more than just washing the engine.

First, I want to explain why the engine is required to be washed so frequently: to maintain our public image. When we are called to duty, no matter what the person(s) that we're being called to assist is going through, they're most likely having one of the worst days of their lives. If we pull up in a dirty, maltreated engine, not only does this not look good in the public's eye, but also the equipment on the engine may not operate to full capacity if not maintained every day, and that can result in loss of lives and property. So like I mentioned earlier, the reason for keeping the engine spotless is pride and maintenance of a very important piece of machinery. Think of it this way: If you can't take care of your engine, how are you supposed to take care of somebody else?

So now that I've cleared up the reason behind keeping the engine clean, I'm going to explain what we have to learn, and have learned during the course of the year so far. We have learned First Responder (FR) skills. When and how to use medical devices to assist in keeping somebody alive in most medical situations: this is called: Basic Life Support (BLS). We have learned human anatomy, and anatomical terms. We have learned the body systems, and what to do in medical

emergencies such as: a stroke (CVA), heart attack (MI), hypothermia etc... I, and five of the other cadets are certified in CPR. These are just a few of the things that we have learned, and there is much more knowledge to gain later in the year. In short, we've learned how not only save a life, but how to make a difference in one too.

The third thing that Fire Science has to give is: The teaching and utilization of the duty to act and honor. The duty to act is being there 24/7 to help protect, and assist the public in their time of need, and putting all others before you. Getting up in the early hours of the morning, or night to help someone in need of medical assistance. To help our community in not only the saving of lives, and the saving of houses, but in developing, and growing. Honor is serving your com-

munity unconditionally, and through any circumstances. Knowing the difference between right and wrong and doing everything within yourself to always do the right thing no matter the consequence. Possessing strength, ethical principles, respect, dignity and admiration. Honor is highly regarded in the fire service and is what exists in all the firefighters staffed at Groveland Fire Department. It is what is being gifted to us as Cadets so that we may follow in making a difference in not only our lives, but other lives as well.

In closing, the Fire Science program has many things to offer, much more than just learning to wash the engine. It's teaching us to make not only a difference in ourselves, but in the lives that we are bound to protect. And that is why Fire Science is more than just washing the engine.

COMMUNITY CORNER February 2011 Supervisor Article

JOHN GRAY SUPERVISOR 4TH DISTRICT TUOLUMNE COUNTY

On January 10, 2011 Governor Jerry Brown released his proposed 2011-12 state budget. To start the year off, I will try to give you a brief summary of the highlights. Unfortunately, by the time you read this article, some of the information may be old news, the same news or not even the plan that we will be operating on depending on whether or not the legislature buys into the plan. We always have to remember that we are in the State of California and "anything can happen".

The proposal released by Jerry Brown suggests a strategy to eliminate a combined 24.5 billion deficit: \$8.2billion in 2010 -11 and \$17.2 billion in 2011-2012. The most striking elements of the plan include a major state and local realignment for spending, an extension of temporary tax hikes and the elimination of redevelopment agencies.

Governor Brown repeatedly emphasized throughout his plan that the borrowing gimmicks, and one-time solutions that have bridged budget gaps in previous years have only delayed the reckoning that the state now faces. This is something I have been harping about for years. Upon initial review it appears that this statement is "mostly true". There is some borrowing from special funds, and a few of the cuts would require federal approval. The plan to eliminate redevelopment agencies would, no doubt, face legal challenges.

The Governor would have the Legislature implement the cuts sometime in March and call for a special election to be held by June at which time voters would decide whether or not to extend the temporary taxes that otherwise are scheduled to expire this year. The budget proposal does not include a reimbursement to counties for the proposed June election. In talking to Debbie Russell, Tuolumne County Clerk Auditor in charge of elections, it would cost the county over \$60,000 to run this special election in the standard way. There may be a way to save considerable dollars by doing a "by mail" ballot only. During the budget presentation when asked what would happen should voters reject the taxes, Governor Brown said to "go through the cuts and multiply by two." He then elaborated, saying that, of the services the state provides, cuts not requiring federal approval would be in the area of universities, prisons, and K-12 education.

The Governor has taking a very tough line, one that may be necessary in tough times.For more information and a detailed review of Governor Brown's Budget proposal, go to the Rural Commission on Rural Counties website. (RCRC) The website is: www. rcrcnet.org.

I began my third year as your supervisor as Chair of the Board. I'm honored to have been selected by my fellow board members for this position. I look forward to the challenge and pledge to do my best to represent Tuolumne County and its people.

In past articles I have touched on the importance of establishing and maintaining a good relationship with our government agencies. What happens in our National Forest and Parks has a direct effect on the economy of rural counties. The Board of Supervisors will be establishing two new committees this year. A Legislative Committee will be set up to deal with State and local governments on a developed platform and a Natural Resource Committee that will deal with the many issues that come before the board concerning the use and protection of our naturals resources. Having these committees in place will be extremely beneficial as we work with many environmental and government to government issues that come before the board.

I have referred to board goals a number of times in previous articles. One goal that we have undertaken is the "development of a five year plan of improvements in Tuolumne County government operations. There have been rough drafts shared with the Board but it has been agreed that we should

hear from the public before attempting to prepare a final plan. As you may recall, the Board held five evening meetings last year, one in each supervisorial district, at which the public was invited to contribute their comments. Additionally, a survey was posted to obtain public input into the process and even more public participation was gathered through three town hall meetings hosted by the respective district supervisors in the Don Pedro, Phoenix Lake and Tuolumne areas. While this welcome input was considered and helped to shape the Fiscal Year 2010 County Budget, no action has yet been undertaken in the development a five-year plan.

A couple of key issues that have been asked during this process are: 1) "What is the County's mission Statement?" Answer:"we don't have one"; and 2) "Shouldn't establishing one be the first order of business?" I agree, wholeheartedly, that we should have a defined vision of where we want to go as a County.

In order to address those questions the Board has agreed on the following process.

Schedule an off-site retreat with an independent facilitator to help guide the Board, other staff and public attendees in the development of County core values, vision and mission statements.

Direct staff to then develop a 5-year plan that compliments and accomplishes the newly developed core values, vision and mission;

The Board is to adopt all of the above drafts ready for public review and input;

Conduct a new round of public outreach in each of the five supervisorial districts with a complimentary survey to get input on the draft statements and plan. (Conducting such outreach on a regular basis was requested by the public last year.)

Modify the statement and plan in consideration of the input received and adopt them; and

Establish future Board goals that compliment these guiding documents.

The Board has acknowledged that this process will not complete the classic strategic planning cycle which includes establishments of related goals, objectives, and tactics and performance measures. To complete all of this at one time would consume the organization when we simply do not have the capacity (human and financial) to do so and still address the immediate demands upon us. The above however would be a good first step which could be built upon. Stay tuned and be a part of the process.

Jalapeno Bottle Caps

Looking for something new to serve at your Super Bowl Party? This recipe is sure to please those that like a spicy "kick" in their appetizers. Although these are traditionally made with a "beer batter", we found that we liked them even better with a Tempura batter. If you have some guests that are not ready for the spiciness of Jalapenos, you can deep fry lots of other veggies in this tasty Tempura batter. Try mushrooms, onion rings, cauliflower, sweet potatoes, etc...to accompany your bottle caps!

This batter recipe is for 1-1/4 lbs of fresh (not pickled) jalapeno slices.

1-1/2 Cups All Purpose Flour1/2 Cup Cornstarch2 tsp Salt (optional)2 tsp Black Pepper, freshly ground (optional)

- 2 tsp Garlic Powder (optional) 2 tsp Chili Powder (optional)
- 1 large Egg
- 1 Cup Vodka 1 Cup Club Soda

Mix dry ingredients in a bowl. The original tempura batter has only flour and cornstarch for dry ingredients; our spicy batter has all of the "optional" spice ingredients as well. In a separate bowl, mix egg and

vodka, and then add club soda. Heat oil to 385 degrees F; wisk

together dry and liquid ingredients for batter (just before frying). Dip items to be fried in batter and drain off excess batter, and then fry until golden brown and crispy.

Serve with Ranch Dressing or Horseradish and Sour Cream Sauce (1/3rd Horseradish, 2/3^{rds} Sour Cream).

The American Veterans Traveling Tribute coming to Tuolumne County

The American Veterans Traveling Tribute (AVTT) and Traveling Vietnam Wall Memorial will visit Tuolumne County March 24-27, 2011 at the Mother Lode Fairgrounds in Sonora in honor of Welcome Home Vietnam Veterans Day (WHVVD) on March 30. The Tribute arrives March 23 escorted by the Vietnam Veterans of America (VVA) Chapter 391's Motorcycle Group, including members of the Patriot Guard, and will be set-up the morning of March 24.

The AVTT Traveling Wall is the largest Wall replica traveling the U.S. It is an 80% version of the Vietnam Wall Memorial in Washington, D.C. At its apex, the Traveling Wall is an impressive eight feet tall. In addition to the Tribute to those who perished in Vietnam, the AVTT also includes several other memorials and exhibits including The Cost of Freedom Memorial, the 911 Memorial, the Walk of Heroes, Vietnam Remembered, the Tribute Panel, World War II and Korean Tributes.

According to George Eldridge, chair of the event, "Last year's parade in honor of WHVVD was a huge success. We decided to pay tribute to those who didn't return. For this year's WH-VVD, in keeping with the VVA's founding principle, "Never again shall one group of veterans abandon another," we chose an event which will pay tribute to all veterans in celebration of WHVVD."

The World War II memorial presents displays of photographs and information to pay specific tribute to WWII veterans. The Korean War tribute is a pictorial display of the

men who fought the 'Forgotten War' along with battle maps and the war timeline. In addition to the Traveling Wall, Vietnam Remembered is a nationally acclaimed art display of original paintings and more for reflection by visitors and veterans. The 911 Memorial includes stand-up exhibits with lighted twin towers to ensure "we never forget". Each name is recorded according to their location at the time of the tragedy. The Walk of Heroes is a series of stand-ups which pay tribute and provide education regarding our country's history, as well as conflicts in which America was involved to ensure our freedom. Freedom did not come free and this tribute represents the true cost as paid in lives. The Cost of Freedom Memorial is another series of stand-ups created in gold dog tags recording the names of those who gave their lives for our freedom since Vietnam and including present-day Enduring Freedom and Iraqi Freedom.

Also at the Tribute is a Tribute Panel where anyone can purchase a custom engraved dog tag. This is a tribute with a personal message to a loved one, past or present. This Tribute travels the nation with all other exhibits.

All area schools will be invited to visit the Traveling Wall as part of their history education on Thursday and Friday.

On Friday at 1 p.m., there will a welcome ceremony. According to Dick Southern, co-chair of the event committee, "We're inviting Governor Jerry Brown to speak along with the California Veterans Affairs Under Secretary

Rocky J. Chavez, who is a Vietnam Veteran, and Assemblyman Paul Cook (R-Yucca Valley) and Vietnam veteran, who put up the bill making March 30 Welcome Home Vietnam Veterans Day. We will also have the Board of Supervisors for both Tuolumne and Calaveras counties represented, along with members of the City Council of Sonora. Keynote speakers will be Medal of Honor recipients including Jon Caviaiani of Sonora, and Steve Mackey, the President of the VVA California State Council. There will be a reading of names of Tuolumne and Calaveras names on the wall and then a total of the 5,880 California names on the wall. This will be recorded by members of VVA Chapter 391 members so it can be played for the remaining three days of the event."

"In addition to paying tribute to all men and women who didn't return," according to AVTT spokesperson Leah Gallagher, "the mission of the project is to travel the nation to honor, respect, and remember men and women who served, and to pay specific tribute to those who gave all in that service. Since the tribute is mobile, it allows people to honor and respect veterans and active military personnel without their having to travel long distances."

Across its 370-foot length, the Traveling Wall contains every single name etched on the original. Computers will be available to locate any individual's name. AVTT's Traveling Wall is not to be confused with other replica walls (The Moving Wall, The Dignity Wall, The Wall That Heals). "We are all on a mutual mission," says Gallagher.

Also at the event a concert-dinner is being planned along with a local Vietnam Veterans Art Show. There will be some vendors with food and drinks. Several veterans' organizations will also have information tables available. The VVA-Chapter 391 is developing a souvenir t-shirt for this event and three Medal of Honor recipients will be offering their autographs on the shirts for a donation and a portion of the money raised goes to the Medal of Honor Society. These medal recipients are all Vietnam veterans.

On Saturday, March 26, VVA-Chapter 391's Motorcycle Group will hold an Honor Ride from Jamestown Harley-Davidson to the Mother Lode Fairgrounds. Motorcycles from various groups including the well known Patriot Guard will gather in Jamestown at 11:00 a.m. to make the ride to the American Veterans Traveling Tribute at the fairgrounds in Sonora. A great number of these motorcyclists are Vietnam veterans.

Another plan is to have an Agent Orange Town Hall meeting to bring attention to the effects of this defoliant in Vietnam and the after-effects it's having on the children born of Vietnam veterans exposed to the chemical. VVA-391 hopes to have the VVA Director of Communications Mokie Porter from Silver Springs, MD on the panel.

VVA-391 is looking for sponsors for this event. The sponsorships range from \$100 to \$5,000 and all include recognition and professional banners which will be displayed for the four days of the event. They are also offering advertising in the souvenir program. They are anticipating a minimum of 10,000 people to attend this four-day event. 

COMMUNITY CORNER A Total Lunar Eclipse


Just a few months ago you may have been lucky enough to catch the total lunar eclipse that occurred from about 9:30 PM on December 20th and lasted into the morning hours of December 21st. This lunar eclipse was the first total lunar eclipse to occur on the day of the Northern Winter Solstice (the first day of winter) since 1638, and the first total lunar eclipse visible from the United States in almost three years, since the February 2008 lunar eclipse. Unfortunately, the skies were cloudy, and the ability to observe this lunar eclipse was somewhat limited. So I decided to share the images that I captured of the lunar eclipse in August 2007.

Our Moon is about 2,160 miles in diameter. The distance from the Earth to the Moon is about 239,000 miles. It has no light of its own but shines by

sunlight reflected from its surface. The Moon orbits Earth about once every 29 1/2 days. As it orbits our planet, the changing position of the Moon with respect to the Sun causes the different phases of the Moon – from full to a small crescent.

An eclipse of the Moon (or lunar eclipse) only occurs during a full Moon and only if the Moon passes through some portion of the Earth's shadow. This can occur only when the Sun, Earth, and Moon are aligned exactly, or very closely, with the Earth in the middle.

> The Earth's shadow is composed of two cone-shaped components, one nested inside the other. The outer or penumbral shadow is a zone where the Earth blocks part but not all of the Sun's rays from reaching the Moon. The inner or umbral shadow is a region where the Earth blocks all direct sunlight from reaching the Moon. It takes the Earth's shadow a little over an hour to totally envelop the Moon.

Because the Moon's orbit around Earth is tipped about 5 degrees to Earth's orbit around the Sun, the Moon spends most of the time either above or below the plane of Earth's orbit. During most full Moons, the orbit passes above or below Earth's shadows, and no eclipse takes place. But two to four times each year, the Moon passes through some portion of the Earth's penumbral or umbral shadow, and a lunar eclipse is visible somewhere on Earth.

When an eclipse of the Moon takes place, everyone on the night side of Earth can see it. About 1/3 of lunar eclipses are total eclipses – that is, the Earth blocks all direct sunlight from reaching the Moon. The Moon does not completely disappear, even during a total lunar eclipse because of the refraction of sunlight by the Earth's atmosphere.

During a lunar eclipse, the Moon can appear various shades of yellow, orange, and red because sunlight reaching the Moon must pass through a long and dense layer of the Earth's atmosphere, where the light is scattered. Shorter wavelengths are more likely to be scattered by the small particles, and so by the time the light has passed through the atmosphere, the longer wavelengths dominate. This resulting light we perceive as red. This is the same effect that causes sunsets and sunrises to turn the sky a reddish color. The amount of refracted light depends on the amount of dust or clouds in the atmosphere. For example, total eclipses tend to be very dark after major volcanic eruptions since these events dump large amounts of volcanic ash into Earth's atmosphere.

Unlike solar eclipses, lunar eclipses are completely safe to watch. You don't need any kind of protective filters. It isn't even necessary to use a telescope. I decided to take a series of photographs to document the entire lunar eclipse event. The equipment set up for these photographs consisted of a digital SLR camera attached to a telescope that was mounted to a motor driven telescope mount.

As most people know, the sky is in continuous movement. The most obvious indication of this movement is the movement of our sun during the day - rising in the east and setting in the west. Our entire planet rotates around the north and south pole axis. The purpose of a motor driven telescope mount is to "track" the movement of the sky in a way that keeps the objects being viewed in the telescope (or camera in my case) centered within the field of view. Lunar photography is less demanding on a telescope mount then deep sky objects (galaxies, nebula, star clusters, etc...) because the photographic exposure time is short - on the order of thousands of a second to several seconds verses exposure times of hours for a deep sky object.

The lunar eclipse photograph printed in this article is a series of 14 separate images of the Moon taken during various times/phases of the eclipse. The time-line begins at the top of the photograph (12 o'clock position) with a full Moon and moves clockwise. As you circle clockwise around this pho-

tograph you can see Earth's shadow begin to cover the view of the Moon. At first glance, this may appear like the normal phases of the Moon that you view in the sky each month, except these views of the Moon are taking place over a 4 hour period, instead of the 29.5 day cycle that it takes for the Moon to go from "full Moon" to "new Moon". At the bottom of this composite photograph (6 o'clock position), the Moon was completely in the Earth's shadow.

Watching a lunar eclipse is a spectacular experience. It's amazing to watch the Moon go from full, to a small crescent, to total eclipse,



and back to full again. I took over 300 photographs to create this final composite of 14 images. The Moon "phased" through many shades of orange and red, and the night sky went from being so bright during the full Moon that I could barely see the North Star, to so dark during the total eclipse that I could easily see the Milky Way.

Your Help = A Better Life for Caiden

Do you know what cerebral palsy is, or do you know anybody with this illness? We can tell you about an adorable three years old boy that was born with CP, that now NEEDS YOUR HELP!!!

Caiden Waggle was born April 1, 2007, in Sonora. To his parents Nick and Kim Waggle; Caiden was diagnosed at five months after birth with cerebral palsy and cortical visual impairment, caused by a car accident at 26 weeks of pregnancy. His parents Nick and Kim both attended Tioga High school.

If you were to see Caiden you would automatically fall in love with his precious smile and big green eyes, which are both impossible to miss. You would never get the idea that this little piece of sunshine would be a victim of this horrible illness.

At three years of age Caiden can't walk, talk, sit up, crawl, or see at a far distance; all he really can do is roll and make sounds. Even with all these downsides Caiden's smile never leaves his face; he is a strong little boy who doesn't give up and makes every effort to accomplish everyday struggles. That for us wouldn't seem like a big deal, but for him it's a huge goal.

We could never imagine the pain Nick and Kim go through every morning waking up knowing he won't be able to

grow up as a normal kid, knowing that there isn't much they can do to help him, but to show and tell him how much they love him and thank God for their adorable little boy. The pain he goes through every doctor visit, every time he sees kids playing around him and not being able to play because he can't walk or talk, but most of all not being able to tell his parents he loves them.

A while back, Kim met a 4 year old boy, who had cerebral palsy as well, and his parents took him to get surgery in Germany; the surgery was a success. He has made huge improvements in his life for example walking which has definitely made his life easier and better. The surgery Caiden will need is called Lumbar which will consist of taking a small amount of bone marrow from his hip and then taking stem cells (which are not blood cells) and putting them in his spinal fluid which flows to the brain. Stem cells are also able to make new cells that will spread throughout his body where they are needed the most. Caiden's surgery will take place in Germany, which will cost \$30,000.

Contractor Checklist for Homeowners

CHECK OUT YOUR CONTRACTOR

Did you contact the Contractors State License Board (CSLB) to check the status of the contractor's license? Contact the CSLB at 1-800-321-CSLB (2752) or visit our Web site: www.cslb.ca.gov.

Did you get at least three local references from the contractors you are considering?

Did you call them and see the work the contractor completed?

BUILDING PERMITS

Will the contractor get any needed permits before the work starts?
 Are the permit fees included in the contract?

CHECK OUT THE CONTRACT


- Did you read and do you understand your contract?
- Does the 3-day right to cancel a contract apply to you?
- Does the contract tell you when work will start and end?

Does the contract include a detailed description of the work to be done, the material to be used, and equipment to be installed? This description should include a plan and scale drawing showing the shape, size, dimensions and specifi cations. It should include brand names, model numbers, quantities and colors. Specific descriptions now will prevent disputes later.

□ Are you required to pay a down payment? If you are, the down payment should never be more than 10% of the contract price or \$1,000, whichever is less.

□ Is there a schedule of payments? If there is, you should pay only as work is completed and not before.

Did your contractor give you a "Notice to Owner," a warning notice describing liens and ways to prevent them? Even if you pay your contractor, a lien can be placed on your home by unpaid laborers, subcontractors, or



material suppliers. A lien can result in you paying twice or, in some cases, losing your home in a foreclosure. Also check the "Notice to Owner" for ways to protect yourself.

Did you know changes or additions to your contract must all be in writing?
 Putting changes in writing reduces the possibility of a later dispute.




