# President's Message

Another near perfect summer in Pine Mountain Lake (my 23<sup>rd</sup>) is nearing an end. Now it is time to prepare the 2012 Budget. After serving on the Board of Directors for two years, I'm astounded at the amount of work required by everyone involved in the preparation of the yearly budget.

All things considered, let me say "WE GET IT". By this I mean the mortgage crisis of 2008 evolved into a stock market crash that morphed into a recession which we are now mired in.

Everybody involved in the budget process lives with this reality daily.

It is the Big Picture that counts for an HOA Board. The Board must look at the Association in its entirety and decide what is in the best interest of the membership. We continually review and refine this mandate. The Board member position is voluntary, but we take our fiduciary duty seriously. This Board comes to meetings having read the Agenda and Board Packets beforehand, ready to make decisions based on factual information. We strive to make informed decisions that are best for the entire community.

Each year, the annual budget meeting is held in October and is open to all members who wish to attend. We hold this annual meeting so that the Board and Management Team can discuss and make decisions in preparation of the final budget.

In the past, members were given carte blanche to ask as many detailed questions as they wished, as many times as they wished. This led to lengthy debates between the members, managers and the Board. Unfortunately, this type of format led to an acrimonious atmosphere and a deviation from meeting decorum and purpose. This year, we are reestablishing a meeting format that is streamlined, and more productive.

Due to the number of agenda items, we anticipate the meeting to last most of the day. To ensure that the meeting is conducted in a productive manner, and to maintain the appropriate decorum, member participation will be limited to comments only.

Each department manager will give a short presentation, and provide an

overview of their budget proposal to the Board. The Board will then discuss the budget proposal with the management team. After the Board has completed their discussion, members will be given an opportunity to comment. Comments should be kept to three minutes and members should only take one opportunity to comment per agenda item.

Members that attend the budget meeting will find that most of their questions will be answered during the process. Nevertheless, Association Controller, Ken Spencer, will be available at the end of the meeting to schedule a time to meet or respond to any member that has a question regarding the proposed 2012 Budget. Ken's office number is published monthly in the PML News and he encourages members to call if they have questions regarding Association finances.

On a different matter, I would like to urge all drivers to please adhere to the posted speed limits within our



beautiful association. I have observed vehicles striking deer and running over squirrels and birds because they were going too fast to avoid them. Let's hope we never have this happen to a pedestrian or a bicyclist.

Thank You for taking the time to read this message. See you at the Grill or the October meeting.

I would like to close this message with a quote by Thomas Jefferson.

"Under difficulties, I have found one and only one rule; to do what is right, and generally we shall disentangle ourselves almost without perceiving how it happened."

# **General Manager's Message**

### **PML Makes Financial Adjustments**

Like most associations, the down economy has affected the PML financial results. A reduction in projected revenue at some amenities, and an increase in costs in other line items resulted in a negative result at the end of August. Even with the most prudent financial planning, there will be factors that are unexpected or difficult to control.

To ensure that we reach our budgeted financial goals, my management team and I took immediate action to mitigate this shortfall. We postponed filling two open positions and canceled an annual employee event. Even with these adjustments, our staff has stepped up to ensure that the quality of member services will not suffer.

We have a great team and they are always looking for ways to operate PML more efficiently with an eye on cost-savings. We will continue to monitor the financials weekly and make other adjustments as necessary as we progress through to the end of the year.

### **2012 Budget Process**

As I mentioned in previous articles, the 2012 Budget Process is in full swing. The day-long, open Budget meeting will be held on Saturday, October 15<sup>th</sup> at the Lake Lodge. The meeting starts promptly at 8 a.m. and we encourage all interested members to attend.

The final approval of the Budget is handled by the Board of Directors at the November Board meeting, which is scheduled for Saturday, November 12<sup>th</sup>. This meeting will also be held at the Lake Lodge and begin at 9 a.m.

### **Current Litigation**

In recent weeks, several property owners asked me why our legal fees are much higher than what was originally budgeted. The biggest impact to our legal fee budget is the PMLA v. Greer/Milliron case. Unfortunately, PML was forced to file a lawsuit against these members earlier in the year to enforce the CC&R's. We did everything we could to mediate the matter prior to filing the suit, but to no avail. We will continue to update the membership as the case progresses, and anticipate recovering all legal fees from this matter.

### **Canada Geese Issues**

As I mentioned last month, we continue to experience issues with the resident Canada goose population. The geese propagate, eat the grass at the Marina and Golf Course and of course, leave many pounds of feces in their wake. Most recently, I received several complaints from members because of the condition of the Marina. The Marina Store closed down for the season and we did not have staff or resources budgeted to continue to clean up the mess. Unfortunately, the problem was worse this year. We are looking at an adjustment to the Marina budget for next year to deal with the problem.

Over the years, we have tried many non-lethal methods to haze the geese,

in an attempt to get them to move to other areas.

We are considering the formation of a waterfowl management committee to enlist the assistance from the membership. So far, I have not received one call from our members.

If you are a member who is interested in serving on this proposed committee, please let our Administration staff know. If we get enough members who are interested in volunteering their time to serve on this committee, I will ask the Board of Directors to approve a charter and form the committee. If we do not see enough member interest to form a committee, we will budget additional resources to resolve this issue.

# **Thoughts About a New Pool**

PML residents should urge the PML Board to plan for the replacement of the current pool at PML. Since 1975, there has been a series of requests, studies, and suggestions to replace the current pool with a pool that meets the needs of the PML residents. A pool that provides a year-round indoors exercise facility for all homeowners. A pool that provides a place for residents to swim laps and a safe place for children to play in the water at the same time. A facility that provides a locker room for people to change clothing before and after swimming.

Simply spending more money to maintain the current obsolete pool facility is not cost effective. We have the space (6 acres) set aside for this facility behind the tennis courts (3 and 4). The last long range survey reported the majority of PML homeowners support a fitness center at PML. Now is the time to build an indoor pool.

With proper planning, I believe we could have an indoor swimming facility that within 5 years eliminates the approximately \$80K (without depreciation) in annual costs. We could implement creative fund raising to minimize the use of PML funds.needed to construct the pool. A new facility would add so much to the value of our investment in PML and improve the quality of life for all residents who chose to use the new facility.

# Horsing Around At The Stables

Well, fall is coming and things are slowing way down at the stables. Until next spring our trail rides will be on Friday, Saturday and Sundays, unless prior arrangements have been made. For any info needed please call 209-962-8667. We did have a great summer here at the stables with lots of events.

On Sept 3rd the Country Mountain Riders put on a play day, there was around 25 riders who tried this out. On September 4th the STCHS group did their Labor Day BBQ and had a very good turnout. There were a lot of displays to see along with wagon rides, petting zoo and very good food.

Labor Day weekend there was a new outbreak of the EHV-1 virus at Kennedy Meadows pack station on Highway 108 out of Sonora. Matt Bloom lost one horse and may lose more of them before it is over. As of September 16th there are seven horses displaying clinical signs and have been quarantined.

There are also two confirmed cases of this virus in San Joaquin County and one horse in Sonoma County. This virus is very easy to spread among horses. We are not allowing any new horses to come into the PML Stables until this virus is



over. There has to be at least 21 days of no outbreaks before this virus is under control. At this point I don't know that we can allow new horses into the stables.

Just a reminder that the Stables are open all year long, so if you want to go on a ride we can do it for you. About the only time we can't do rides in the winter is if the trails are too muddy or if it snows too much. These trails do dry out real quick which allows us back out in a couple of days after some sunshine.

# **PMLA Money Matters**

During the recent Federal government budget deficit/default debate there was a great deal of discussion on how to handle this crisis. Many people argued that the way to address the issue was to cut spending, while others said we needed to raise taxes to reduce the deficit. What is the right answer? I'm sure we each have our opinion on this difficult subject.

Listening to the debate and the impassioned rhetoric I found myself relating this whole process to the challenges we face here at PML as we work on the Association's budget for 2012. Now I understand that PML's budget and financial issues are not on the same scale as the US Government, however the principles and the underlying concepts are basically the same. Should we cut expenses or raise the assessment? As with most choices there are consequences that go with choosing either path. It is my belief that those that blindly support one or the other of these choices exclusively is ignoring the reality of the situation.

Cutting expenses sounds like an

easy solution. Just reduce what we spend and the problem goes away. Unfortunately this is something that is easier said than done. How much should we cut in expenses? Where do the cuts come from? What is the affect of the cuts?

When cutting costs it is easy to get trapped by the NIMBY affect. Cut costs but "Not In My BackYard." Advocates of cost cutting seem to want the "other guy" to suffer the pain. "Reducing services at an amenity (Golf Course, Marina, Stables, etc.) is great as long as it is not something I use." This could very well be the mantra of some cost cutting advocates. It takes courage to look at not only the cost reduction but how that cost reduction affects the overall operation of the Association.

Advocates of higher taxes (assessments) to solve the issue can often believe that just paying more will take care of the problem and keep everything humming along. Unfortunately this does not take into account the plight of those taxpayers (homeowners) that are having a hard time even paying the current assessment. Does a higher assessment really solve the problem or just create a new one? How do we collect the higher amount? What about those who can't pay?

As you can see there is no easy answer and rarely is the real solution found at either extreme. The middle ground is generally where the best choice lies. Compromise is the name of the game. Each side has to give a little to accomplish something for the greater good.

In the case of PML this is where the Board of Directors comes in. They have a fiduciary duty to address the needs of the Association as a whole and not just a special interest group or one amenity or department. They have to balance the desires of a diverse range of property owners and come up with the best plan to insure that PML remains a strong, vibrant and successful community.

Be assured that the management team and the Board will be working hard to accomplish this goal with as little "pain" as possible, while still maintaining the high standards you have come to expect when it comes to the services and value you receive as a PML property owner.

I urge you to keep this in mind as we go through the challenging process of developing the budget and related assessment for next year. Finding the middle ground and compromising on strongly held beliefs that may be tough and difficult to accept. However, only by working together and taking all factors into account can we truly develop an economic plan that works for the Association as a whole, as well as the individual property owners that make up this community known as Pine Mountain Lake.

# **Shades of Green**

Where do the labor hours go? As the mowing season slows down, we will turn our attention to the fall cleanup. This cleanup process is finally completed around the first of the year. Daily blowing of the tees, greens, and fairways, along with sweeping and relocating the leaves to our mulch areas and grinding them up, requires considerable labor hours.

Other projects for fall and winter are drainage improvements and tree trimming. Last winter the majority of our tree work consisted of cleanup of storm damage. That limited some of the trimming of other trees that we do each season for playability and to improve irrigation coverage.

Drainage projects scheduled are to improve the drainage near the approach to the fourth green. All of our culverts are failing and we will begin here. It is in a location that is difficult to work in while the hole is open for play. We are looking into ways of not removing the culvert but to insert another drainage pipe for water flow and sealing around the existing culvert.

Located near the left bunker on eighteen is another failed culvert. The drainage that comes off of the parking area in front of the Grill comes down to the drainage that crosses in front of the eighteenth green. Where these two culverts come together has failed, after each rain late last spring we would have a large sink hole.

Fall aeration of the greens has been completed. We are aerating all areas of the course and should be completed by the middle of October. We do not enjoy this process any more than you, the player, does. However, the golf course does. We will do everything we can to complete this process while having the least amount of impact on your round of golf.

Have a great fall. Enjoy your course; take a drive to see the colors of the aspens and dogwoods this season.

# **Compliance Chatter**

### Gate Card/Clicker Policy

I suppose it goes without saying that the safety of our residents is an important function of any homeowners association. One of the key means to that safety is controlling who has access through our gated roads. It is very important that we know who has entered and this is why our gate card/clicker rules are closely followed by our Safety personnel.

Unfortunately, many members violate these rules and when asked about the rules many claim they had no idea this was a violation. Therefore, a review of our gate card/clicker policies can support our safety officers as they enforce our policy, which is spelled out in Resolution #04.04 amended November 14, 2009. The following is a condensed version of this resolution and highlights the areas where we find most violations.

### **Owners:**

Gate cards and clickers are only issued to property owners on the deed. One card is issued per owner on the deed. These cards/clickers provide access through any gate and can only be used by the named Owner on the card.

Property Owner dependant photo ID cards are issued to children under 18 living with the property Owner. They are for access only through the guest lane at the main gate.

Special User Access Cards may be purchased by the property Owner. These gate cards can be issued to property Owner's relatives, one generation up and one down without the General Manager's signature. All others must apply in writing and receive approval from the General Manager. These cards provide access through any gate.

### Renters and Tenants of Property Owners:

Property Owners who rent their homes for 3 months or more may allow their tenants to purchase gate cards. Rental cards are issued only to the names of those on the lease/ rental agreement. These are all access cards and can only be used by the named renter on the card.

Renters with dependants, 16 years

of age or older and who live with the renter, can purchase gate cards for their dependant. No more than two dependant gate cards per renter will be issued. The dependant must be listed on the rental agreement. The renter must show the dependant's driver's license and a need for the card. These cards provide access through any gate and can only be used by the named dependant renter on the card.

For renters who do not want to purchase an all access gate card, they can obtain a photo ID card that only provides access through the guest lane at the main gate.

Short-term renters are required to have a pass called in to the main gate for access into PML from either the management company or the Owner. Vehicle access parking passes are also required and can be purchased by the Owner or Management Company at the Administration office.

### **Conclusion:**

Anyone using a card/clicker for which they do not qualify is in violation and the card/clicker will be confiscated. The Owner can pick up the card at the Administration office. The following are examples of gate card violations:

- 1. You lend your adult daughter your clicker so she can have access to your vacation home.
- a. Your adult daughter does not qualify for an Owner card/ clicker. She should have a Special User Card or be placed on your authorized visitor list for automatic access at the main gate guest lane.
- 2. You lend your gate card/clicker to a hired worker.
  - a. Your hired worker does not qualify to use your gate card/clicker. You should call in for a day pass so he will have access through the main gate guest lane.
- 3. You lend your gate card/clicker to your business partner so they can spend a weekend at your vacation home.

PML Fire Abatement Team Update

October is here and we'll now see many leaves and pine needles coming off the trees and falling to the ground. I want to remind my neighbors that the best practice is to leave them on the ground until spring to help avoid a soil erosion problem. We just spent a lot of money with our lake dredging project, which is a direct result of rainwater and soil erosion carrying dirt and silt into our lake. As we explained in our "Be Ready-Be Safe" DVD, it's not a good idea to rake up all the debris on the ground and expose the bare soil. Leave that material where it falls. Of course, it is important to get that debris off the sidewalks and decks, for safety reasons.

As for removing brush and limbing trees, most folks who are doing yard clean up are taking unwanted vegetation to the compost pile. But some will burn in place. Remember, you need a PML Burn Permit in order to do outdoor burning. And you'll need to call into the main gate to report your intentions. That's a good time to check to see if it's a permissive burn day, or if there are CAL FIRE restrictions. We have 435 permits issued to date. Thank you all for your support.

### Burn Permit Process - Last Season Report

Last fall/winter was our first season with the burn permit program in place. The safety department logged 900 calls over the entire season from people who wanted to burn. All had their permits. We received a total of 24 complaints of excessive smoke. Safety visited all sites to investigate and coached the property owners.

Most complaints are the result of people trying to burn wet leaves and pine needles. So again, leave them on the ground during the winter and spring months. When it's time to do your fire safety cleanup, rake them up and take them to the compost pile. If you must burn needles and leaves, make sure they are completely dry.

The permit process is really an educational process. As we get complaints, we educate. We expect to drive down the number of complaints each year and look forward to nice clean air to breathe.

- a. Your business partner does not qualify to use your gate/ card clicker. You should call in for a day pass so they can enter through the guest lane at the main gate.
- 4. You lend your gate card/clicker to your tenant so they don't have to purchase a gate card.
  - a. Your tenant does not qualify for an Owner gate card. They need to purchase their own or apply for a photo ID card that gives them access through the main gate guest lane.
  - b. If they are a short-term renter, the Owner or Management Company must call in a pass to the

main gate to allow the tenant access to PML. Vehicle Access Parking passes must also be provided to the tenant. One is required for each vehicle in the party. They can be purchased at the Administration office.

Most violations occur because the card/clicker is given to someone who does not qualify to use it. In addition, while it is convenient to lend your card, consider the fact that our safety personnel have no idea who has entered and whether or not they are authorized to be here.

In closing, strict adherence to these rules provides a safe environment, which benefits all members and their families. Let's all do our part.

# This Old Mail House

The architecture is simple, the silhouette is pronounced, a somewhat rustic motif of function over style, and the views are grand. The Rock Canyon Mail House, sitting above the slope overlooking the Tennis Courts on Rock Canyon Way.

This is the first of the mail houses to receive a reconstruction of the pavement, drainage, curbing, railing, and the placement of protective bollards. After being built in 1990, the building had changed little, except for the electric service line being constructed to convert the building to full electric service. Enhancements had been made to provide better lighting for the residents who use this postal service mail house, and a ventilation system for the interior of the building.

The pavement had deteriorated over the years, along with some movement on the fill embankment, which together were creating a storm water drainage concern, along with the asphalt breaking up. Two separate but major concerns are protecting the mail houses from vehicle collisions, and safe-guarding the visitors who are using the facilities. Protective steel bollards are placed on the vehicle approaches at the mail house to achieve this protection.

The Maintenance Department has begun work on the mail houses with the Rock Canyon Mail House. The crew demolished and removed the asphalt pavement, removed the old railing, and graded the site. A road base was placed about the building and parking site. A concrete retaining curb was constructed on the top of the slope to protect the embankment. This short concrete wall also safe-guards vehicles from going over the embankment. Steel railing has been installed to enhance the site, an aesthetic improvement, as an additional safe-guard in preventing visitors from falling over the embankment. The steel bollards are placed, painted safety yellow with reflective stripes. The parking has been enhanced and the pavement has been slurry sealed.

The drainage at the site has been improved with the grading. Storm water will now channel away from the building and will be directed to a concreted culvert. Enhancements are being made to correct the drainage and erosion of the embankment. A game trail and foot path down to Rock Canyon Creek and the hiking trail has created an erosion problem. Work will be done to control this erosion on both sides of the creek. The Maintenance Department will be constructing a pathway and moving the bridge which connects the Rock Canyon Mail House with the Tennis Courts.

This is the first of the mail house site improvements. The Maintenance Department will be working on the Ferretti Road Mail House, the Golden Rock Mail House, and the Clement Mail House in the next few months. We will try our best to reduce the impact to the residents who use these mail sites and perform the work in a timely manner. Thank you for your patience, and your compliments.



# **Gluten-Free at the Grill**

Recently, inquiries about what is available at the Grill for a gluten-free diet have been increasing. I have read up on this topic to best serve our guests

and how the gluten-free diet applies to our menu. We cook from scratch and use whole ingredients, however some of the ingredients we use have gluten and other ingredient labels say "This product is manufactured in a facility that processes foods containing wheat, milk, soy, tree nuts and seeds..." By using fresh ingredients, as opposed to packaged or pre made, it gives us more control over the product we serve to our guests. That being said, we cannot give a 100% guarantee items are gluten free because we do use flour and bread in our kitchen. If you or someone in your party has a food allergy of any kind, please tell your server and we will be happy to accommodate you. Here is a list of gluten free menu choices:

### Prime Rib, minus au jus

**Grilled Rib Eye with Chimichurri** 

Pork chops with honey apple glaze

Top Sirloin, minus straw onions

Pan-Seared Salmon with wasabi cream

**Grilled Salmon with Fruit Salsa** 

Grilled Mahi-Mahi with Fruit Salsa

### All Side dishes except rice pilaf

The following information is from *www.wikipedia.com.* "Several grains and starch sources are considered acceptable for a gluten-free diet. The most frequently used are corn, potatoes, rice, and tapioca (derived from cassava). Other grains and starch sources generally considered suitable for gluten-free diets include amaranth, arrowroot, millet, montina, lupin, quinoa, sorghum (jowar),

taro, teff, chia seed, and yam. Various types of bean, soybean, and nut flours are sometimes used in gluten-free products to add protein and dietary fiber. In spite of its name, buckwheat is not related to wheat; pure buckwheat is considered acceptable for a gluten-free diet, although many commercial buckwheat products are actually mixtures of wheat and buckwheat flours, and thus not acceptable. Gram flour, derived from chickpeas, is also gluten-free (this is not the same as Graham flour made from wheat). Gluten is also used in foods in some unexpected ways, for example as a stabilizing agent or thickener in products like ice-cream and ketchup." Our ice cream does not have stabilizing agents according to the label.

On another health note, I have been using a new grain at The Grill. Something new and not your standard starch side dishes. Quinoa (pronounced keen-wa) is a new trend in grains, in plant form it is related to beets and spinach. The following information is from www.wikipedia. com. Quinoa was of great nutritional importance in pre-Columbian Andean civilizations, secondary only to the potato, and was followed in importance by maize. In contemporary times, this crop has become highly appreciated for its nutritional value, as its protein content is very high (12%-18%). Unlike wheat or rice (which are low in lysine), and like oats, quinoa contains a balanced set of essential amino acids for humans, making it a complete protein source, unusual among plant foods. It is a good source of *dietary* fiber and phosphorus and is high in magnesium and iron. Quinoa is gluten-free and considered easy to digest. Because of all these characteristics, quinoa is being considered a possible crop in NASA's Controlled Ecological Life Support System for long-duration manned spaceflights.

Quinoa is very easy to prepare and holds well when cooled. It is great as a hot side dish, cold salad or as a hot breakfast cereal. An important tip to remember, the quinoa must be soaked for 15 min prior to cooking, to remove the saponin; the removal of

# **Pine Mountain Lake Aero Club**

July and August were busy fly months for the AERO club members. Some of us logged in over 10 hours in one month. I have been doing lots of solo flying and even completed a solo cross country trip to Tracy. Jim Goodrich took a trip up to Portland and did some glider flying and Rick, Danielle and Janet and myself have been doing lots of training. Bob has been keeping the plane operating safely so that we can all enjoy the thrill of flying.

Larry Jobe prepared a booklet which is named "Path to a Private Pilot Certificate" that will be available on airport day at his booth, however the information was so good that I asked him to send me a copy and he did. Listed below is some information from his document that is very interesting especially if you have a desire to become a private pilot:

· Learning to fly is a complex task that takes practice and time. While you can legally get your certificate within 40 hours of flight time, that is rarely done. The older you are the longer it will take you. (Boy, I sure know about that). Motor skills we use in driving a car do not transfer over to flying and in fact become an impediment at times. Thus if you have been driving for forty years it will be harder for you to re-train your motor skills to fly a plane. A young person who has just started driving doesn't have the problem of overcoming their years of driving and they usually adapt right away. So as a general rule of thumb, for every year you are over 18, add an hour of flight time to the 40 hours. 60 years old equals 82 hours flight time (40+42). Nationwide average is

reported as 80 hours of flight time. Figure about four hours of ground time for every hour spent in the air.

• You need to physically fly the plane, plus learn about weather, flight rules, aerodynamics, navigation, communications, air traffic control and aircraft systems. There are ground schools for this as well as self study courses. You also have to pass a physical exam administered by an FAA physician.

• Costs are the big variable in the equation. Aircraft rental rates vary widely, as does the cost of an individual instructor. Ground school and course material usually runs about \$200 to \$400, plus you need to get a good noise canceling headset such as "Lightspeed" which Larry highly recommends. It will cost between \$500 and \$900 depending on the model and vendor. Flight time, times the hourly cost of the plane and instructor, will be the biggest portion of your cost and there is no way to predict how much time this will entail.

• General aviation and "those little airplanes" as many call them, are as safe as any other mode of travel, if not safer. Flying is as safe as each individual chooses to make it. How to fly safely and deal with the extremely rare occurrence of an actual emergency is a top priority in your training.

# **Country Mountain Riders and Friends in the Saddle**

You have to love your horse to get up at the break of day, feed and muck, brush, pick hooves, saddle and trailer to an event that requires you to jump logs, ride up, down, and through ditches, around pine trees complete with hanging back scratchers, coax your naturally claustrophobic horse into an unfamiliar trailer, run barrels and poles and ride through poison oak, not to mention the heat that day (Sept. 3rd). Many a bottle of water was guzzled and refilled as we all realized a couple of them were not going to keep us ahead of the water curve. Despite this somewhat unappealing description, all of us, and I mean the ones that worked the event and the ones that rode it, had a great time! Unfortunately, the buckles did not arrive in time, but four category winners went home with the cash that would allow them to purchase their buckle, and there were a few ribbons given besides. The overall winners for the four age groups were senior, Nellie Moore; adult, John Banks; Junior, Jordan Kovacs and Pee-Wee, Michelle Edwards. Congratulations, all!

Just after Christmas we reported on six new young horses that arrived from West Virginia from the Asgaard Arabian Farms. One of these was MiMy, a mare purchased by Deborah Kalkowski. Following the Clinton Anderson methods for starting a new horse, MiMy has developed into a very nice mount for her owner. She made her first endurance ride at the Eastern High Sierra Classic ride this August out of Bridgeport, CA. Adding to the course's challenge was the fact that base camp was at 6800 feet and they climbed another two thousand feet in the course of the ride. Along with her rider/owner, Deborah, they came in 13th in a field of twenty-five riders on a thirty-mile ride. Timewise they came in second to last, but that is not the only criteria for deciding position. The condition of the horse and its ability to recover its heartbeat to sixty beats per minute are a major factor. This is a selling point of these strong Arabian bloodlines and proved out on this ride. Deborah was also glad to see how good-minded and calm her horse went on the trails. She noted how many had problems with their horses and remarked at how important the natural horsemanship training was to the thorough and consistent development of her horse. Owners today are lucky to have so many good clinicians that develop a "toolkit" we can dip into to help a horse/rider through a problem. Those of us willing to admit it will tell you that when there are problems, it is generally the rider that IS the problem, not the horse. They get it; we have to learn

# Why Do I Top the Ball?

BY PAUL PIERETTI

When the club head hits the top half of the ball, the shot never gets airborne and the result is a "thin" or "topped" shot. The club head must contact the ball at the low point of the downswing in order for the ball to fly in the air.

Weight Shift: When you stay on your back foot, Danny, on the downswing, the club head rises through impact, hitting the top of the ball. Practice lifting your right foot and tapping your toe at the end of the swing to ensure you transfer your weight to your left side.

Sliding: If you slide your body toward the target on the downswing, Wally, you will be ahead of the ball at impact and the club head can catch the top of the ball before it reaches the bottom of the swing. Practice keeping your head slightly behind the ball at impact.

Lifting the Ball: In an effort to try to help the ball in the air, some golfers actually swing up at the ball, (image that Bob) hitting the top portion and creating the opposite of the desired result. Put a penny in front of the ball and try to hit the ball and sweep the penny away. Fear of the Ground: To avoid slamming the club into the ground on the downswing or "hurting" the grass (you know who you are) some golfers tense up and the club never makes contact with the grass. Relax your shoulders and make a practice swing, clipping the grass and even taking a small divot.

Flipping the Wrists: Beginning golfers sometime flip their wrists through impact, rather than let their arms swing, as well as some old ones like Doc. When the wrists flip, the club head rises and the ball does not. Practice posing in the correct impact position, with the hands slightly ahead of the club head, the left wrist firm and the weight on your left foot.

Poor Ball Position: If you play the ball too far forward in your stance, Mr. Thurman, the club head will be rising by the time it gets to the ball. Position the ball in the center of your stance for irons and off the inside of your left heel (right-handed golfers) for tee shots. Play fairway woods and hybrids just left of center.





In my last article, I wrote about the ill conceived rural fire fee brought forward at the state level. The Tuolumne County Board of Supervisors voted unanimously to oppose this poorly designed plan. Sacramento listened to the rural county's concerns, looked at the bill and, as I predicted, came back with amendments to the bill that made the new bill even worse than the original.

Assemblywoman, Kristen Olsen, has gone on the record as opposing the two new bills, Assembly Bill ABX 124 and the Senate Bill X17. In summary the letter we sent the Board of Forestry contained the following concerns and remains salient to the new bills brought forward.

- The legality of the fee Does it meet the definition of a fee versus a tax under proposition 26?
- The gross inequity of the fee being borne by rural residents.
- The double taxation of some property owners within fire districts that have their own "special assessment" without any additional benefits received from the state.
- The threat the fee poses to our existing cooperative fire response system.

Everyone must continue to put pressure on the Governor to eliminate these bills.

Occasionally I receive calls and questions regarding cell coverage and asking "what is the county doing to improve broadband and cell service".

The County, City of Sonora and the Tuolumne County Economic Development Authority (TCEDA) have been working together with broadband and cell providers to improve coverage. As part of that effort, Comcast and CVIN is bringing a new fiber backbone into the County. We are encouraging their companies to push services out to all areas of the county directly and/or in partnership with local Internet Service Providers (ISP), such as Mother Lode Internet. We have also been working with Sierra Nevada Communications to expand services into the easternmost parts of the County and also into the South County. Golden State Cellular and ATT continue to expand their respective 3G services.

I know that for some it seems like a slow process...but it is progressing!

Last week I was discussing county government with one of the "regular readers" of the Supervisor articles. (I'm not sure, but he may be the only one. I do, however, know that he is the most critical!) He is always a gentleman but straight to the point. His criticism is that I am not profound enough. For one to be profound, I think you really need to know what the word means. So, I googled the word on the internet-like a good user of resources should. I might have remembered that when you use the google dictionary you rarely get one definition but more often you'll find 137,480 different ones. This created more of a dilemma than I had when I started. I wasn't sure which definition to go with; surely they all meant the same thing.

One definition was "coming from the depth of one's being". I could have chosen that one but on this same day I had a conversation with another critic that said I was shallow. So I faced another dilemma. How does a shallow person go beyond what is superficial or obvious? My approach, pick a subject, think about it, make a statement and then let the critic(s) blast away.

The first topic upon which I will attempt to be profound is that of education. It has been, and continues to be, in the news quite a lot, both on the local level and across the nation.

I was told early on that by getting a better education you will have a better life. My observation so far is that this is very good advice. My education has been extremely helpful on my life journey. What I am worried about is that the educational opportunities that have been available in the past are slowly eroding away. We have reduced the number of school days and increased class sizes due to teacher lay-offs.

We find ourselves fighting over students in our own communities. We have cut funding to the very most important safety net for the future that we have, the education of our children. Many have taken the position that education is for other people's children and they shouldn't have to contribute. They are missing the broader picture. Education really isn't for the benefit of other people's children. It benefits all of us to have an educated society.

I believe that we have cut education enough. We can be lean and mean but we also need to be realistic. There is a cost to education. Monies should be spent wisely but to withhold funding in this area is extremely short sighted. Not everyone needs, or even wants, a college degree but everyone should be literate. These young leaders of tomorrow will shape the future of our society and our nation.

In closing, I would like to remind small business owners and those that are thinking about starting a business of any size that there is a great partner available to assist them on their path to success. 





### **Spanakopita**

RECIPE PROVIDED BY TOM KNOTH AND PAULA MARTELL

You may not recognize the name of this tasty appetizer, but chances are that you have had it somewhere. This very rich Greek dish incorporates cheeses, spinach, onions, garlic, and herbs in a decadent fillo pastry to make an unforgettable bite of food. It is a great "make ahead" dish and works well for parties.

- 2 lbs Fresh Spinach (or 10 oz Frozen Spinach)
- 1/2 Onion, chopped finely
- 6-8 Green Onions, finely chopped
- 2 Cloves Garlic, minced
- 1 Tbsp Olive Oil
- 5 oz (150g) Feta Cheese (sheep's milk preferably), crumbled
- 3 oz (90g) Ricotta Cheese
- 1/3 Cup Parmesan, freshly grated
- 1 Tbsp Fresh Dill, chopped
- 1/2 Cup Fresh Italian Parsley or Cilantro, chopped
- 1 big pinch Nutmeg
- 12 sheets Fillo Pastry, thawed (also referred to as Phyllo or filo pastry)

1/2 Cup Unsalted Butter, melted

Trim the stems of spinach and clean them well in cold water. Filling the kitchen sink with lots of water and then submerging and rinsing the spinach works well in cleaning out the mud and debris. Drain. Roughly chop and then place it in a steamer.

Steam for 5-8 minutes or until the leaves are wilted. "Shock" the spinach by placing in ice water, and then drain. Thoroughly squeeze out the excess water from the spinach. This step is extremely important to avoid a soggy filling and crust.

Note: If using frozen spinach, let it defrost for a couple of bours or microwave until defrosted; then thoroughly squeeze out the excess water from the spinach.

Measure out and combine the feta, ricotta, parmesan, dill, parsley (or cilantro), and nutmeg with the spinach.

Heat a skillet over medium high heat; add 1 Tbsp of Olive oil and shortly after the onion; sauté the onion for about 2 minutes or until tender. Add the green onions and sauté for 1 minute, then add garlic, and cook for another 2-3 minutes. Remove from heat and then add the mixture of spinach, herbs, cheeses and nutmeg. Check the taste and season as needed with salt and pepper. Some Feta Cheeses are very salty so you may not need any salt, but you will likely want to add some black or white pepper. If you want a little "kick" to your Spanakopita, you can also add a pinch or two of Cayenne or Chipotle Pepper.

Preheat the Oven to 350F. Melt 1/2 Cup of unsalted butter until just melted. Moisten and then squeeze out a towel (to avoid your opened Fillo dough from drying out). Open the Fillo dough and place on a clean counter top (or on plastic wrap), then place towel on top to cover.

Place one sheet of Fillo dough on a cutting board. Using a pastry or silicone brush, paint a light coat of the melted butter all over the sheet. Place two more Fillo sheets on top of the first sheet, and butter each after placing. Cut the combined three Fillo sheets into equal thirds lengthwise.

Spoon a little filling (a Tablespoon or two) on an angle at the end of each strip. Fold the pastry over to enclose the filling to form a triangle. Now take it upwards to form another triangle. Repeat this process until you reach the end. You will have a small strip at the end which you can grease with a little butter mixture and stick to the pastry. Brush the top lightly with



butter mixture.

At this point you can seal the pastries with plastic wrap and store in the refrigerator until ready to cook, or you can very tightly cover them with plastic wrap (or vacuum seal) and freeze them for later cooking (defrost at least 30 minutes before cooking). Better yet, cook them immediately per the following directions:

Grease baking sheet(s) and arrange the triangles on it with seam side down. Bake the triangles for 18-23 minutes or until the pastry is golden brown. Allow to cool for 10 minutes before serving. These may also be served at room temperature.



Each Stage of life presents us with changes and challenges; childhood, adolescence, adulthood, parenthood and senior citizen. When we are young children we are faced with learning many things, e.g. physical agility, language, the social system and relationships. As we get older we must adjust to siblings, school and other authority figures besides our parents.

Adolescence is a particularly difficult stage. In adolescence there are some life changes that are very confusing and emotionally trying; physical growth, sexuality, raging hormones, peer pressure and school grades.

This life change has many facets that may include personal health issues, death of a spouse or family member or friend, budget and financial adjustments.

All of the life stages can be difficult. It depends a lot on the support of family and others who are important in our lives at the time and the specific problems we are facing. It also depends on our own attitude and self esteem. If as a child we were encouraged to believe that we were a worthwhile person and had the opportunity to develop our strengths and improve on our weaknesses, than we have the tools to adjust to the emotional rollercoaster of growing up.

The same is true when we hit the snags of adulthood. Being a parent is another gargantuan task. At this stage we are truly tested. We need to remember what it was like for us when we were our child's age but still maintain the position of teacher, trainer and loving parent.



Like most hobbies, astro-photographers get better over time. Advances in equipment, new imaging techniques and sometimes just more patience all add up to better images. This month I'd like to share two images of the same object that I took, five years apart. The object that I chose to compare is the Whirlpool Galaxy.

Galaxies are large systems of interstellar matter and stars that come in many shapes. They typically range from a few thousand to several hundred thousand light-years in size and have masses between several million to several trillion times that of our sun.

Historically, galaxies have been categorized according to their visual shape. A common shape is the elliptical galaxy, which has an ellipse-shaped profile. Spiral galaxies are disk-shaped with curving, spiral arms. Galaxies with irregular or unusual shapes are known as peculiar galaxies, and typically result from disruption by the gravitational pull of neighboring galaxies. Small galaxies that lack a coherent structure could also be referred to as irregular galaxies. There are probably more than a hundred billion galaxies in the observable universe.

The Whirlpool Galaxy, also known as M51, is a spiral galaxy located at a distance of approximately 23 million light-years from Earth. It is one of the most famous galaxies in the sky and, under the right dark-sky conditions, can even be seen with binoculars. Spiral galaxies are disks with spiral arms that extend from the galactic bulge (large, tightly packed group of stars) in the center of the galaxy. The spiral arms are brighter than the surrounding disk because they are sites of ongoing young and hot burning star formations. Many scientists believe that there is a massive black hole in the center of these galaxies.

The image of the Whirlpool galaxy on the LEFT is one that I took in June of 2005. I had just recently started my astro-photography hobby. It was a single 10 minute exposure, which was a long exposure for me at the time, taken from our back yard in Pine Mountain Lake. I used a Canon Digital Rebel DSLR camera attached to my telescope and I hand guided the mount for the entire 10 minutes. It certainly looks like the Whirlpool Galaxy, but it lacks the color, contrast, and detail in the image of the Whirlpool Galaxy on the right. The image on the RIGHT was taken in March 2010. Five years had passed and I used that time to perfect my imaging skills. The image on the RIGHT was created from a series of 45 separate photographs taken from my observatory using a specialized camera used specifically for astrophotography. Each individual photograph was between 3 and 5 minutes of exposure time, 141 minutes in total. These individual photographs were then digitally stacked, one on top of another, to create the final image printed here.

Long exposures from today's digital camera sensors can capture light far too faint for our unaided eyes to see. One of the things that I really enjoy about imaging galaxies is how incredibly far they are located from us. The Whirlpool Galaxy is 23 million light-years from Earth. Light travels about 1 trillion miles in a year – so the Whirlpool Galaxy is about 23 million trillion miles away. Given its relative distance from the Earth, it's amazing to be looking at "light" that has taken 23 million years to reach our eyes – or in this case the camera sensor.

Newspaper print, like the PML Newsletter, doesn't have nearly the resolution or color range to show all the fine details in this image. Please visit my on-line astrophotography gallery at *www.GrovelandAstro.com* to view a higher resolution version of my many other astrophotography images.

While it may be difficult to completely appreciate the details in the differences between these two images in newspaper print – I can assure you the differences are extreme. Five years and several hundred hours of experience...see for yourself what a difference five years can make...


By the time this prints, Pine Cone Singers will have marched in the annual 49er Festival Parade as well as hopefully help elect our new Honorary Mayor – WOOF!



## OBITUARY

### **ROBERT FRANCIS STOFLE** August 29, 1917 - Sept. 3, 2011

Groveland resident Robert Francis Stofle died peacefully Saturday of natural causes at Meadow View Manor in Sonora. He was 94.

Born in Palisades, Colorado to George and Elva Stofle, the family

later moved to Oakland, CA in 1919, where his father worked as a mechanic for the Southern Pacific Railroad. Mr. Stofle graduated from Fremont High, where he met and later married Jeanette Arlene Paris of Oakland, CA in 1942.

Mr. Stofle served as a pilot in the Army Air Corps – Air Force during WWII and he received his flight training in Roswell, NM. He was assigned to

cargo flight missions based in Calcutta, India and flew C47 cargo planes over the Himalayan Mountains into China carrying gasoline fuel for the Flying Tigers air fighters who were fighting against the Japanese invasions in China. The flight path over the mountains was nicknamed the 'Aluminum Highway' because of the number of planes that crashed due to inclement weather conditions. Captain Robert F. Stofle flew over 3,000 hours, mostly instrument navigation during the flight missions, and was later put in charge of plane crash investigations. He ended his service duties as a Retired Reserve Major Officer in Oakland, CA.

Robert worked for Ballenger & Company as a West Coast salesman for hospital supplies for 10 years before he established his own manufacturing business, Professional Apparel Company, in Oakland, CA where he produced specially designed apparel for hospitals and patients in California. In 1960 he opened his first retail medical uniform store located on Broadway in Oakland. When he closed the apparel factory, the retail uniform store was expanded and moved into the Broadway/MacAr-

thur Shopping Mall, and a second retail store was opened in Pleasant Hill, CA in 1980.

The Stofle family enjoyed many summer vacations camping in Yosemite and planning family reunions with East Coast relatives at the Yosemite Lodge and Ahwahnee Hotel. They also loved traveling up the Oregon Coast with their motor coach along the **Olympic Coastline** and on up to Van-

couver and Victoria Island. Jeanette Stofle's ashes were scatted in Bandon, OR after her passing in 2002.

Mr. Stofle moved to Groveland with his daughter and son-in-law, Rebecca & Jim Novak in 2007. The Stofle-Novak family has enjoyed their shared homestead ranch home in Pine Mountain Lake, joined by their daughter, Jessica Novak, and two great grandchildren, Alexis Avelina Novak, and Ava Sophia Novak as a four generation family for the past four years. Mr. Stofle moved to Meadow View Manor in Sonora this year after his health conditions required more nursing care.

There will be a private memorial service with family members in Bandon, OR next month to scatter ashes, and to say the final farewells to both beloved parents, Bob & Jeanette Stofle.

- Did you contact the Contractors State License Board (CSLB) to check the status of the contractor's license? Contact the CSLB at 1-800-321-CSLB (2752) or visit their Web site: www.cslb.ca.gov.
- Did you get at least three local
   references from the contractors
   you are considering?
- Did you call them and see the work the contractor completed?

#### CHECK OUT THE CONTRACT

- Did you read and do you understand your contract?
- Does the 3-day right to cancel a contract apply to you?
- Does the contract tell you when work will start and end?
- Does the contract include a detailed description of the work to be done, the material to be used, and equipment to be installed? This description should include a plan and scale drawing showing the shape, size, dimensions and specifi cations. It should include brand names, model numbers, quantities and colors. Specific descriptions now will prevent disputes later.

- Are you required to pay a down payment? If you are, the down I payment should never be more than 10% of the contract price or \$1,000, whichever is less.
- Is there a schedule of payments? I If there is, you should pay only I as work is completed and not before.
- Did your contractor give you a "Notice to Owner," a warning notice describing liens and ways I to prevent them? Even if you pay your contractor, a lien can be placed on your home by I unpaid laborers, subcontractors, or material suppliers. A lien can result in you paying twice or, in I some cases, losing your home in a foreclosure. Also check the "Notice to Owner" for ways to protect I yourself.
- Did you know changes or additions | to your contract must all be in writing?
- Putting changes in writing reduces the possibility of a later dispute.
