# **General Manager's Message**

## **Radio Narrow Banding Project**

PML has owned and maintained radio towers and a license to operate radios on a wideband frequency for many years. This radio station is important to our association as it provides communications between Facilities Maintenance, Golf Maintenance, Department of Safety, and other departments.

The FCC mandated that all radio operators move to narrow band frequencies by January 2013. Last year we worked with two communications companies to come up with a plan and a cost estimate. I was not satisfied that we had enough information or solid proposal to allow the Board to make an informed decision. The cost of this mandated transition project is significant, and it is imperative that we have the right information so that we can keep our costs as low as possible.

I assigned the project to key staff and pushed this it to a high priority status. Sergeant Natalie Moffitt collected detailed data on all of our current equipment and we have narrowed down our requirements. We are finalizing the project timeline and the team is working on the RFP documents so that we can go out for quotes. Now that the Project Preliminary Report is finished, we can move towards improving our overall infrastructure and upgrading our equipment during the remaining months of the year.

## **Shooting Range Project**

Our staff met with the County to ensure that the permit applications for this project were submitted without any problems. We applied for the grading permit and onsite development permit. After another review, county planning sent us a letter informing us that in order to proceed with our project, we would have to rezone the property and file for a conditional use permit or file for a general plan amendment. Meeting either of these conditions would put our project behind, and over budget, with no guarantee of approval.

Director Gustafson is the Board liaison for this project and provided input and suggestions for a minimalist design alternative to our original project plan. The head planner confirmed that this option could resolve our issues as no permits would be required. Our Maintenance Manager, Tom Moffitt and a Shooting Club board member, Dick Collier worked on the design and met with the head planner to confirm it will be acceptable. We received formal approval from the County and our staff is proceeding with the project.

#### **Campground Improvements**

Our maintenance department is working on improvements to the PML Campgrounds. Camping sites have been cleaned up, trees trimmed, the soil graded, and the tables replaced. The weathered wooden tables have been replaced with permanent concrete tables. The concrete tables are more resistant to vandalism and theft and we currently use them at the Marina and near the Lake.

The campground restroom buildings are being renovated this year. The upper restroom/shower building was recently completed. We had a serious problem over the years with woodpeckers. The birds damaged the siding in many places, creating a deterioration of the plywood siding and trim. The siding is being replaced with a fiber reinforced cement board is resistant to woodpecker assaults, and will discourage the birds from attacking these buildings. With new siding, trim, paint, concreted pathways, and split rail fencing, the building has a fresh new look.

## **Roads Refurbishment Project**

Some members have asked when our roads project is set to begin. This year's project will include two years worth of roadwork and is tentatively scheduled for May. Once the engineer finishes the evaluation, he will update our pavement management plan and prepare the bid packages for the project. These bids will go out to pre-qualified contractors prior to the bid date. We anticipate spending around 1 million dollars on the project this year.

# **Campground Improvements**

New concrete tables have replaced the weathered wooden tables.



Two new horseshoe pits have been added to the recreation area of the group camping area.

The recreation season will be here soon, and there are several improvements being made at the Campground. Camping sites have been cleaned up, trees trimmed, the soil graded, and the tables replaced. The weathered wooden tables with steel frames have been replaced with permanent concrete tables.

These picnic tables are similar to the concrete tables we have at the Marina and Dunn Court. The tables will last many more years than the wood and steel tables, and will remain in place. The PML Maintenance Department handled the delivery and placement of the tables at the sites. Two semi-trailers were on site in March, direct from the manufacturer, for this delivery. The tables were craned off the trailers, and put in place with the roughterrain forklift.

Campground restroom buildings are being renovated this year. The upper restroom/ shower building has a face-lift. We have had a

serious problem over the years with woodpecker problems. The birds have damaged the siding in many places, creating a deterioration of the plywood siding and trim. To remedy this destruction, the buildings are being sided with shiplap coursing of Hardiplank siding. The fiber reinforced cement board is resistant to woodpecker assaults, and will discourage the birds from attacking these buildings. With shiplap siding, new trim, paint, concreted pathways, and split rail fencing, the building has a fresh new look.

Additional improvements are under way at the Campground. The group camping area, in the middle of the lower Campground section, has added recreations. Besides the sand volleyball court, there are now two horseshoe pits. Plans for more recreation uses are being considered for placement in this common area.

In conjunction with the Trails Project, an annex of parking and trails access is being constructed at the lower Campground entrance. The access road from the upper restroom building to the trailhead has been improved. Signs are posted to direct visitors to the trailhead annex.

The hiking trails have picnic sites available for day use only. Some of the tables from the Campground have been placed at these sites along the trails. The picnic sites are displayed on the sign mounted to the trailhead kiosk at the trailhead. The picnic sites range from a shaded site, to sites with panoramic views. Hiking trails are moderate to strenuous, wear adequate footwear, and always carry water. Keep in mind, this area is habitat for local wildlife, be attentive to these wild creatures. Warnings will be posted on the Campground signboards, and at the trail kiosk.

The Pine Mountain Lake Recreation area is available for use year-round, and be aware that conditions may change. Weather and fire danger may demand the area to be closed to use.

# Shades of Green

"Spahn and Sain and pray for rain" is exactly what we need, two good days followed by two days of rain. Remember that last March and April it was so wet that #11 was unplayable at times, did we think the following spring we would be asking for more rain and snow? What a difference a year makes. The good news is that as I write this, it is still winter and maybe spring will be good to us.

Now April is here. What is harder to do, pay Uncle Sam or to have to putt on those sanded greens? Yes, it is time to aerate all areas of the course, finishing with the greens on the 23rd and 24th of April. Our fall greens aeration is scheduled for September 24th and 25th. In July we will do a light aeration and we will not close the course for that. Those dates are July 9th and 10th. We appreciate your patience while performing these tasks and do all we can to avoid disrupting your game. Our annual soil tests are calling for over thirteen tons of gypsum to be applied to the fairways this year; we will do that right after we aerate the fairways.

Other projects we continue to work on are tree trimming, improving bunker edges and drainage improvements. Recently we leveled areas on #3 and #17 tees in hopes of reducing the amount of had on out to the course and play a

that had settled out over the years. Speaking of settling out, there are various locations around the course where the soil around the main irrigation line is sinking, due to the dry conditions.

Have you seen that the coyotes are back on the course? They don't bite or eat very much, but, for the last ten days or so they have been keeping the geese away from #8 & #9 fairways. These decoys are hard at work and seem to be assisting in keeping the geese out of the area. From previous experience, we will need to relocate these decoys with some frequency. The suggestion to try them again came from our waterfowl committee that will be trying various methods to keep the geese away from different locations around P.M.L. The geese have too many places to go in our area, and that it makes it difficult to try one method to be successful to persuade them to move on.

One of the battles we fight each spring is the seed head that is produced by the poa annua, which is an annual blue grass that is part of our putting surfaces. Having the bent grass and poa share the same surface is demanding at times to manage, due to their different needs. We do use a plant growth regulator you, and if so, bring the savings you

Our enhanced Fire Safety enforcement under Resolution #95.04 has been in force since 2009. We have been inspecting every Lot in the month of June each year. If members hadn't complied during our first inspection we sent a Courtesy Notice that July 1 is the deadline. On July 15 we re-inspected and those Lots still not in compliance were fined \$500 and we hired a crew to bring these Lots into compliance and added these amounts to the member's account.

We have made great strides over these last three years and our hats are off to our members for your cooperation and support.

We now feel we can go to a new level. No longer will we be inspecting member's Lots in June. We feel members are now aware of what needs to be done and they have this annual job set up to be completed by July 1 every year. Some members hire vendors to perform this work and others do this work themselves and also, this year members have another option... our new AutoCleanup Program. Members who choose to participate will have PMLA arrange to have their Lot cleaned from a pool of approved vendors according to our standards, and have this amount added to the member's account.

We will be inspecting all Lots starting July 1. Those who are not in compliance will receive a Notice of Non-Compliance and a 15 day notice before a fine is levied and we hire a Preferred Vendor to perform the work. The cost to perform the work and the \$500 fine will be turned over to the Covenants Committee for hearings and decision making.

This process is, in fact, how the Resolution was written back in 2009. We now feel everyone is sufficiently educated and we can return to the original intent of the Resolution.

Remember, nothing has changed as far as our Fire Safety requirements. Please be ready for our annual Fire Safety inspections which start on July 1, 2012.

**Lesson Corner – Stop Putting Around!** On average all of us spend 40-50% of our strokes on putting. Do you spend 40-50% of your practice time on the putting green? While it's fun to beat balls at the Practice Facility we should all spend more time working with the "flat stick". Here are some keys to making your practice and your rounds more enjoyable and spending less of those strokes on 3 and 4 putts:

**Eyes above the ball** - Avoid having your eyes in front of the ball or beyond the ball. Try holding your putter with two fingers from the grip end a few inches below the eye and what you want to see is the putter head dangling directly above the ball.

**Every Putt is a Straight Putt** – most of the work in putting is done before we stroke our putts. First you line up the putt, figure out speed and direction and then we address the ball and make our stroke(s). Avoid trying to help the putt break left and/or right. Once you pick your line; think about only hitting a straight putt on that line and let the slope and grain do the work.

40 – 60 Rule – One of the biggest culprits of missing putts is deceleration. Try taking the putter back 40% and then accelerate through the ball to 60%. In other words; if you take the putter back 4-inches,

accelerate through to 6-inches past where the ball was.

"No Peeky Rule" – This is my favorite. This drill will help keep you from decelerating. Once you've lined up your putt and have addressed the ball. Take your back swing/stroke (40%) then as you start your forward stroke; rotate your head back away from the target. In other words, look away from the target and your ball as you make contact. This drill helps eliminate the pulls, pushes, and coming up short on your putts associated with decelerating.

Try these tips on the practice green and get that "flat stick" working for you instead of against you.

# On the Lake: PLANTS VS. WEEDS... NOT ON MY PROP!

When talking to folks about the plants that grow in and around our lake, I've rudely interrupted the conversation more than once to point out the difference between plants and "weeds." So, what is the difference? To a lot of people, I think the main criterion is: "if it's on my propeller, it's a WEED." Or perhaps if it blocks your view of the lake, gets tangled on your feet, or eats your favorite fishing lure. The truth is, we really don't have a weed problem in Pine Mountain Lake. The aquatic vegetation (plants) that grows in the lake, serves a very useful life function for the lake. It comes in three broad categories; submersed aquatic vegetation (SAV), floating, and emergent.

The SAV that is most prevalent on our lake is Elodea. As the category suggests, it usually stays below the surface. It is quite common in 10-15 feet of water in the coves. It does have a wicked stepsister, Hydrilla, which so far, we don't have in the lake. For the floating category, we have pondweed. That's right! Even the common name sometimes incorrectly calls a very beneficial plant a WEED. You will recognize this one from the floating, lance-like or elliptical, reddish-green leaves that float on the surface (or wrap around your prop). The last category is the emergent vegetation. These are the tall cattails and tules (too-leez) that grow near the shore. All serve a very useful function in maintaining a healthy lake.

Wherever these plants grow, if you look closely (put on a snorkel for a really good look), you'll see an amazing variety of critters from bugs and snails to fish of all sizes. In the emergent vegetation, you'll find bird nests and more great habitat for fish, especially the little ones that don't want to become dinner. And it's not just the value as habitat that the plants provide. The cattails and tules (aka bulrush) help stabilize the shoreline and prevent erosion. They also break the action of waves. They are so much better for the health of the lake than seawalls which merely reflect waves back into the water. I'll save my seawall talk for another day... maybe after I hire a bodyguard.

Perhaps the greatest benefit that these plants provide is on water quality. They soak up nutrients that would other wise be available to the algae that grow in the lake. The algae, or plankton (specifically phytoplankton), are microscopic plants that float in the water column. If you have too much algae, you can end up with green, gooey looking water with scum on the surface and some very unpleasant smells. In lakes without a lot of aquatic vegetation, algae become the main beneficiary of all the nutrients that are in the water. That results in water that isn't very clear and often ends up with recurrent "blooms" of algae that can cover large areas or even the entire surface.

So, although they might restrict your view a little, or slow your prop, they are doing a valuable service by keeping the water more clear, protecting shoreline, and providing valuable habitat.

FACT: Once established in a lake, Hydrilla can quickly spread and cover the entire surface of the water wherever the depth is less than 20 feet. Most coves in PML would be inaccessible. INSPECT YOUR BOATS! Hydrilla has already invaded Calaveras and Mariposa counties.

# We Are What We Eat!!

In the past few years there have been a lot of 'new' catch phrases in the Food Industry, and these can lead to some confusion. What is '**sustainable**', a

'**localvore**' or the even the oldest '**organic**'. In the media these days these words are tossed around with ease but very little explanation, so let me attempt to make these words a little friendlier.

The most common phrase as of late seems to be 'sustainability', simple enough sounding. Sustainable food production takes into consideration a lot of history and science, the history is remembering things like the Dust Bowl in the '30s and the causes. And the science entails enhancing the environment around the Farm; proper soil building can help the farmers achieve almost the same yields as heavily fertilized fields. Over fertilization causes many problems, from selenium build up in ground water to algae blooms in the Gulf of Mexico. In the Gulf, this has devastating effects on, specifically, the shrimp population. The algae blooms consume vast amounts of dissolved oxygen in the water, causing unlucky critters, in this case the shrimp, to suffocate. In a sustainable situation, the food producers try to impact the fields with as little chemical additives as possible and a much more aggressive soil conservation plan. Better soil means fewer pollutants in the soil, water and air... It's all connected.

When I was young, I remember 'pen raised, corn fed beef' was touted as the 'most flavorful, most tender cuts available', and now all you hear about is 'open range grass fed', why? It's easy, cows eat grass! Before man intervened in the Bovine world, modern cows' ancestors wandered grasslands and plains, foraging on the grasses and plants available. At the time, not a stalk of corn in sight! We took advantage of the cows 'want' to herd, then we fenced them in and finally with the introduction of cheap feed corn, a new animal was born. The modern cow has a lot of maintenance involved, pens need to be cleaned, twice daily feedings, etc. But the American Farmer

is smarter than that! He realized that a cow in a large pasture has a source of free/inexpensive food (i.e. grass), exercise proved beneficial, and no pens to clean. What resulted from stepping back in time a bit was a healthier, tastier cut of beef, with little or no antibiotics, free fertilizer for the free food, less labor and sustainable food production. When we as humans stray away from what mother nature provide, we are left with an inferior product.

The most misunderstood word of all is 'Organic'. Certified Organic means that the produce or animals were raised in a natural, sustainable, chemical free and environmentally friendly way. If you frequent some of the local Farmers Markets (which I encourage you to do) you will see 'certified organic growers' and 'certified producers', the difference being that a producer can only sell items that he grows himself, whereas 'Certified Organic' indicates that this guy has grown at least 3 years without the use of chemicals (pesticides or fertilizers) and completed the rigorous government program to prove it. Most 'Certified Producers' are on that path and produce a mostly if not all organic product already. One of the benefits to locally produced vegetables and meats are 'trace elements'. The FDA only test for certain items, we see those on the nutrition labels, but organically or naturally grown produce is shown to have significantly higher trace elements such as Folic acid, Potassium and Zinc, to name just a few. The term 'Localvore' describes individuals who try to get all their food from local, usually within a 60 mile radius, to get the freshest and healthiest foods possible. Living in California with the worlds' Salad Bowl at our feet we are able to enjoy the 'localvore' lifestyle with ease. Please take advantage of our local Farmers Markets, I know I do and look forward to the weekly trip.

In 1879, with only fifty dollars in his pocket, Giacomo Peirano, a grape farmer from Genoa, Italy, immigrated to San Francisco, CA, in the hopes of fulfilling the American dream of striking it rich with gold during the historic Gold Rush age. Soon realizing the days of really collecting a big share were no longer in sight, he decided to take whatever he had left of his fifty dollars and moved to Lodi, CA.

In 1992, Lance Randolph, the fourth generation of Peirano to farm the 300 acre estate, began making Peirano wine simply for himself and to prove Lodi could produce desirable wines. After considerable praise for his ability to make elegant wines, he decided to start bottling and selling Peirano wine using his estate grown grapes. Since then, Peirano has won numerous awards for producing top of the line wine using many of the old techniques valued by Giacomo Peirano.






The following Board resolution is an amendment to Resolution # 95.04.

## FIRE SAFETY PLAN POLICY AND PROCEDURES.

The purpose of the amendment is to make an adjustment in the inspection process and policies. This serves as notice to all members that the amendment was adopted by the Board of Directors on March 17, 2012 at a duly noticed monthly meeting.

The main effect and change in this draft is a reduction in the number of letters sent to members, fire safety inspections and the addition of burn pile regulations. The draft was discussed at the February 18, 2012 monthly Board meeting and published for member review and comment.

THEREFORE BE IT RESOLVED that the Board of Directors does hereby approve and adopt the fire Safety Plan developed by Robert Irwin and William H. Bowman to reduce or eliminate the wildland fire potentials, the attached policy entitled "Fire Abatement Notice and Enforcement Standards and Procedures".

BE IT FURTHER RESOLVED, that the annual deadline for property owner fire safety compliance is July 1.

## FIRE ABATEMENT NOTICE TO HOMEOWNERS

California's wildfire history over the last several years has caused those residents who live in rural areas to understand the need to do fuel reduction work prior to each fire season. Pine Mountain Lake is clearly one of those communities at risk for major loss. That is why volunteers and staff have developed a Community Wildfire Protection Plan. It is a strategy for PML that articulates what we need to do to reduce the threat, and helps us focus on specific tasks. As an example, our Board of Directors has taken aggressive measures to reduce fuels in our greenbelt areas.

Similarly, our staff and Board of Directors have reviewed the status of fuel reduction work done by property owners on privately owned lots. Thankfully, there are hundreds of property owners who do a stellar job of reducing fuel loads and maintaining their properties. Unfortunately, there are hundreds of lots that are not fire safe. This has resulted in a decision to strengthen our enforcement policies and procedures.

Please read the attached PMLA FIRE ABATEMENT STANDARDS, INSPECTION SCHEDULE AND FINE POLICY. It provides:

- Reference to sources for fuel reduction standards

- Revised inspection schedule

- List of actions for those properties found not in compliance

Also, be aware that Cal-Fire is empowered to inspect PML properties and levy fines for non-compliance.

You are welcome to contract with a private firm or to perform the work yourself. However, if you wish to obtain a bid from the company that will be providing fire abatement services to Pine Mountain Lake Association on common areas, as well as many of the owners of developed and undeveloped lots, please contact the PML administration. And if you would like assistance in deciding what action needs to be taken on your property, contact the PML Fire Safety Coordinator. He can help you develop an "Individual Fire Abatement Plan" that not only brings your lot into compliance with standards, but also provides a park like setting for your property, as well as improving the health our forest.

Thank you in advance for your cooperation. Only as a community taking action together can we reduce the threat of wildfire.

## Fire Abatement Enforcement Standards And Procedures

## STANDARDS:

- For a complete picture of legal statutes, PMLA policy, and fire abatement best practices, property owners should refer to the following documents:

  - b. PML "Community Wildfire Protection Plan", August 2008, PMLA

  - d. "Living with Fire in Pine Mountain Lake". A Fire Abatement Guide for the Property Owner. Fire Safe Council, Highway 108 (revised 2010)
  - e. PMLA Burn Pile Standards
- 2. Pine Mountain Lake Fire Safety Plan, December 1994, Robert L Irwin and William H. Bowman

## INSPECTION SCHEDULE AND FINE PROCESS

- 1. All properties must be in compliance with fire abatement standards on July 1 of each year.
- 2. PML staff will conduct inspections of private property starting July 1 of each year.
- 3. Those properties found not in compliance will be sent non-compliance letters, stating necessary changes.
- 4. Property owners will have 15 days from the date of the letter to remedy non-compliance issues called out in the letter.

5. PML staff will conduct a follow-up inspection for those properties notified as not in compliance. PMLA will take the following action for those properties found to have uncorrected deficiencies:

- a. "Final Notice Letter" sent to property owner.
- b. Property owners will have 15 days to request a hearing regarding these actions
- c. Property owner fined \$500 as a charge to the property owner's member account.
- d. The property will be immediately abated by the company providing fire abatement services to Pine Mountain Lake Association, with the cost of the fire abatement services being charged to the property owner's member account.
- e. The property will be scheduled for abatement the following year by the company providing fire abatement services to Pine Mountain Lake Association, with the cost of the fire abatement services being charged to the property owner's member account.

Authority: special individual assessment, as set forth in Article IV, Section 4 (a) (iii) of the First Restated Declaration of Restrictions). A special individual assessment shall be a continuing lien upon the property against which each such assessment is made per PMLA CC&Rs, Article IV, Section 4 (a) (iii) in accordance with the members right to notice and hearing pursuant to Article XIV, Section 6.

# PMLA Burn Pile Standards

November 1 – May 31 (burn season)

- Maximum pile size is 4' x 4' x 4'
- A ready water source available
- Attendance by an Adult until fire is out
- 10' Diameter clearance from vegetation or flammables
- PML burn permit required by property Owner and any other required permits.

June 1 – October 31 (no burn season)

- Disposal at the compost dump is required for all brush, limbs, leaves/needles
- A cut and stack (burn pile) for future burning must be authorized by PML Fire Safety Coordinator
- Conditions at the time will dictate the criteria for authorization to maintain a burn pile for future burning

Einar is a lifelong glider pilot, former jet fighter pilot in the USAF, and exchange officer with the Royal Air Force where he attended the Empire Test Pilot's School in Farnborough, England. In 1992, Einar first envisioned the Perlan Project when an image of a stratospheric mountain wave, at 75,000 feet above Northern Scandinavia, was first shown in Germany. Einar believed that such mountain waves could be used to fly a sailplane to astonishing heights. Einar and Steve Fossett proved this concept when they set a world record altitude for gliders of 50,671 feet on August 30, 2006.

Our aviation community celebrated with Danielle Coelho on the occasion of her first solo. Her instructor, Larry Jobe, climbed out of the plane and sent her alone into the skies on February 28th. Danielle reported it was much quieter, lighter, and more pleasant in the cockpit and she was surprised at how much better the plane performed. She and her instructor were greeted by an enthusiastic and congratulatory crowd upon Danielle's safe and successful solo flight.

Now for another rules quiz, prompted by bad advice I've been given on the course. You tee off on number 14. Your tee shot is a little long, a little left, and ends up on the 15th tee. When you get to your ball, you find that the wooden tee sign is between you and the hole. Your ball is far enough from the sign that it won't interfere with either your stance or your swing, but it is definitely in your way. What are your options?

The sign, being artificial, is an obstruction. Since it cannot be moved without undue effort, it is an immovable obstruction. Rule 24-2 states that interference from an immovable obstruction happens when your ball lies in or on the obstruction, or when the obstruction interferes with your ability to take your stance or make your swing. The rule specifically states that intervention on your line of play is not interference according to this rule. In other words, you have to play the ball as it lies or declare it unplayable, and follow the procedure for that rule.

Until next month, put your drives in the fairway, your putts in the hole and have fun out there.

# **Helping Hands Building**

INTERVIEW BY PATTI BEAULIEU WITH LEONARD CASSARETTO, BUILDING OWNER

In case you are asked, or were wondering, here is some history on our current Thrift Store location. The building is owned by Leonard Cassaretto and was previously owned by his grandparents and parents. It was built c.1850 and its original use was as a store/trading post. Its' historical name of record is Raboul's Trading Post. In 1873 Casimer Raboul sold the property to Michael Noziglia for \$500 in gold coin. Noziglia's wife transferred the property to Luigi Cassaretto (Leonard's grandfather, who was in Italy) in 1873 and it has been in the Cassaretto family since then. It then became the Cassaretto Market and run by the family. Leonard's father was one of 9 children born in the family living quarters, above the store, which is now our attic. Then they built the house next door. The closed off door on the west side of our building was so they could go between 'work and home'. It was always a market, trading post or

stage stop. In the 1930's the Cassaretto family began renting it to different people for their businesses. It was Pigg's Market, Ken's Market, and then Tiano's Market for many years, with next door being Tiano's Coffee Shop. It has gone through several remodels to become what it is today. What is now the 'Green Room' was the walk in freezer and meat locker. The back room and kitchen were storage and, at one time, the wall between us and the Cocina was open and the only entrance to the Tiano Coffee Shop. After Tiano's Market left, it was closed off from next door and became several businesses, including a gift shop named "Class with Sass'. Two iron doors (that are still laying out back) were removed to install the windows we now have in front. We occupied the building in the mid 90's, and hopefully have found our permanent home.

Thank you to Leonard Cassaretto for this interesting information.

# **RECIPE OF THE MONTH**

# Salsa Verde

RECIPE PROVIDED BY TOM KNOTH AND PAULA MARTELL OF "TWO LITTLE PIGS BBQ CATERING"

Salsa Verde or "green sauce" can range in spiciness from mild to mouth-searing. It may be served warm, as in a "Chile Verde", or cold, as a condiment. In Mexican cuisine, salsa verde is frequently used as a dip for tortilla chips, or served with tacos or enchiladas. It compliments pork, beef, poultry, and fish; and it's also great on eggs.

You can sample a great salsa verde at Cocina Michoacana in Groveland or you can make your own with this recipe:

#### **INGREDIENTS**

1/2 lb Tomatillos 1/4 Cup White Onion 1 clove Garlic 2 Chipotle Chiles (from a can of chipotle chiles in adobo) or 2 fresh Serrano chiles (remove the seeds for a milder salsa) 1/4 cup fresh Cilantro, with stems 1 tsp Lime Juice

1/4 tsp Cumin 1/2 tsp Salt 1/2-1 cup Chicken Broth 1 tbsp. Vegetable oil

#### DIRECTIONS

Remove papery husks from tomatillos and rinse well. You can cook the tomatillos by either a roasting or boiling method; we prefer roasted. Roasting method: Cut in half and place cut side down on a foil-lined baking sheet. Place under a broiler for about 5-7 minutes to lightly blacken the skin. Boiling method: Place tomatillos in a sauce pan, cover with water. Bring to a boil and simmer for 5 minutes. Remove tomatillos with a slotted spoon.

Place tomatillos, onion, garlic, chile, cilantro, lime, cumin, salt and chicken broth in a blender and blend until desired consistency is reached (in Mexico, Salsa Verde is thin and smooth, not chunky).



The salsa can be eaten at this point, or it can be cooked. Cooking the salsa gives it a different flavor and color. Try cooking half the batch and see which you like better.

To cook: Heat oil over medium heat and then add the salsa. Cook for 15-20 minutes, until salsa thickens slightly and turns a different shade of green.

If using this salsa for enchiladas, add a bit more chicken broth to make the salsa juicier. The extra juice gets absorbed by the tortillas and creates a moist enchilada.

### **Domestic Violence**

Domestic violence is recognized globally as a critical public health problem and a human rights violation that robs victims of "full and equal participation in all spheres of life." According to surveys from around the world, 10% to 50% of women report having been physically harmed or hit by an intimate male partner. Intimate partner violence is the major reason for injury to women in the United States. Women and children are especially vulnerable to violence from family or other household members. However, no one is immune as it affects. both men and women and occurs in all forms of intimate relationships regardless of sexual orientation and includes all races, ethnicities, socioeconomic backgrounds and levels of education.

Unlike street violence, DV occurs in the context of shared lives in which the victim and the perpetrator share, or once shared, a residence, financial obligations and resources, children, or friends. DV is often taken less seriously than from a stranger or street violence because it is considered a "family concern."

The primary victims of DV are women, aged 16 to 24 years old are considered most at risk, although older women have been victims but often do not report it.

In nearly 50 population-based surveys from around the world, 10% to over 50% of women report having been physically harmed or hit by an intimate male partner. Intimate partner violence is the major reason for injury to women in the United States. From the findings from the National Violence Against Women Survey, researchers estimated that approximately 1.3 million women are physically assaulted annually by an intimate partner or expartner. Findings also from this survey reported that 200,000 women are raped each year in the United States by a partner or ex-partner.


Female violence against male partners is less frequent and is generally not reported. Physical injury of men is no less acceptable and should not be overlooked any more than same gender abuse. Although the majority of DV is by men against women, same gender partners are also targets.

Domestic violence is defined as physical, sexual or emotional/psychological abuse directed toward partners in current or past familial or intimate relations. This also includes violence directed toward dating partners. Typically, DV does not involve a single violent assault, but rather is a progressive process increasing in intensity to control one's partner. Physical violence is almost always accompanied by psychological and emotional abuse. Common features include keeping the victim isolated, lack of privacy, patriarchal attitude, rigid gender stereotypes, acceptance of aggression, intimidation and economic hardship.

Victims are often not allowed to stay in contact with their families or friends. They are required to stay in the home, not work or have any money of their own. The physical abuse can start with a push or a slap and can intensify to punches and beatings and sometimes rape. In many cases the victim is too fearful or ashamed to tell anyone. Their comments often are: "It was my fault I shouldn't have said or done what I did that made him mad." Another typical comment is, "I can't leave because I have nowhere else to go and I really love him." The worst possible consequence of domestic violence is death. According to the Bureau of Justice Statistics Crime Data Brief (2003), on average more than three women are murdered by their husbands or boyfriends in this country every day.

#### Some questions you may want to ask vourself:

- Does your partner consistently control vour actions?
- Can you leave the house, go shopping, or visit with family and friends

whenever you want?

- Do you have access to money or your records?
- Does your partner make you do things you don't want to do?
- Has your partner hurt you physically purposefully?
- Does your partner belittle or humiliate vou?
- Do you feel responsible for your mistreatment?
- Has your self esteem been destroyed?
- Do your fear for your safety or that of your children?

• Have you hidden your fears from everyone?

If you have answered "yes" to any of these questions you might consider talking to someone, perhaps your religious leader, your parent or a counselor. There are local agencies that want to help victims of Domestic Violence, like Tuolumne County Behavioral Health, Mountain Women's Resource Center and Center for a Non Violent Community. There are also private counselors who are trained in preventing and treating victims of Domestic Violence. REMEMBER: No one has the right to abuse another person.

### **Photographing the Nighttime Sky**

Many of the images from the articles that I write in the Pine Mountain Lake Newsletter are taken with the aid of an array of telescopes, telescope mounts, and cameras-but anyone can take beautiful pictures of the evening sky with just about any camera. One thing that I like to do is to take photographs of the evening sky shortly after the sun sets. Often I will include some terrestrial reference like a tree line or the horizon in the same photograph. This terrestrial reference can give night sky objects more perspective.

Taking a photograph after sunset requires some special considerations. First of all, in order to collect enough light, the exposure time will be greater than day-time photographs. Longer exposure times require a very steady camera so the image doesn't come out blurry. The best way to accomplish this is by using a tripod. If a tripod isn't available, try setting your

camera on a steady location, like a wall or chair, and use the "countdown timer" feature for your camera shutter. Using the countdown timer on your camera will also minimize the shaking that would normally occur when you press down on the shutter button.

Another challenge when taking photographs in low light conditions is camera focus. The auto-focus feature on your camera requires a minimum level of light to operate properly. One trick that I usually use is to focus on a distant bright object so the camera can focus, and then use that focus setting when taking photographs of dim objects that are a similar distance away.

Another fun thing that I like to do in the early evening is to look towards the west and see what bright sky objects are visible. Then I try and fit as many of these objects in the same photograph as possible. Often various bright objects will be close together, or aligned in a way that will make the photograph more interesting than if you just zoomed in on each object individually. Start by looking at the sky just after sunset. As the sky darkens, look for bright objects. Often the brightest "stars" in the sky aren't stars at all, but planets. Naked eye visible planets (that don't require the use of a telescope or binoculars) include Mercury, Venus, Mars, Saturn, and Jupiter. The Sun, moon, and naked eye visible planets all travel approximately the same ecliptic path in the sky from our point of view on Earth. Because our solar system is almost flat



it forms a plane. This plane is called the ecliptic of our solar system. Take notice of the path that the sun and moon travel in the sky, and look for naked eye visible planets traveling along the same ecliptic path. Many web sites are available to help you identify what's good to look for in the evening sky. Many of these web sites even include what bright objects will appear close together. One web site that I like to use is www.SkyAndTelescope.com.

I took the photograph that's printed in this newsletter on February 25, 2012 from a high point in Big Oak Flat overlooking the Priest grade. I used a DSLR digital camera mounted on a tripod. The exposure time was 15 seconds. You can easily see the valley lights in the horizon and low cloud formations. The long exposure time helps to highlight these features. This image shows an interesting alignment of two planets and the moon taken about an hour after the sun set. In the upper left is the planet Jupiter. Jupiter is the fifth planet from the Sun and is the largest one in our solar system. If Jupiter were hollow, more than one thousand Earths could fit inside. The brightest object in the photograph is the moon. Just below and to the left of the moon is the planet Venus. Venus is the second planet from our Sun and is often mistaken as the brightest "star" in the sky. Venus is an "inner planet" - this means that Venus is closer to the sun than our planet. Because it's an inner planet, Venus is only visible a few hours before or after the sun rises or sets. This is why Venus is also called the "morning star"

and the "evening star" So next time you look up at the early nighttime sky and recite "star light, star bright, first star I see tonight ... " - just remember that first "star" probably isn't a star at all, but rather a bright planet like Venus or Jupiter. I've added labels to this photograph so you can easily identify the location of the moon and planets. The resolution of a newspaper print photograph can make it difficult to see details as faint as a single "star" (or in this case a planet), but with the labels you can see where they are in the photograph.

The position of the planets varies from month to month. During the month of April 2012, Venus and Jupiter will be visible as you look towards the west after the sun sets and the sky starts to darken. Mars is also visible high in the sky and Saturn will be visible as it rises in the east. Mercury will not be visible in April because it will have already set

in the west by the time the sky darkens.

### From Your Tuolumne County District Supervisor

JOHN GRAY, TUOLUMNE COUNTY 4TH DISTRICT SUPERVISOR

As I prepare this article, we find ourselves getting a little relief from the dry winter season with spring-like rains and a bit of snowfall. We all hope that this will contribute to more abundant water storage and help to avoid water shortages over the warmer months ahead.

The Board of Supervisors has established a number of goals for 2012 and we are well on our way in accomplishing them.

One of the Board of Supervisor adopted goals for 2012 was to revise the County Code Compliance Ordinance. It has been my opinion that the Code Compliance Ordinance adopt in 2005 was not "user friendly". Frustration with the procedure was expressed by County Staff, complaining property owners and the community at large.

The cumbersome 2005 ordinance was punitive in nature. The goal of any code compliance regulation should be to gain compliance, not create more difficulty.

I am happy to say that at the March 6th Board Meeting, we passed a new Code Compliance Ordinance.

The new revised ordinance has two primary goals. (1) To protect the health and safety of Tuolumne County residents and visitors, and; (2) to gain compliance with the County Ordinance Code. As a secondary goal, the new ordinance aims to provide quick resolution on the determination of violations to provide closure for property owners, complainants and the County.

To address enforcement frustration, the key features of the ordinance cover:

Failure to prosecute : Except for violations impacting health and safety, where in the event the County has no record of the violation a final administrative order must be satisfied. If this is not done within 2 years of the date the code compliance case was opened, the case shall be deemed closed and the County will not re-open or re-file the case under the provisions of the Code Compliance Ordinance.

Statute of Limitation; Violations which have been in existence for 5 years prior to the date of discovery by the County are not subject to the Code Compliance Ordinance. However, all allegations of non-permit violations will be referred to the County Assessor's Office for potential reassessment.

The new Code Compliance Ordinance makes it clear that the prosecution of a violation is up to the discretion of the County. Given the limited resources available at this time, physical abatement of violations will likely be limited to the most serious in regard to health and safety issues.

In cases where the violation is nor corrected and do not impact health and safety, the County will consider the case "closed" upon the recording of the Final Abatement Order.

Should the property owner/responsible persons desire to seek any entitlements from the County; those recorded violations will have to be resolved. It is unlikely that a property with a Final Abatement order against it would be transferred with a new mortgage. Under health and safety, resolution of the code compliance would be part of any transfer.

I know that I have gone into a considerable amount of detail on this topic and I hope that I have not confused anyone but for further information you may refer to the County Web page for the Ordinance in its entirety. The County has struggled for years to gain Code Compliance. As a County Supervisor, I field many complaints concerning property violations. This new ordinance should help to resolve many of those long-standing problems.

On the State Level, It's "Business as Usual... Let's Make Deal". In an effort to provide constitutional protection for the Governor's public safety realignment (AB109-early release from state prison for less violent offenders) there is a new proposal which would lower the proposed sales tax increase from 1/2 cent to 1/4 cent for us all. Then, there would be an adjustment for the two upper income brackets from 1.5% to a 2% increase-for those earners or joint filers with combined incomes of \$600,000, or more. There would be an increase from 2% to 3% for those joint filers whose combined incomes exceed \$1,000,000. The bracket for joint filers earning up to \$500,000 will remain at a 1% increase.

According to an independent legislative analyst, even with these changes that include cuts to the arts, education and other important programs, there will still be a \$2.5 billion dollar shortfall under the Governor's new proposed plan. The tax increase may go a long way towards balancing the budget but it still will not make up the entire deficit.

Recently, I read an article that during Governor Brown's first governorship personal income tax generated about 1/3rd of the state revenue but since that time, personal income taxes have become the dominant source of state income. I have to ask myself the question "Could the continued increase in the state income tax cause some major financial fallout?" It certainly hasn't fixed anything so far.

I'm not an economist, but it seems to me that planning a budget based on the assumption that a handful of higher income Californians will continue to do well in stocks and other speculative investments will be the answer to solving the State's financial difficulties..

Maybe a better fix to solve our problems would be to make California as business friendly as possible. We have had enough companies leave the State to relocate in non-or lower income tax states to build their businesses.

If you have a solution let me know and I will pass it on to the Governor.

In closing, we have made tremendous strides to improve our local government over the past three years. I look forward to continuing this challenge.

# Nearby Genealogical Research Libraries

In February, several participants in the monthly Genealogy Workshops made a "road trip" to the new Family History Library at the Church of the Latter Day Saints on Old Highway 120. There were three LDS members there to greet us and they were well prepared with handouts, one-on-one assistance, cookies and punch. It's a beautiful facility with 2 desktop and 3 laptop computers. They offer high speed connection to the Internet, access to the FHL portal and have several genealogy site subscriptions (ancestry, fold3 (formerly footnote), heritagequest, etc.) Anyone is welcome

to use this wonderful facility; it's open and staffed Wednesday evenings 6:30 - 8:30 and Sunday 1:00- 3:00.

Another LDS Family History Center is located at 19481 Hillsdale Drive in Sonora. Their resources include a large reference library; inter-library loan from the Family History Library in Salt Lake City, Utah; computers linked to numerous subscription databases; a microfilm library; microfilm and microfiche readers. They're hours are Tuesday-Thursday, 10am-4pm and 6:30pm-9pm (closed first Thursday evening of each month).

The Tuolumne County Genealogical

Society Library at 158 W. Bradford in Sonora is another research library you'll want to check out. The library contains local records as well as over 1000 books on all states and some foreign countries, miscellaneous microfiche, family histories, school yearbooks and a collection of exchange and donated periodicals from most states and some foreign countries. They also have access to World *Ancestry.com*. They're open Tuesday and Thursday from 10:00 - 4:00 and Saturday 10:00- 3:30.

You certainly don't want to overlook the Tuolumne County Library System. The main library at 480 Greenley Rd. in Sonora has a small genealogy section plus microfilm and fiche readers. One of their greatest assets to genealogists is their ability to borrow books and microfilmed records from the Sutro Library in San Francisco. If you're not familiar with the Sutro Library, it has the most extensive genealogy collection west of Salt Lake City as well as a comprehensive U.S. local history collection. The Count library also offer us in-home access to Heritage Quest Online, a comprehensive treasury of American genealogical sources. It's accessible through the library's web site: *http://www.library.co.tuolumne. ca.us/#focus.* 

If you're interested in researching your family and would like help getting started or have already done research and would like to meet people who share your interest, please come to our monthly workshops held in the downstairs meeting room of the Groveland Branch Library at 1:00 on the 4th Friday of each month (excluding November & December.)


# Angelo Amoruso is Tioga Student of the Month



#### What can parents and the community do to help at Tenaya School?


