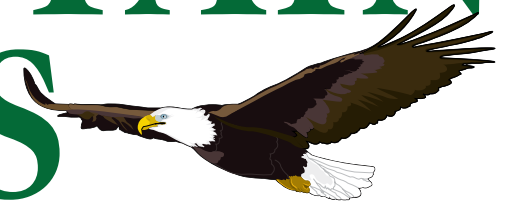

General Manager's Message

PML Cell Tower Project

A PML member filed an appeal to the cell tower project and a hearing was scheduled before the County Board of Supervisors on Tuesday, March 15th. PML member, Pauline Turski and I presented testimony in support of the project and our partner with Anthem Telecom presented additional information. Our Controller, Ken Spencer attended to provide support and answer questions of the news media. Also in attendance supporting our project was PML Member, Michelle Ronning. I would like to thank these folks and all of the members who sent in letters and signed the petition supporting our project.

I would also like to thank our County Board of Supervisors and staff for their assistance and understanding of the importance of cellular communication for our community.

We are now working on negotiating the specific conditions of the security agreement with the County and Anthem is working with the County Planning Department on the permit. We are targeting a completion date sometime in May.

Tree Mortality Update

The County is conducting tree mortality community forums through their office of emergency services. The purpose of these meetings is to inform Tuolumne County residents about the County's Hazard Tree Removal Plan.

PML is participating through our membership in participating agencies, specifically the Fire Safe Council and Groveland SWIFT (Southwest Interface Team).

One of these meetings is scheduled to be held in Groveland at the Tenaya Elementary School Gym on April 19th at 6pm. Information is available on the Tuolumne County website. We have also posted the information on the PML website and official PML Facebook page.

LRPC Member Survey

The Long Range Planning Committee has finalized the preparation of the 2016 PML Member Survey. As per Board direction, they have included two questions that address single-room/guest house rentals to gauge member input on a possible CC&R amendment. The survey will be conducted online and hard-copies will be available for those who would prefer this method instead. The LRPC members are administering the survey and will be collecting the data.

The Committee will assign a member to report back to the Board with the survey results. We have also prepared a distinctive button and link, prominently placed on the PML Website homepage, so that the online survey is easy to find. Hard copies are available at the PML Administration Office. For more information, please call (209) 962-8600.

GCSD Water and Sewer Rate Study

The new GCSD water rate schedule was adopted in January of this year. On March 2nd, GCSD announced in a public statement that the engineering study that was used to prepare the rate study and subsequently determine water rates contained an omission. GCSD was using asset inventory information that was provided by Boise Cascade the original PML subdivision developer. Unfortunately, the data did not include the pipeline infrastructure for PML.

This significant omission totals approximately \$44 million dollars. I have met with GCSD General Manager, Jon Sterling to discuss our concerns and to better understand the potential impact to PML and its residents. Rough estimates place the discrepancy at a budget shortfall to GCSD at \$275K per year as amortized over the 40 year lifespan. This reflects an approximate increase of \$7 per month per customer. This assumes that the District can get grant funding to cover 75% of the expense. Again, these are preliminary estimates.

The water increase that went into effect in January will increase Association water costs by \$20K. We are evaluating the additional potential impact to PML based on the new findings that there has been an omission error in the original study.

Since the water rate study and implementation was conducted in accordance with Proposition 218, the District is not going to revisit this until after their review and implementation of new sewer rates. Before any rate increase go into effect, the District conducts meetings and rate-payer workshops to get input before moving forward with any increases.

According to GCSD, they held a sewer rate workshop on March 11th and 6 people showed up. They have another scheduled for April 9th at the Groveland Community Hall at 10 am and encourage all interested members to attend and participate.

We are monitoring this situation closely and will provide updates as more information becomes available. All questions regarding current or proposed GCSD water and sewer rate increases should be directed to district staff.

Grill Grease Interceptor Project

The Restaurant grease interceptor project is making progress. The grease interceptor is a component of our plumbing system that captures any water that has anything in it that will solidify and cause a blockage in the sewer system. The old interceptor is outdated and failed. The design specifications for the new system have been submitted to GCSD for review and approval before they are submitted to the County for permitting.

This is an in-house project that is being handled by our facilities maintenance staff. Once the interceptor is installed and working, Maintenance will complete the loading dock area improvements and Pro Shop to Driving Range pathway connection points.

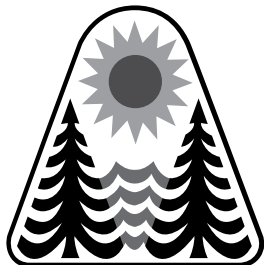

PMLA Money Matters

It's finally here! You have waited 12 long months but the PMLA Annual Report has arrived and is included in this month's issue of the PML News. I am sure that each and every one of you have already pored over every detail of this fascinating, stimulating and exciting piece of reading.

No, you haven't read it yet? Perhaps you didn't even know it was included with this month's issue. More likely you have already used it to start that fire keeping you warm on these cold nights. In any event I would like to point out a few of the highlights included in this year's report. In addition the report will be posted on the PMLA website.

First off is the President's Message. This brief recap of the year's activity hits several of the highlights regarding our financial results for the year. In addition the President addresses the status of our Reserve fund and the monies spent on capital improvements and replacements during the year.

Directly beneath the President's Message is the report from our Independent Auditor. This standard letter summarizes the audit process including Management's Responsibility and those tasks and processes the auditor uses in conducting their review of our results. Perhaps the most important aspect of this report is the presentation of their audit opinion. This statement provides their bottom line report on the fairness and general accuracy of our financial results and reports for the year. Once again this year we received an unqualified opinion from the audit firm. This indicates that our results meet the criteria and can be relied upon as accurate by our members. As a note we have received an unqualified opinion for over 10 consecutive years.

The following pages contain the "meat" of the report and present PML's financial results in numeric form. This includes a Balance Sheet (which details the value of our assets such as cash, inventory, fixed assets, etc. as well as our liabilities and equity such as accounts payable, payroll and our fund balances). Also included is the Statement of Revenue & Expenses. In essence this is a report on how much money we took in (income) and how much we spent (expenses). The report breaks these income figures down into specific line items such as Assessments, Sales, User Fees and Administrative Fees. Similarly the Expenses are listed under such categories as Salaries, Services, Supplies, Utilities, etc.

The report also contains a similar income and expense report broken down by department/amenity. This provides information on how each area performed from a financial perspective. For comparison purposes the results from 2014 are also displayed in this same table.

Throughout the report there are several Notes to the financial statements that help to explain the underlying policies, procedures and facts that support the numbers. These detail such things as our basic Accounting Policies, the make-up of

our various funds, and specific comments on the components of the major categories in both our balance sheet and income statement. Importantly it also makes specific reference to the disposition and usage of any funds available at the end of the year that are in excess of those anticipated in our annual budget.

Finally there is a table at the end of the report which provides supplemental information on our Reserve/Replacement fund. This gives a breakdown of Reserve fund by component type and includes the current replacement cost as well as an estimate of the remaining useful life of the assets contained in each category.

While this report certainly does not make for enthralling reading it does present a fairly comprehensive overview of how the Association handled your assessment dollars over the past year. I hope you will take a few moments to review the report and become informed about our financial results for the previous 12 months. Don't hesitate to contact me if you would like to discuss any of the information presented in this important annual report.

BEFORE YOU BEGIN CONSTRUCTION ON YOUR LOT

The Declaration of Restrictions (CC&Rs) states that no construction of any type (new construction, driveways, grading, lot clearing, etc.) can be performed without prior approval from the Environmental Control Committee (ECC).

Failure to obtain approval could result in the stoppage of work or even fines, and nobody wants that to happen. Inspections are made every Tuesday and reviewed by the Committee every other Thursday, so we can accommodate our members.

Building Our Community

Did you know that you are required to have your exterior paint colors approved by the Environmental Control Committee BEFORE you paint your home?

According to the CC&R's:

ARTICLE V, SECTION 1

(b) Definition of Improvement. The term "Improvement," as used herein, shall include, but shall not be limited to, the construction, installation, alteration, remodeling, and exterior color selection of buildings, walls, fences, landscaping structures, landscaping, retaining walls, piers, boat shelters, floats, privacy structures, outdoor spas, antennas, television satellite reception dishes, heating or air conditioning equipment or swimming pools, including above ground pools and wells.

(c) Approval Generally. Before commencing construction or installation of any Improvement on any Lot within the Properties, the Owner planning such Improvement must submit to the Association's Environmental Control Committee (the "Committee") a written request for approval. The Owner's request shall include plans and specifications satisfying the requirements of the ECC Rules (see Section 5, below). Unless the Committee's approval of the proposal is first obtained, no work on the Improvement shall be undertaken. The Committee shall base its decision to approve, disapprove or conditionally approve any proposed Improvement on the criteria described in Section 6, of this article V.

The process is easy. Just provide the Committee with paint chips showing your chosen colors. The Committee will review your choice at their next meeting. Meetings are held every-other Thursday. The Committee will either approve, deny or recommend a change. Once the job is complete, notify the ECC and the inspector will go out to visually inspect your home to confirm it has been painted the approved colors.

Don't count on your painting contractor to inform the ECC. Ultimately, the responsibility falls on the property owner.

By following the process outlined above, you can be assured your color choices fall within the acceptable range of colors and continue to enhance the natural beauty and character of Pine Mountain Lake.

Remembering Gentleman Michael Neagley

Michael Neagley has been a PML employee since April of 2001. He passed away on March 10, 2016 at the UCSF Medical Center in San Francisco, having succumbed to the final stages of esophageal cancer. Previous to his moving to Groveland, he lived in Berkeley, where he attended the University of California as an Arts Major. He was the Gates Technician, aka Gate Guru, in the PML Maintenance Department, he was also the Laborer's Union Local 1130 Shop Steward, a Pool Technician, the A/V Technician, our painter, a PML employee with an exceptionally good standing, who always showed respect for everyone, a true gentleman.

You may have seen him at the monthly PMLA Board of Directors Meetings at the Lake Lodge. The tall man with the white hair, preparing the refreshments, monitoring the sound system, handling the meeting setup, coming back in later in the day to handle the tear-down. I had asked Mike to attain an ADA Placard from the California DMV, which would enable him to utilize the placard while on duty driving PML V43; he would then be able to park close to his work assignments at PML amenities, in one

of the approved ADA parking spaces, but Mike thought it might draw negative attention, so he never pursued the opportunity. He was the term of endearment when I would say, "he is the senior member of our mature work force".

Mike seldom missed work, always working the weekends, having Tuesdays and Wednesdays off, worked the holidays too. He would extend his mid-week days off by a single additional day during the San Francisco Giant's baseball season, the home game stands. Mike would come in with a calendar, marking the days off so he could attend the games with his sister Frances, who lives in city of San Francisco. He had no family living here in Groveland, we were his family. Alan,



Susan, and others would check in on Mike and his home on a regular basis.

His physical ailments had become more pronounced with his age, as we watched him suffer in silence; both knees and hips causing him pain, he was planning for joint replacement surgeries. This would be several weeks off, which he would only do during the PML off-season, when the PML activities had slowed and the pool was closed. Mike Neagley was close to his retirement.

Knowing all his abilities and experience, he will be sorely missed. Last year, on the morning of Monday, November the 9th, at our morning staff meeting, I realized he was very sick. Mike would not speak to me in the staff meeting, but came

into my office to share his medical problems. He had lost forty pounds of body weight, was extremely dehydrated, barely conscience, and very ill. He was having difficulties with swallowing, unable to drink, eat and take his medication. I removed him from his work duties and advised him to seek medical care immediately. He went to the emergency room at Sonora Regional Medical Center, received emergency medical care, and called me back "don't worry about me, I will be OK". He was later transported to San Francisco to receive specialized medical care, and to be closer to his sister Frances.

He would call, tell me he was going to be off for ten weeks, asking if we needed anything or advice on gate repairs. I told him not to worry, get well, and we would see him when he comes back.

Mike was a dedicated PML employee, a rare find, and man worthy of everyone's respect. He had earned it. A man of many talents, who loved the arts, who cared for all of us. We will retire his M-9 call number, remove his seat from the meeting room, have a vegetarian feast in his honor, and forever remember him as Gentleman Michael Neagley.

FIRST TEE REDESIGN PROJECT

The scheduled redesign of the first tee began on Monday March 7. The project will redesign the first tee complex to eliminate the retaining wall and establishing a golf cart staging area. A few of the many benefits of the redesign will be a more open and wider area to stage golf carts, reducing congestion and making the area more efficient and convenient. The redesign will replace a great deal of the grass covered area around the tees with landscaping covered with mulch and drought resistant plants. Only the tee surfaces will be spray irrigated, greatly reducing water use in this area. We anticipate reopening the tee complex around May 1.

RULES QUIZ

Tee to Green

Rob Abbott – Golf Course Superintendent

The golf course maintenance team has been hard at work through the winter months. The team has been cleaning up fall and storm debris along with many other projects readying the course for our summer season. With the warm and dry month of February, we saw a surge in growth and we were actively mowing the course, which gives us a nice clean finished product moving into spring. The maintenance team will continue doing their best to keep up with the growth and care for the grounds to provide members with the best product possible.

The spring months bring a lot of projects and challenges. We will be aerifying the greens on April 11th and 12th. We should have the tees, fairways, and rough, along with a verticutting of the fairways done by this point. All of these activities need to be finished in preparation for our pre-emergent herbicide being laid down to aid in the prevention of weeds on our tees, fairways, and surrounds. Hopefully the only challenges we find will be dealing with rain and spring growth. We have been keeping our fingers crossed for a lot of rain and with the exception of a dry February, Mother Nature has not let us down. As of March 8th, the total inches of rain add up to 32.35.

With all of this rain and a full lake our irrigation needs for the summer season should not be an issue. Although with that being said, we are still going to be in

conservation mode using all of our available water wisely. We will be using a blend of recycled water and lake water throughout the summer months to irrigate priority areas, and conserve in others. Our new plan calls for us to use a maximum of 13 inches off the lake and we will stay within our new parameters. This is a 20% reduction over previous years. Our local utilities district has worked incredibly well with us throughout the drought allowing us all of the water they had available. They also held back irrigating their spray fields in order to supply us with what we needed to survive during this time.

Along with all of our other chores, we will work throughout the warm spring months to rehabilitate areas that we had to let go during the 2015 summer season. While some of these areas have come back with new growth, others are going to require some work. We will utilize plugs from our green and tee aerification to help smooth out the perimeters and will be using our seed drill to till seed into the soil. We will be working the priority areas first and slowly work our way around the course. We purchased extra fertilizer for our early summer application and will be broadcasting into the rough adjacent to the fairways to help stimulate some of those areas as well.

Let's all get outside and experience the warm weather, and I look forward to seeing you on the course.

Hooves and Happenings

“April showers bring May flowers”, well I don’t know what April will bring, as it is the beginning of March when written, but March has “come in like a Lion”! We are all enjoying the rainy weather, even the minor problems that go along with it: fewer trail rides, flooding stalls, wet and muddy horses, but all-in-all we know it’s a Blessing.

In the next few articles, I will be featuring a different Lesson / Day Camp horse. All of these horses are wonderful with children and beginning adults and love to have attention. These horses are presented in no particular order or preference. They are all geldings (males); all will be measured by “hands”; and a “hand” is a measurement of 4”, considered the width of a man’s hand, from the ground to the horse’s withers or point of shoulder. This “hand” has been used since long ago, when people did not have measuring tapes, only their hands, handy (pun intended).

This month is Caspian. Caspian is a Dutch Warmblood “sport horse” breed. Warmblood simply distinguishes this type of horse from the “cold bloods” (draft horses) and the “hot bloods” (Thoroughbreds and Arabians). He stands 17.3 hands tall, which equals 5’9” and 19 yrs old. Don’t let his tall size fool you, he is just a big baby. Nine times out of ten, the big horse is gentler than a pony, who often has a Napoleonic nature. He was born, or foaled, in Denmark and was imported to the United States as a Dressage (English riding style) competitor. With his short summer coat, one can see the white brand of his breed on his left hind flank. Caspian eventually became a children’s show jumping horse, but sustained a small injury, which made him unable to continue jumping, but he loves his job as a lesson / day camp horse. He also enjoys being groomed, petted, often stands s.t.a.r.i.n.g at our staff or boarders till



someone comes to visit him. His “winter buddy” is Jacki Orton one our boarders, who has been caring for and occasionally riding him when not being used for lessons.

Come out and meet Caspian! Or better yet, have a lesson on him, Monday through Friday, by special arrangement with me. With our nice sand arena, we can do lessons no matter how wet outside.

On the Lake: Force Be With You!

Last month I suggested taking a hike along the Tuolumne River on the Preston Falls Trail. Afterwards, I realized that I should have gone into more detail about safety in and around moving water. I remember a time when I was crossing the Tuolumne River just upstream of Don Pedro on a very sandy stretch of the river. My companion was a Coast Guard certified captain, avid surfer, scuba diver and all around water guy... or so I thought. About halfway across the river, he got a bit nervous and let me know he was not comfortable. Besides the force of the water, the sand under our feet kept getting washed out the longer we stood in one place. After sharing a few techniques with my friend, we crossed safely and all was well. And that’s where the force comes in. Not the Luke Skywalker kind of force, but the Ronnie River-wader kind. R2 if you like.

I tried to calculate the force that water exerts on a person, but there were a few too many factors to try to put an exact number on it (yes, I am math-limited). Some of the most obvious factors include the velocity and depth of the water. But you also have to remember that, due to buoyancy, as you go deeper into the water, you are putting less weight onto your feet. At some point, being swept into the current becomes a real possibility. In swift water, that can easily happen even if you are less than knee deep. If that happens, there are a few things you need to do to get out safely. I can’t cover them all in this article, but I will touch on a few.

First, don’t panic and don’t try to stand up in swift water. A lot of rescues involve people who tried to stand up, but instead got a foot stuck under a rock and then got folded

over the rock by the force of the water. It’s called foot entrapment. Instead, you should float on your back, look downstream, keep your feet up, protect your head, and use your hands to back-paddle into slower water where you can swim to safety. It’s gets more complicated if there are hazards like trees, brush, waterfalls, boulders, rapids or Darth Vader. With the storms we’ve already had, and the upcoming runoff from melting snow, our creeks and rivers are going to be a force to reckon with very soon. Be careful, be prepared and know your limits.

Now a little lake news. I was out on our Lake right after March came in like a lion. What an interesting day. The creeks were flowing fast and muddy. There was at least 2,000 cubic feet of water going over the spillway every second. That’s around 65 tons every second. People living near the spillway could feel the rumble. Not to worry though, our spillway is designed to carry well over 10 times that much. That would be Biblical!

There was also a dock and pontoon boat that broke loose and got hung up partially over the spillway. Not the first time a dock has broken free. I’m pretty sure some of our dock builders don’t fully understand “The Force.” And you won’t believe this. There was a boat out there towing a water skier. Illegal this time of year (no fast boating May-October), but you have to admire their spirit of adventure.

At the upcoming Friends of the Lake meeting on May 15, I think I’ll be speaking about one of two things. It will either be about water safety, or all of the monitoring we do to help manage the Lake. Stay tuned.

Until then - SPLASH!!! But please, only if it’s on purpose.

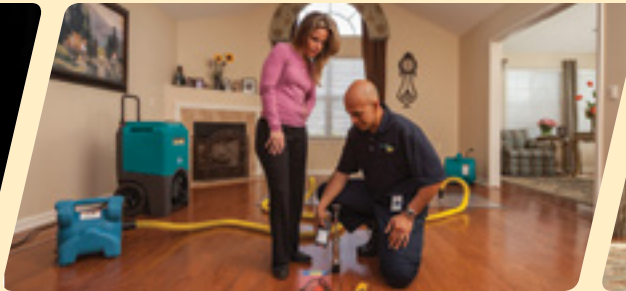

CC&R's, Article VIII, Section 19 – Use of Private Streets within the Common Area

(d) All provisions of the California Vehicle Code must be honored at all times when operating any motor vehicle within the Properties.

Honoring the California Motor Vehicle Code by visitors and residents alike is an ongoing problem in PML. Unfortunately, I see it first-hand due to the amount of time I spend driving our narrow streets doing inspections and meeting with members.

What's in a Name?

Natalie Trujillo - Director of Safety

In March of 2000 the Board of Directors voted to change the name of the then-titled Pine Mountain Lake Security to the Department of Safety. The Board aptly felt at the time that a change from "Security" to "Safety" would be more apropos of the duties and responsibilities currently understood by the Department. Safety is a service-oriented amenity even more so than a security-oriented one. That being said, the "Security" functions of this amenity have remained basically the same over the last 16 years; access control, parking enforcement, repressive patrol, crime prevention when possible and the Main Gate's role as the information hub have not changed drastically. Some of the Department's security efforts, and even its service roles, have had to be eliminated or altered based on new statutes and case law. Sometimes the risk or precedent set in fulfilling a specific function does not outweigh the liability that could be incurred by the employee personally, the supervisor or the Association as a whole. For example,

not even a decade ago, Department staff were still permitted by the Department of Fish and Wildlife (formerly the Department of Fish and Game) to shoot sick and injured animals, including deer, foxes, and squirrels, when it was evident that they had no hope of survival. When California's laws changed surrounding the licensing of "Security Guards" that privilege was essentially withdrawn and our ability to euthanize animals diminished. Our focus on member service however has been continuously evolving and adjusting to both the community and the Association's needs. It is the Safety Department's mission to consistently exceed the expectations of our residents - within the appropriate guidelines and restraints of the Association and the law. Our mission will remain the same no matter what our official title is.

Last year an exception was made by the Board, due to the low Lake level caused by the drought. Pontoon boats were parked at Dunn Court under an emergency exception. A PML member has proposed allowing for several pontoon boats spaces at Dunn Court due to the lack of space at the Marina. The Board of Directors has tasked staff with the evaluation of this idea.

If you are an interested member, please share your opinion regarding the Dunn Court pontoon boat beach space proposal. Your input is important and will be considered by the Board of Directors in determining the best course of action to take.

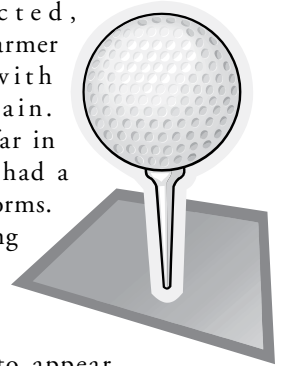

Friends of the Lake Asks: "Is the Drought Over?"

Friends of the Lake kicks off its 2016 season with a timely presentation at Lake Lodge, at 5:00pm on May 15 addressing the question "Is the Drought Over?" Our speaker is Chris B. Graham, PhD, a water scientist working for the Hetch Hetchy Water and Power (HHWP) Division of the San Francisco Public Utilities Commission.

Dr. Graham is responsible for modeling upcountry snowpack accumulation and melting, and the inflow to HHWP managed reservoirs in the Sierra Nevada Mountains, including Hetch Hetchy Reservoir, Lake Eleanor and Cherry Lake. Hetch Hetchy delivers water to 25 utility customers in the Bay Area, providing water to 2.6 million customers He received his PhD and MS in Water Resource Science and Soil Science at Oregon State University, and a BA in Mathematics from the University of Montana.

Dr. Graham's presentation will discuss current snow, rain and reservoir storage level conditions and how they compare to

previous drought years. He'll also address how Hetch Hetchy ensures water delivery to Groveland.

Friends of the Lake is a PML social club open to any PML resident who is committed to enjoying our beautiful lake and ensuring safe and equitable usage. In addition, we work with the PML Association to promote improvements such as lake dredging, lighted buoys, shade umbrellas, the new Marina building, and Wednesday night slow-boating.

Museum Happenings

Like parents everywhere, the early pioneers of Groveland and Big Oak Flat were interested in providing a good basic education for their children, boys and girls alike. Home schooling was often the only option for early settlers in the area until other families moved in. Then they would band together to provide or build a school house and go about securing a teacher for the community.

A teaching certificate could be acquired by taking an examination held at the Tuolumne County Courthouse and going before the County Board of Examiners, consisting of the County Superintendent of Schools and four members of the Board of Education. In 1912 "the testing lasted six long days, from 9 a.m. up to midnight, or beyond. As quickly as one test was finished another appeared," according to Carlo De Ferrari's mother, Mary Sweaney De Ferrari.

Teachers were also expected to have extremely high moral values, not to smoke or drink in public, and in short, be a paragon of virtue and hard work. Aside from the duties of teaching a wide range of ages and abilities, they were expected to keep the school house clean, draw each day's water supply and keep the wood stove burning on cold days.

Early school house furniture consisted of desks and benches of rough planks. Chalk boards were smooth boards painted black and the school yard contained 'privies' (outhouses) and a flat area, suitable for game playing at recess time.

Lack of funding often required students to furnish their own supplies including slates, chalk and books so reading material brought from home meant a Bible, an almanac or other old texts to share and exchange. A typical school day began with a patriotic song, salute to the flag, and possibly a scripture reading or prayer. The main subjects were the three R's, reading, writing, and 'rithmetic and also penmanship, spelling, grammar, geography and lots of rote memorization.

Little or no playground equipment existed so recess play was creative and inventive with games like 'drop the handkerchief', 'hide and seek', and 'blind man's bluff'. The older students enjoyed baseball and games like 'ante over' and 'dodge ball'. Lunchtime was spent outside under a shade tree in good weather. Your lunch sack or bucket may have included a homemade sandwich, fruit, and a hardboiled egg.

The school house also served other community functions. Social and holiday gatherings, spelling bees, school plays, and graduation ceremonies were the highlight of each year.

Around the turn of the 20th century, Kindergarten through 8th Grade one-room school houses could be found in Chinese Camp, Jacksonville, Moccasin, Big Oak Flat, Groveland, Hardin Flat, Buck Meadows and on ranches in Deer Flat, Spring Gulch and Bull Creek. Two-room schools were later built in Big

Oak Flat (1898) and Groveland (1916).

John Gamble and his son and daughter were some of the community's earliest teachers. Other longtime educators were Mrs. Martha Scofield, Mrs. Edith Osborne, Mrs. Mary De Ferrari, and Mrs. Rose Moynihan.

In 1953, the Big Oak Flat and Groveland schools were unified with Kindergarten through 4th Grade taught at Big Oak Flat and 5th through 8th Grade taught at Groveland, with students bused to their respective schools. After 8th Grade, students endured the daily bus trip down and up Priest Grade to Sonora Union High School to complete their high school education.

The building in this archive photo is the historic one-room Elmore School which was a great example of families securing Tuolumne County School Funds for an accredited teacher by meeting the five student minimum requirement. It was built in 1943 near Smith Flat, east of Groveland, at Highway 120 and Hells Hollow Road.

In 1935 John and Martha Elmore came to California from Missouri with high hopes of establishing a lucrative logging business. They had a large family of seven children to support, with three others dying as infants. But after settling in Stockton, they soon realized alluring stands of timber were located far to the east. With their savings depleted, they temporarily moved to Linden in 1936 and earned a living by picking fruit.

Then in the late 1930s, John Elmore purchased a struggling mill operation in Buck Meadows and named it the Big Creek Lumber Company which pleased his primary Los Angeles customer looking to do business with a supplier having an official sounding name. Daughter Velma said that most of the logs they cut came out of the Jawbone area. At this time, John also purchased 30 acres for each of his sons, Von, Milbern, Carl, and George.

Homes for John and Martha and each of the grown sons were built near the mill, with additional shacks constructed for mill employees and their families. The pictured Elmore School, built next to son Von's house completed the growing community. The Elmore's daughters, Velma, Morine, and Zula helped their mother prepare meals each day for the mill workers. Lumber buyers often scheduled trips around mealtime to partake in the fruits of Martha's culinary expertise.

The Elmore School enrollment varied greatly over the years, starting with the minimum of five students in 1943 and growing to a peak

of 61 students in 1958. In that peak year, the school had three teachers and a principal. With the growing numbers of students came a need for more classroom space and an annex was added on the southeast end of the original building in the 1950s. The school

infrastructure included restrooms, kitchen, an elevated stage area, and basketball court on the west side.

John and Martha retired from the logging business in the 1960s and moved to Knights

Ferry. Son George continued to operate the mill but struggled to find workers who were willing to live so remotely. He eventually closed the family business and sold off the machinery in the early 1970s. With the opening of the new and modern Tenaya School, the Elmore School closed in 1964 and with it the ended another chapter in the story of the country school. The historic structure remained in the Elmore family until sold in the 1990s and the current owner has hopes of restoring Elmore School.

If you like old firearms (and who doesn't?) I invite you into the Museum to see our newest exhibit featuring black powder firearms. You might also enjoy the six-foot wide panoramic photo of Tuolumne County residents visiting San Francisco in 1915 for the Panama-Pacific International Exposition. Perhaps you can identify a relative.

Get BACK to GOLF!

Spring is in the air, daffodils are blooming and the golfers are on the greens. Winter bodies may feel the affects of hibernation as muscles are stretched and challenged with the return to golf. Pre and post golf stretching and warm up can help in the return to activity and lessen the aches and pains that often follow starting a new activity.

Prior to stepping up to the first tee warming up the muscles and joints involved in the golf swing is the key. Here are a few simple things to add to your routine:

- 1. Trunk twists:** hold the club in both hands behind your shoulders. Twist slowly and gently side to side feeling the stretch through your mid back and waist
- 2. Side bend:** with the club still held behind your shoulders, turn to the side and hold for 10 seconds, repeat 5 times on each side.
- 3. Hamstring stretch:** place one foot up on the cart, keeping knee and back straight, lean forward until you feel a gently pull on the back of your leg, hold for 30 seconds on each leg.

You may see that as you return to the greens this year there are restrictions in movement, either due to pain or stiffness, that can't be resolved with pregame stretches. This is where our BACKtoGOLF program comes in. Kerrie Robison, PT at PMT trained with Bud Ferrante in Carmel and has brought his program to Groveland.

Bud has combined his physical therapy training and love of golf into a program to maximize the body's ability to meet the needs of the complex "golf swing". We assess your body's ability to meet the flexibility and strength required to position your body to be in the right place to hit the golf ball. BACKtoGOLF is golf swing specific training with special consideration given for joint replacements and surgical joint repair.

These type of surgeries may limit range of motion and require golf swing specific rehab to achieve maximum function.

Autism/Asperger's Syndrome

The developmental disorder of Autism is usually first diagnosed in infancy, childhood or early adolescence. This disorder has a very wide spectrum of symptoms and behaviors. They may include repetitive behaviors, physical and medical issues, nonverbal communication and social challenges. Some individuals will only have a few symptoms and be mildly autistic, while others are severely autistic with many symptoms.

Infants with autism do not look at their caretakers' faces or pay attention to their voices. They avoid eye contact, cannot read facial expressions, body posture or other ways of communicating. Toddlers often ignore their names and play alone rather than playing with others. They lack the ability for pretend play.

Autistic children typically have a difficult time starting to speak. They have language delays and speak much later. As they get older they may have difficulty carrying on a conversation. They may talk repeatedly in monologues on a particular subject.

Repetitive behaviors can be seen when children want to play with toys in a limited way, such as lining up toy animals or trucks in a row over and over again showing signs of obsessive thoughts and interests.

Self-stimulating and soothing behaviors, such as rocking, arm flapping and spinning, is not uncommon behavior in autistic children. They are more comfortable with routine and do not always handle changes well. They may become very agitated and uncontrollable.


According to the National Institute of Neurological Disorders and Stroke, Asperger's Syndrome is a form of autism that is also expressed

through speech and language difficulties and repeated behavior patterns. Some scientists view it as a distinct disease while others see it as a less severe type of autism. They also believe a variety of factors may be responsible for the faulty brain development. It is diagnosed during early childhood development, usually by age 2, if tested, as a neurological disease. that can be diagnosed during early childhood development, usually by age 2, if tested. However, many are not diagnosed until they are seen around other children.

Many children with Asperger's are very active when they are young, but they can have problems with motor skills development. They tend to focus on a few specific topics of interest and can become obsessed with them and want to talk about them constantly and learn about them as much as possible.

The Asperger's Education Network reports that typical behavior in these children include superior intellectual recall, environmental sensitivities to things such as loud music. They have difficulty socializing with children their own age. They may have a large vocabulary as reading skills can develop early.

There has been no cure found, as yet, for either Autism or Asperger's Syndromes. The diagnosis is based mostly on observations of the child's behavior. Treatments aim to control symptoms and improve social skills. Children with Autism or Asperger's Syndrome need love and understanding, as well as a structured schedule and an orderly environment. Behavior modification therapy and special training can help children to learn some skills that will help them into adulthood.

The Tennessee-born owner/innkeeper of the historic Groveland Hotel, was known as much for her work to restore the property to its "Old West" grandeur, as her knack for making guests and members of the community feel at home.

Peggy was a resident of Groveland and was extremely active in the community. In addition to her roles as the innkeeper at the Groveland Hotel and with the Yosemite Highway 120 Chamber of Commerce, she was a member of the Tuolumne County Planning Commission and was active in the California Hotel and Lodging Association. Tuolumne County was her home for well over two decades and she made her energy and enthusiasm for the Mother Lode known. Many agree, by all accounts, our community is much richer for it.

She began her career as a computer programmer with the Air Force Civil Services. She was the first female manager at Lockheed Martin, a flight school owner, a junior college professor, a California real estate salesperson, and was inducted in the CHLA Hall of Fame.

Also noteworthy were her accomplishments not noticeable to the outside world. She

attended Notre Dame de Namur University, a private Catholic university based in Belmont in San Mateo County.

The story of Easter starts with the Passover, told in the first third of the Biblical book of Exodus. The Jews at this time have come to Egypt because of a famine, while Joseph of the Coat of Many Colors is Pharaoh's trusted Counselor.

Sometime after Joseph's death, the Jews are enslaved by the Egyptians and forced to perform hard labor, under bitterly cruel conditions for hundreds of years. Eventually, the prophet Moses goes to the new Pharaoh and asks him to let the Jews go.

When Pharaoh refuses, God sends a total of ten plagues that devastate Egypt. In the first nine, the waters of the Nile turn to blood, frogs appear everywhere, lice infest everything, wild animals menace the land, cattle die, there is an outbreak of boils, hail destroys the crops, locusts devour whatever is left, and the land is covered in darkness. After each plague, Moses asks Pharaoh to set the Jews free. Every time, Pharaoh refuses.

The final plague is the killing of the firstborn sons. Moses instructs the Jews to sacrifice a lamb for each family and spread its blood on the doorposts of their house. God passes over the marked Jewish houses, and kills the firstborn male child in every Egyptian household. There is a great outcry, and Pharaoh finally tells Moses to take the Jews and leave Egypt without delay. The Jews leave in such a hurry they don't have time to make bread for the trip; instead, they leave carrying bread dough, which bakes on their backs before being able to rise. The holiday is

called "Passover" because God passes over the Jewish houses, protecting them while killing the Egyptian firstborn sons.

The two holidays, Passover and Easter are entwined from the beginning—the word Pasch, originally meaning Passover, comes to mean Easter as well. The Easter story is at the heart of Christianity. It celebrates the Resurrection from the dead of Jesus, three days after he is executed. The celebration of Passover takes place just before the Crucifixion and Resurrection of Christ.

After Jesus is crucified on the Friday now known as Good Friday, his body is taken down from the cross and buried in a cave tomb. On Easter Sunday, Jesus appears in his Resurrected Body. According to Biblical sources the Resurrected Jesus appears several times to a number of people over the next 40 days. He knows the importance of convincing His followers He IS the Risen Lord Jesus. Without their firm conviction of His Resurrection, their faith and Christianity would have been lost.

Therefore, Liturgical Christian Traditions celebrate a Season of Easter for 7 weeks, until Pentecost Sunday on May 15. To some extent we celebrate Easter and Jesus' Resurrection every Sunday of the year.

The Road To Broken Dreams

On April 16, at 7 p.m. the Southern Tuolumne County Historical Society will host acclaimed author and historian Sharon Giacomazzi. She will speak about the historic mining settlement of Bennettville, located high upon Tioga Pass.

In 1883 the Great Sierra Wagon Road was built to service the needs of a silver mining operation at Bennettville, elevation 9800 ft., off of what today is Tioga Pass (Highway 120). An eastern mining company and its investors were confident that the reported "thundering ledge of silver" would make them millionaires. But, Lady Luck did not smile on their plans and kept her treasure locked up tight in the granite of Tioga Hill. After the bust, the 56-mile-long route was neglected and fell into disrepair for 30 years. Some called it "the road to broken dreams."

Though Bennettville proved to be a firecracker that didn't go bang, the builders of the road couldn't

have imagined that it would become the forerunner of dramatically scenic Tioga Pass Road. Now as then, the real treasure of the area is the powerful beauty of the high country landscape. Sharon will guide you through Bennettville's fascinating story and tell you how you can walk on the original road to the mine and town site.

Skillet Chicken Parmesan Dip

Chicken Parmesan is one of our favorite dishes, and Paula has a great recipe for it. So our interest was piqued when I found a recipe for chicken parmesan dip. That recipe turned out to be just OK, but we revamped it with the flavors of our Chicken Parmesan in mind. The result was outstanding and we hope you will try it out:

INGREDIENTS

- 2 Cups Marinara Sauce
- 2-3 cloves Garlic, minced
- 1-1/2 tsp Italian Seasoning
- 1/2-1 tsp Crushed Red Pepper
- 1 8 oz package Cream Cheese
- 1 Cup Ricotta Cheese (whole milk)
- 4 Breaded Chicken Tenders, chopped into smaller pieces (buy at PML Grill)
- 2 balls Fresh Mozzarella Cheese, sliced thin (or can use Mozzarella Pearls)
- 1/4 Cup Parmigiano Reggiano Cheese, grated
- 1/4 Cup Romano Cheese, grated
- 1 baguette Sourdough Bread, sliced for serving (make crostinis if preferred)



DIRECTIONS

Preheat the oven to 350F. Combine Marinara, garlic, Italian seasoning, and red pepper. Then combine the cream cheese and ricotta and spread on the bottom of a cast iron skillet. Pour half of the marinara mix over it, and then add the chicken tender pieces. Top with the remaining marinara, and then add a layer of mozzarella cheese. Top with Parmigiano and Romano cheese.

Place in the oven and bake for about 20-22 minutes, until the cheese has melted and the dip is bubbly. Serve warm with baguette slices (or crostinis) for dipping.
