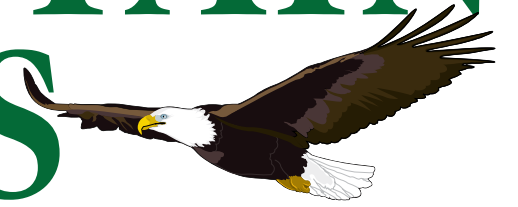

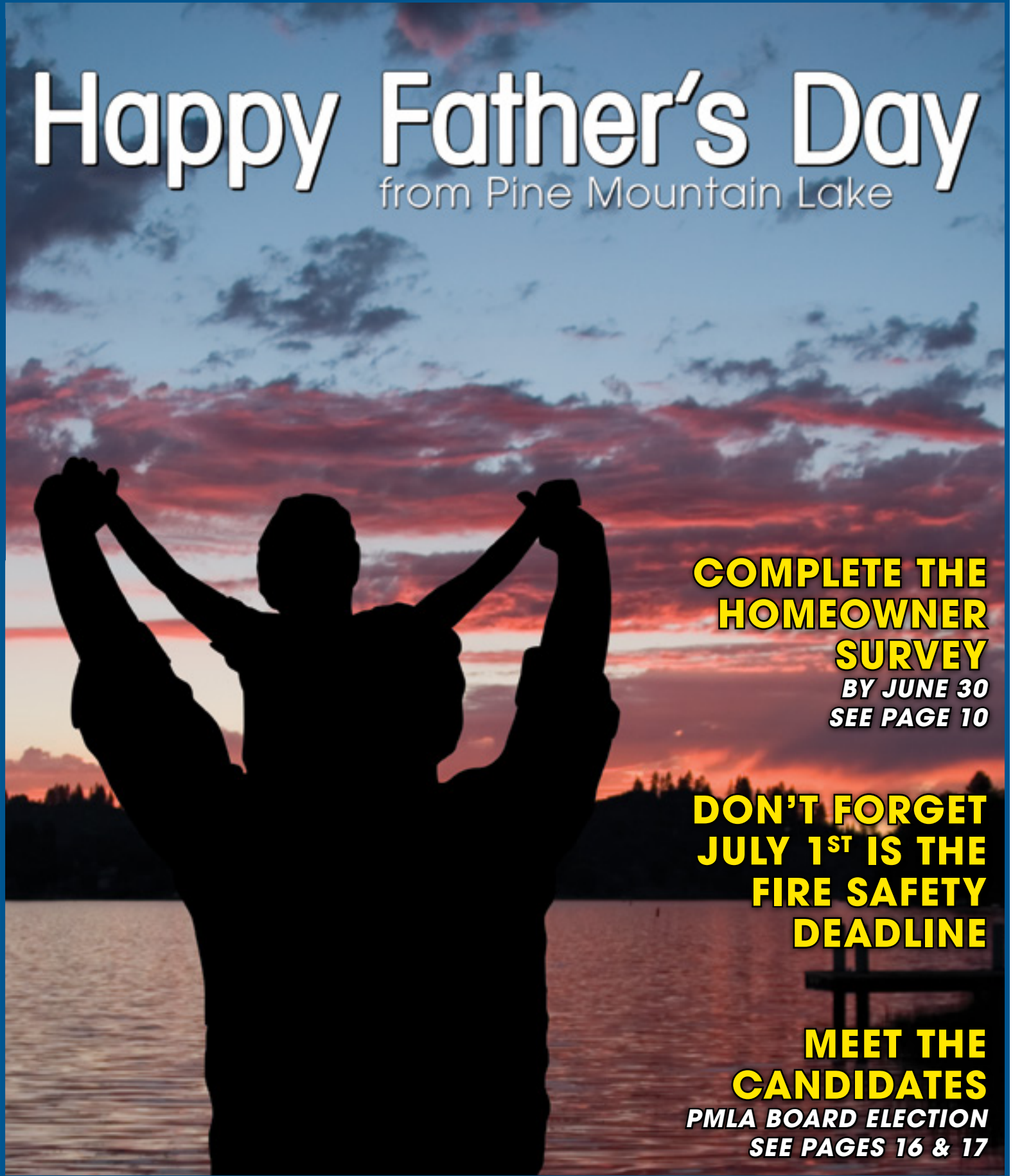

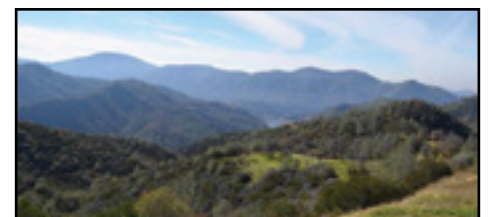

General Manager's Message

I am pleased to announce that my Assistant, Ivonne Deckard completed the coursework necessary to earn the designation of Certified Community Association Manager through the California Association of Community Managers. This designation is an important recognition of education and skill in community association management. Congratulations Ivonne, we are very proud of you!

Seasonal Amenities Open on Schedule

The Swimming Pool, Marina Store and Lakeside Cafe were opened on schedule and we are already receiving positive member comments. I encourage all members to get out and check out our seasonal amenities as we offer a lot of fun activities. More information can be found in the PML Activity Guide. The 2016 PML Activity Guide went out with the May edition of the PML News, and an online copy can be found at the Official PML Website.

Gears and Grooves Mini-Triathlon

As I mentioned last month, the Second Annual Gears and Grooves mini-triathlon is scheduled for Saturday, June 11th. The Triathlon Committee has adjusted and improved the route, and PML is looking forward to more participation this year. The founders of the Triathlon, PMLA Director Steve Grier and his wife Maureen are working with staff to coordinate the logistics within PML and I am sure it will be a lot of fun. We encourage all members to sign-up and participate.

LRPC Member Survey

The Long Range Planning Committee 2016 Member Survey went live on April 1st as planned. The LRPC members are administering the survey and will be collecting the data.

The Committee has reported that we are already exceeding the returns of past surveys for the same timeframe. The Committee has received more than 500 member responses and this is useful for a solid survey sampling of the membership. The Committee would like to thank the membership for their input. This information is used by the PML Board of Directors and the management team in setting priorities for our community. Once the deadline has passed, the Committee will assign a member to report back to the Board with the survey results.

To encourage maximum member participation, our staff has prepared a distinctive button and link, prominently placed on the PML Website homepage. Also, those members who complete the survey and provide their name and contact info, will be eligible to win one of three PMLA gift cards just for taking the time to respond.

Bark Beetle Mitigation

Our staff has been working with the County and other agencies to come up with effective methods to mitigate the infestation of bark beetles. Bark beetles are always around, but really thrive during a drought due to the weakened condition of the trees.

Last year, we discovered a product

called Splat Verb. This is a pheromone-based jell that comes in single and multiple tree applications. It is applied in four spots around each tree trunk and gives off a pheromone that tells bark beetles not to bother attacking the tree as it is already infested with beetles and is full. Our Maintenance Department uses this product in addition to other methods to mitigate the bark beetle hazard in our greenbelts and common areas.

This product is not useful for trees that are dying off due to other conditions or if the tree is already infested, but it is a good start towards mitigation. In the past we have been able to offer the product for sale, but have discontinued this due to regulatory requirements. Members can buy the product online and other treatments are available through the local pest control companies.

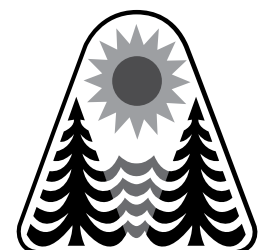

Community Standards

Dennis Pipal – Community Standards, Director

Another fire season is upon us and the weeds are heavier than in recent years due to the wet winter. In addition, many of you have dead vegetation that needs to be removed to the compost. (No burn season begins June 1 of each year).

WEEDS: As most of you know, cutting green weeds is no fun. On top of that, cutting green weeds in May or early June will likely grow back before the July 1 inspection. The rule for weeds is: in the 30’ defensive space the weeds need to cut to the dirt. Outside the 30’ defensive space they can be no longer than 3”. Our recommendation is to wait and see if they die and turn brown sometime in late May or the first 2 weeks of June. If they don’t turn brown, cut them in late June or you may have to cut them again for the July 1 inspection.

DEAD VEGETATION: The drought has caused a lot of vegetation to die. The cedar trees are particularly hard hit. In most cases the larger cedars are dying from the bottom up. We recommend you remove as much of the dead (brown) limbs as possible. If the cedar is over 50% dead it will not likely survive. Most of the smaller cedars are completely dead and need to be removed to the compost.

COMPOST RULES: June 1 is the start of the no burn season and will last until

approximately November 15, 2016. Cleaning your 30’ defensive space requires the removal of all fallen needles and leaves which can be taken to the compost and dumped in its designated area.

Slash/brush can be dumped in its designated area. Please do not combine needles/ leaves with slash/brush in your load. These need to be dumped in separate areas of the compost yard.

Tree logs are limited to 6” in diameter and under. If you have timber larger than 6” in diameter there are vendors who have locations to take this material outside of PMLA. In addition, Tuolumne County has opened a log storage facility in Chinese Camp for the logs in excess of 6”.

BARK BEETLE PINES: Any dead trees removed prior to June 1 should have the slash burned. The tree log should be removed from PMLA unless it is tarped in 6 millimeter clear plastic for up to 5 weeks in order to kill any remaining beetle residue. Trees removed after June 1 should have the slash chipped and scattered or tarped. The tarping is designed to suffocate any remaining beetle residue by baking them in the hot sun. The tarp needs to be sealed tightly around the edges so no air gets in or escapes. The temperature must attain at least 113 degrees for an extended period of time for the tarp to be effective. Up to 5 weeks in the summer sun should do the trick.

PMLA Money Matters

Ten years. One decade. May 24th marked the 10th year of my job as the Association's Controller. In many ways it seems like just yesterday. I have learned a lot during that time. Hopefully my contributions to PML have been worthwhile. It also means almost 100 of these monthly articles. That's a lot of Money Matters. I thought it might be interesting to look back on all that has happened in that time.

My very first article appeared in the July, 2008 edition of the PML News and Reserve Funding was, not surprisingly, the main topic. Some things never change and even back then I was preaching the importance of a healthy Reserve Fund to help ensure the long term financial health of the Association.

Long time readers of this column know that I have covered a multitude of topics during that time including budgeting, assessment increases, the impact of lot mergers, the annual financial report, departmental financial results, where your assessment dollar goes and how we handle and protect the Association's assets.

While I have visited several topics more than once during that time it is always important to put a slightly different slant on a familiar topic. Many times this included my often lame attempt at humor. Sometimes funny, other times, not so much. Above all I have tried to be honest, informative and entertaining. Hopefully I have accomplished at least some of those goals during that time.

Looking back over 10 years it is amazing how many things have changed. In 2008 our Reserve Fund contained \$1.8M. As of last month the Reserve balance had grown to over \$2.6M. A nice increase but still leaving us a ways to go in order to be

truly healthy.

The annual assessment related to Operations (not including increases to the Reserve Contribution) has increased on average by only 2.8% per year since 2007. The only amenity/department whose required assessment subsidy has actually decreased since 2007 is the Grill/Bar operation (2.9% since 2007).

Since 2006 we have re-opened the shooting range and converted some of our tennis courts to the newest activity in PMLA, Pickleball. This fast growing sport has actually doubled the revenue received for racket sports in PML in one year.

Two things that have stayed consistent over the last 10 years is our financial results and audit performance. Since 2006 we have reported year end results that were better than budget each year. This helps keep things on track and prevents the need for any special assessments. In addition our audit reports have consistently been positive with the Association receiving an "Unqualified Opinion" each year.

Hopefully the next few years will continue to show improvement in our Reserve Fund status and continue with the positive financial results we have experienced over the last few years while at the same time providing the high level of member service that you have come to expect.

Thanks for letting me be part of this great organization for the last 10 years. I have thoroughly enjoyed the ride.

On the Lake: PHISHING PHOR THE TRUTH

Aside from the misspelling, the title would be good for what scientists do. They look for the truth. If they have a question, they propose various answers for the question, and then rigorously test them by experimentation or using data that is already available. It's called the scientific method. If you have a problem, you form a hypothesis, and then you test it. So, the use of Ph in the title might give you a hint. More correctly, I'm actually referring to pH.

Recently on social media, there has been some discussion about the pH of the water we receive from GCSD. It resulted in GCSD paying a consultant to write a White Paper to explain it. The paper correctly stated that the pH of the water we drink is purposely raised to somewhere between 9 and 10 to prevent corrosion of our plumbing and the possible leaching of heavy metals into our drinking water. So, what is pH?

If you remember pH from basic chemistry or high school science, it's a scale that quantifies whether a liquid (in our case water) is acidic or basic. The scale is hard to explain, but the key points are that it is a logarithmic scale where an increase of 1 unit actually means an increase of 10 of the "things" that are being measured. In pH, it is the amount of free hydrogen ions that are being measured. It's more complicated because pH uses a negative logarithmic scale. For our discussion, all we need to know is that a pH of 7 is neutral, pH below 7 is acidic, and pH above 7 is basic.

So, the pH of our drinking water is about 9.5. And that is what raised the concern on social media. Is it safe to drink? I would give it a definite YES. If I had more thumbs, I would give it a ten. And to back up that answer with real data, I tested it. I measured about 12 ounces of our tap water today, and the pH was 9.8. Then, I gargled a couple of times with another 12 ounces and measured the pH at 7.5. Next, I put just one drop of lemon juice into 12 ounces and the pH was 7.1. I ended by putting one teaspoon of coffee into 12 ounces of water and the pH was 7.5. It changes so easily because our water is extremely pure. GCSD adds only a small amount of safe chemicals to the water to raise the pH. And remember the reason for adding it. It prevents things like lead from ending up in our water. We don't want to end up like Flint!

I know we are a "worry driven" society. Everybody seems to need... almost crave the need to worry about something. But let me tell you, our drinking water is not something to worry about. We are blessed to have some of the best drinking water anywhere in the world. Hats off to Yosemite National Park, Hetch Hetchy Water & Power, and GCSD for protecting, delivering, and treating our water.

If you still need to worry, worry about the other stuff we routinely drink.

Until then - SPLASH!!!

Tee to Green

Rob Abbott - Golf Course Superintendent

As I write this article in early May, we have had an amazing 39.80 inches of rain which has helped rejuvenate the course after the long drought. Turf has come back in many areas, and with the over seeding we have been doing we look forward to a lush and healthy season.

The month of May will be a month of preparation with several large tournaments and holidays coming up. Memorial weekend at the end of May followed by the Sonora Regional Tournament in early June, the Pine Tree Invitational mid-June and the Motherlode Invitational a week later followed up by the 4th of July. Wow it's going to be busy. The golf maintenance staff will be doing many chores in preparation for these events such as adding sand to the bunkers that need it, edging cart paths, cleaning and painting yardage markers on the tees, fairways and paths, cleaning the heads with yardage chips, detail weed

eating and mowing, along with all the other daily tasks performed by the crew. Aesthetics are the very core in the game of golf, and your maintenance staff will strive to provide top notch playing conditions.

The greens were aerified in early April. This process makes them sandy, bumpy, and slow. This is the process and the conditions we must deal with to have healthy greens the rest of the year. With that said, I have noticed an abundance of ball marks on our greens. Repairing these slight depressions is very important. A ball mark can cause the grass in the depression to die, leaving not just a scar but also a pit in the putting surface that can knock putts offline. Repairing a ball mark restores a smooth surface and helps keep the grass healthy. But repairing a ball mark incorrectly can actually cause more damage. The ball mark repair tool is an essential piece of equipment

that every golfer should have in his or her golf bag. The first step in repairing ball marks is to take your ball mark repair tool and insert the prongs into the turf at the edge of the depression. Note: Do NOT insert the prongs into the depression itself, but at the rim of the depression. The next step is to push the edge of the ball mark toward the center, using your ball mark repair tool in a, "gentle twisting motion," in the words of the GCSAA.

This is the step where golfers who incorrectly, "repair" ball marks usually mess up. Many golfers believe the way to "fix" a ball mark is to insert the tool at an angle, so the prongs are beneath the center of the crater, and then to use the tool as a lever to push the bottom of the ball mark back up even with the surface. **Do not do this!** Pushing the bottom of the depression upward only tears the roots, and kills the grass.

Wrong: Using the prongs as levers to push up the bottom of the depression.

Right: Using the prongs to push grass at the edge of the depression toward the center.

Just use your ball mark repair tool to work around the rim of the crater, so to speak, pushing the grass at the edge toward the center of the depression. Once you've worked around the rim of the ball mark with your repair tool, pushing the grass toward the center, there's only one thing left to do: Gently tap down the repaired ball mark with your putter or foot to smooth the putting surface.

I would also like to take a moment to congratulate three of my employees who all had anniversaries over the last couple months. **John Brooks 25 years, Ed "GROOT" Groothuyzen 20 years, and Matt Smith 10 years.** We thank them for their years of service, and we all look forward to seeing you on the course.

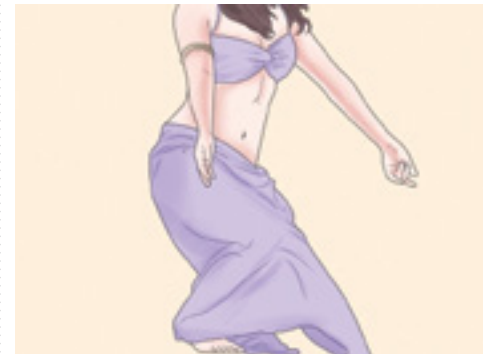
And don't forget the **5K TRAIL RUN** on Friday, July 1st, 7 am!!

From Your Tuolumne County District Supervisor

John Gray – Tuolumne County 4th District Supervisor

It's election time again and I've spent the past several days and weeks participating in public forums and at speaking engagements. Incumbents talk about what they have done to improve government and new candidates talk about how everything has been mishandled and mismanaged and how they can do a much better job.

Public service requires that its representatives have the willingness to devote the time it takes to serve the public. Being a County Supervisor is a full time job and a full time commitment. Without the commitment the public is not adequately served.

During the forums, candidates are questioned as to how they intend to solve a multitude of problems so as to ensure that everyone in Tuolumne County can have a "happier" life.

Over the past 7 ½ years I have written many articles that address issues that County Government has been and is currently working on. I have highlighted programs that have been established to benefit the residents of our county.

Topics for my articles are chosen in the hope that I will receive questions, comments and good feedback from the readers. Gratefully, this does happen....but not as much as I'd like.

The first step in leading is to develop a "vision" on where you want your organization to go and then to develop a plan to get you there. When I entered my first term in office there was not a clear vision for the County to follow. I have mentioned previously about the process that the board followed to create Tuolumne County's "vision" which is defined as "the ability to assure that Tuolumne County is a place where all citizens enjoy opportunities to thrive in a safe, healthy and productive environment." It is my job and that of my fellow board members to lead our county responsibly to fulfill that vision.

In order to move forward and solve the problems that stall progress, we need your help. Have questions about county issues? Contact me. Want a personal one-on-one meeting? Contact me. Is it a complicated matter? Contact me and I will arrange for County staff to meet with us.

There's nothing more frustrating than hearing what we haven't done or what was done wrong when no one even told us of a problem. You might not always get the answer or the result that you want but it will certainly not be due to lack of effort on our part.

Following is an excerpt from California State Association of Counties (CSAC) Director Matt Cate's in reaction to the

Governor's May Budget Revision. These comments address areas of interest from my previous articles.

"Given the volatile nature of state revenue and the duration of the economic recovery, we understand the Governor's emphasis on fiscal prudence. California Counties agree that, as the Governor has said, managing budgets is "like riding a tiger". The Governor is striking a difficult balance between current needs and preparing for the inevitable economic downturn.

We applaud the Governor for making housing and programs for the homeless a priority. These are complex issues and there is no "one-size-fits-all" solution, but we have to find ways to provide people with homes, training, treatment and other services to get them off the streets. As always, California counties plan to work closely with the Governor and the legislature to maximize this effort.

California counties are extremely pleased that the Governor recognizes tree mortality as a significant risk to people, infrastructure and the environment. There are more than 29 million dead trees in our forest, and more are going to die due to the drought and bark beetles. The Governor proposed spending \$150 million in cap-and-trade funds on forest health and tree mortality in his January budget. The May Revision contains an additional \$11 million that will help remove trees in the most impacted communities, and makes \$39 million more available in disaster assistance grants which could be used to assist counties with tree mortality.

In addition, we are pleased that the Governor has continued to place a high priority on transportation funding. Local streets, roads, and bridges are in dismal condition—as are many state highways. The May Revision continues to reflect the Governor's January transportation funding and reform proposal which will generate \$36 billion over the next ten years to help make critical repairs to our infrastructure. We look forward to working with the Governor and the Legislature on legislation that includes new spending on roads, coupled with accountability, streamlining and reforms."

Tuolumne County is still awaiting the final notification on the National Disaster Resiliency Competition Application (NDRC). We do know that the State has been informed that Tuolumne County has been awarded \$70 million dollars for projects in our county. We have sent letters to the State requesting more details. Tuolumne County will be receiving these funds because of our ability to work in collaboration with

The proximity of the triathlon will allow participants to easily arrive in Groveland Friday night, participate in the all-day triathlon Saturday, and still have time to remain in Groveland to shop, dine, and explore or head onto Yosemite. You can learn of other activities happening in Groveland for the evening and weekend.

Children of Abusive Parents – Part Two

In my previous article, “Abusive Parents – Part one” I discussed the parents who had difficulty being the kind of parents they may have wished they could have been. This was difficult for many reasons, as previously stated; under no circumstances can their abusive behavior ever be acceptable or condoned.


Children have basic inalienable rights – to be fed, clothed, sheltered and protected. They also have the right to be nurtured emotionally, to have their feelings respected and to be treated in ways that allow them to develop a sense of self-worth. Children have the right to be guided by appropriate parental limits on their behavior, to make mistakes and to be disciplined without physical or emotional abuse.

Parents have great power with their authority and children are forced to submit to their requirements. A child who is compelled to become his own parent, has no positive skills to emulate, learn from and look up to. Without a role model the child blames himself for the abuse. It is easier for a child to feel guilty for having done something “bad” and to think they were the cause of and deserved the abuse.

Whether they were beaten, left alone too much, sexually abused, or treated like nonentities, overprotected or overburdened by guilt, they almost all suffer similar symptoms: damaged self-esteem, leading to self-destructive behavior. They end up feeling worthless, unlovable and inadequate.

This may lead to antisocial behavior as they get older which may force them to seek ways of escaping from the pain they have endured, such as using drugs, alcohol, overeating, sexual promiscuity, criminal acts or even self-harm. There are better strategies to release yourself from these self-defeating life patterns that have plagued your life and can help you to learn that you have worth and you do matter.

It is quite normal to feel a great deal of anger and resentment toward your parents for their inadequacies but when you become an independent adult you can and need to change your focus. Looking back is not generally very helpful especially if you keep thinking, talking and feeling angry. It's time to take your own inventory of your strengths and how to develop them for the future. Take care that your body is healthy, you eat well, get enough sleep and certainly exercise on a regular basis to rid yourself of the negative energy of anger and allow yourself to grieve the loss of your robbed childhood. All of this takes great courage, time and the belief in yourself. By letting go of the past hurts and recognizing that you have control over your own life, it will give you the power to move forward. This may be difficult to do alone. You may learn to recognize abusive behavior in potential mates and steer clear of them. You will also be able to effectively break the cycle of abuse with your own children. Don't give up, YOU DESERVE to find happiness within yourself and your future family.

Literacy Skills for Baby

Did you know that early literacy starts way before a child reaches school? It begins before babies can talk and continues as they become toddlers and preschoolers. In fact, studies show a link between the number of words children know at age 3 and their reading ability at age 10.

So, what does this mean for parents and grandparents and other caregivers? It means literacy skills are developed when young children hear a variety of words from their families and caregivers, when they are encouraged to speak and use their new vocabulary, and when they are exposed to books at an early age.

There's truth in the old saying that children become readers in their parents' laps.

So, what should we do?

- 1) Read to children from the time they are born.
- 2) Speak to young children constantly, describe what you are doing, read labels and signs aloud, sing songs, etc.

Exposing the little ones to reading and vocabulary early and constantly helps them develop skills that will be invaluable for success later in school and in life. This is one of the reasons the Brainy Groveland reading program encourages Tenaya third graders to love reading. The Groveland Library also offers pre-school story time at 10:30 on Friday mornings. The library will also offer a Summer Reading Program for elementary school students.

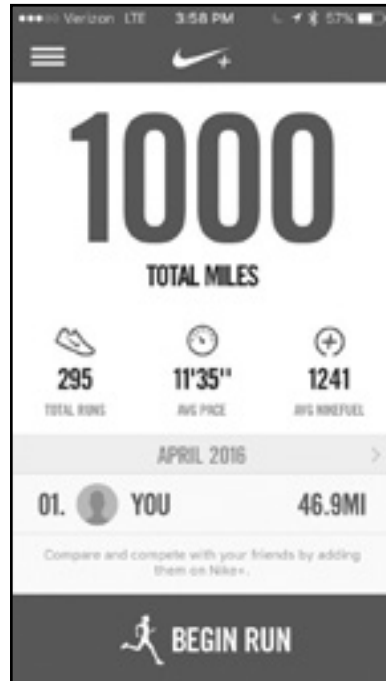

Chicken (Alla) Cacciatore

Recipe provided by Tom Knoth and Paula Martell

Cacciatore is pretty easy to make for a dish that produces such decadent results. My passion for this recipe goes back to my college dorm room cooking days, where I was limited to a portable cook-top. I always used a recipe from my 70's era Better Homes and Garden cookbook. And it turns out that Paula was using that same recipe decades before we met.



Cacciatore means "hunter" in Italian. In cuisine, alla cacciatore refers to a meal prepared "hunter-style" with onions, herbs, usually tomatoes, often bell peppers, and usually wine. A not so well known secret is that wine boosts the flavors of tomatoes, and that is why it is often used in tomato sauces. In southern Italy, cacciatore often includes red wine, while northern Italian chefs might use white wine. I am preferential to red wine which seems to give a little richer taste to the dish.

INGREDIENTS

- 3 Tbsp olive oil
- 2.5- 3 lbs chicken, meaty pieces, skinned, bone-in or boneless is fine
- Salt and freshly ground black pepper
- 2 Tbsp butter
- 1-1/2 cups crimini or button mushrooms, quartered
- 1 medium onion, halved and thinly sliced
- 1 medium green or red bell pepper, thinly julienned
- 2 cloves garlic, minced
- 1 14.5 oz can diced tomatoes and their juices (can sub fresh tomatoes)
- 1 6 oz can tomato paste
- 3/4 Cup dry red or white wine
- 2 tsp Italian seasoning
- 1/2 tsp red chili flakes (optional)
- 1 tsp sugar
- 1 Tbsp fresh basil
- 1 lb linguini, cooked al dente
- Freshly grated Parmigiano-Reggiano

DIRECTIONS

Heat 2 tablespoons of the oil in a large Dutch oven over high heat. Season the skinned chicken pieces on both sides with salt and pepper and place in the pan, brown on each side for a total of 15 minutes. Remove the chicken to a large plate.

Add 1 Tbsp oil and 2 Tbsp butter to the pan and heat until butter is melted. Add mushrooms, onions, and bell peppers; cook a couple minutes and then add garlic. Cook until mushrooms are browned and onions are soft, remove to a plate.

Add tomatoes, tomato paste, wine, Italian seasoning, chili flakes, and sugar to pan and combine. Return the chicken and mushrooms to the pan, reduce the heat to medium-low, cover the pan and cook until the chicken is tender, about 30-35 minutes, turning once during cooking process.

If thicker sauce is desired, increase the heat to high and cook the sauce, stirring occasionally, until slightly thickened, 8 to 10 minutes. Season with salt and pepper (if needed), and you prefer a less acidic taste, you can add a little more sugar. Garnish with fresh basil. Serve over linguini or rice (optional) and sprinkle with freshly grated Parmigiano-Reggiano.

Although we celebrated Pentecost Sunday on May 15 this year, the season of Pentecost continues for five months. It is a Liturgical Season that emphasizes Spiritual Growth and Renewal, symbolized by the color green which encourages Christians to grow in faith and service and to celebrate God's glorious Creation.

Pentecost is a regular Old Testament festival established in the time of Moses. Passover, which becomes Easter for Christians, is the first of several annual festivals prescribed to be celebrated in the Jewish year. Exactly 50 days after Passover, the Jews celebrate the Feast of Pentecost. Nearly 1,500 years after Moses, the events of Acts 2 occur when the Holy Spirit comes down indwelling the followers of Jesus. People of the Jewish faith from all languages are gathered in Jerusalem to celebrate the Old Testament Pentecost. They are drawn to hear Peter's message. On this day the Church of Christ is born. This event is recorded in Acts, Chapter 2. The Spirit of God descends on the 120 followers of Jesus and they begin speaking out loud in languages from around the world. This creates such a commotion that thousands, who are in Jerusalem at the time for Pentecost, come to see what is happening.

In front of the gathering crowd, Peter speaks the first gospel message. "Three thousand were added to their number that day" (Acts 2:41). The number of gospel followers has been growing continually ever since that Pentecost Sunday.

Of course, we'll celebrate Father's Day on June 19 at Mountain Lutheran Church! Our guest speaker will be a representative of Gideons International with updates on their work and inspiring scriptural passages. June's Second Mile offerings are for spreading the Good News

of Jesus with Bibles given by Gideons. Our Pastor has a small gift for all men who attend church on this day.

Museum Happenings

Early Big Oak Flat and Groveland pioneers faced many hardships, ranging from battling the physical elements to scratching out a living in a remote region. While these challenges certainly made day to day life difficult, they also made families strong and resilient and brought communities together to support and serve one another.



Virginian John W. Scofield came to California and in 1884 filed an Agricultural Patent or Homestead on about 158 acres below the Divide Cemetery that, today we commonly call 'The Scar' in Big Oak Flat. The two youngest sons of his ten children left California to fight in the Spanish American War in Cuba in the late 1890s. The older of the two brothers was James J. Scofield, known as Jody and the younger brother was John Bright Scofield.

In 1898, after the War, Bright met a Pennsylvania-born school teacher named Winnie May Douglas and they were married in Elmira, New York. Bright and Winnie returned to Big Oak Flat and settled on the family homestead and had four children over the next eight years, two boys and two girls and lived in a log home on the family homestead.

Meanwhile, Jody Scofield married Winnie's younger sister Adeline (Addie) Douglas in Big Oak Flat in 1903, had two sons, and worked as the night shift boss for the Longfellow Mine in Big Oak Flat. Jody filed the Agricultural Patent for the section of land north of his brother's property.

Sadly in 1909 while Bright was in Nevada working as a silver miner, 32-year old Winnie died leaving four young children aged one to nine. The four children were sent to an orphanage in Santa Rosa where they were badly treated. Learning of this, Winnie's parents Alinas and Florence Douglas and 14-year old daughter, Nellie left Pennsylvania and came to California to care for the children.

The Douglases moved to the Big Oak Flat homestead and Alinas added three rooms to the log house and built a large barn for a dairy operation which supplied milk to local businesses including Priest's Hotel. The accompanying archive photo shows the dairy barn with Alinas Douglas and family.

The Golden Rock Ditch crossed the homestead and both Alinas and son-in-law Jody worked as caretakers for the Golden Rock Water Company. The ditch watered a huge garden and apple orchard on their wooded property.

Nellie, the youngest Douglas daughter married Clarence Lebow, a brakeman for the

Santa Fe Railroad in 1913. They had two daughters, Winifred and Dorothy before the marriage ended in divorce. In 1920 Nellie married Budd Eaton, who had moved from Pennsylvania to woo her. Son Harold was born the following year in the family home on the north side of Highway 120. Budd worked as a surveyor for the City & Co. of San Francisco for 33 years, from 1915 to 1948, as did son Harold who was Hetchy's Mechanical Shop Superintendent from 1948 to 1983.

One of Winnie and Bright's sons, Raymond (Ray) Scofield was foreman of the Tuolumne County Road Department which operated out of the Groveland building which is now the Helping Hands Furniture Barn. Ray married Martha Alexander, a well-loved local school teacher.

Ray's son Darrell worked for the Tuolumne Co. Road Department, California Department of Fish & Game, and California Division of Highways. Darrell's son Lester managed the Stables at the Pine Mountain Lake Equestrian Center for many years.

The Scofield homestead supported Jody and Bright's descendants for over 100 years as they worked in the area and made lasting contributions to our community.

According to Harold Eaton, 'The Scar' site first sold in the early 1930s for about \$600. The buyer resold it 15 years later for \$35,000. Carlo De Ferrari, County Historian, wrote, "about 1979 it appeared the area would be adorned with a 37-acre development containing a 200-room hotel, service station, theatre and bowling alley." In 1988 a gas station was built, although never opened. Grading removed the vegetation and the nickname 'The Scar' stuck.

Other proposed ventures have come and gone but one thing is certain, a development of this nature could impact this community's economy, growth, traffic, and historical complexion dramatically. Only time will tell.

I look forward to seeing you at this year's STCHS Wine Cruise on Saturday, June 4. Festivities begin at Lake Lodge for an afternoon cruise on the beautiful and full Pine Mountain Lake with food and libation at seven spectacular lakeside homes.

STCHS June 18 Program

The Southern Tuolumne County Historical Society's June 18 program features Neil Fahy and his impersonation of homesteader Cyrill C. Smith. Mr. Fahy titles his presentation "Reminiscences of a Hetch Hetchy Homesteader (or How San Francisco Built a Dam and Made Me Rich)". Cyrill C. Smith built a cabin on Hog Ranch at Hetch Hetchy in 1856, received a homestead in 1884, and his son sold the property to the City and County of San Francisco in 1909.

Fahy (as Cyrill) will explain how he and his in-laws acquired the Hetchy property, then how the City of San Francisco received Congressional approval to construct a dam in a national park and secured the needed land holdings and water rights. He will discuss the engineering vision that was required to make the system a reality and how access was made to the remote valley. Cyrill will explain the development of the electric power system, the dam and its subsidiary facilities, and the transportation of the water 180 miles to the Bay Area without the use of a single pump.

Neil Fahy, a retired geologist, first worked

as a Camp Mather naturalist in 1944 and, after WWII, from 1947 to 1949. He returned as a volunteer naturalist and camp historian from 2008 to 2016. In 2014 his book "Fun Facts and More about Camp Mather" was published by the Friends of Camp Mather. He also wrote "Josiah D. Whitney, the California State Geological Survey, and Yosemite Valley" published by the California State Division of Mines & Geology in 1985.

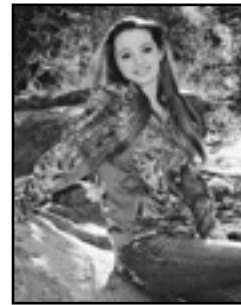


