### **SUMMARY**

Conducts swim lessons for PMLA Swim Center with approved swim lesson curriculum in a safe environment for children. Maintains payments, records and progress of participants. Builds rapport with participants, property owners, renters and guests.

**ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following:

- Enrolls swim lesson participants in correct sessions based on age and ability
- Ensures proper payment for swim lessons
- Enthusiastically teach swim lessons in accordance with approved curriculum
- Upholds water safety and pool regulations at all times
- Ability to work well with children and guardians
- Prepares swim lesson area with proper tools and swim lesson props/aides
- Keeps attendance and provides reports of participants progress to Seasonal Pool Manager
- Must wear proper/modest swimwear during lessons
- Must be able to work outdoors in various weather conditions
- Regular, punctual attendance is required
- Other duties may be assigned

### **QUALIFICATIONS:**

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. - Excellent customer service skills
- Cash and credit card handling abilities

### **EDUCATION and/or EXPERIENCE:**

Less than high school education; or up to one-month related experience or training; or equivalent combination of education and experience

### **LANGUAGE SKILLS:**

Ability to read and interpret documents such as safety rules, operating and maintenance instructions, and procedure manuals. Ability to write routine reports and correspondence. Ability to speak effectively before groups of customers or employees of organization.

**REASONING ABILITY:**

**PHYSICAL DEMANDS:**

While performing the duties of this job, the employee regularly works in outside weather conditions and is regularly exposed to wet and/or humid conditions. The noise level in the work environment is usually moderate.
